## 1989 JUDGES RULING, IGNORED BY CERRITOS CIT ATTORNEY, TAKES BARROWS OUT OF COUN

weeks ive ago Hews Media Group-Community News published a report pertaining to Article IV of the Cerritos City Charter, which was re-written after voters overwhelmingly approved Proposition H in 1988 that mandated term limits.

Barrows supporters, who

opinion, slammed the report.

Conversely, Cerritos voting residents who are tired of seeing the same city council members cycle through the City every two years, praised the report.

The City, through its attorney, sent out a press release to all media outlets contradicting the report citing the 2004 AG's opinion, even taking the unusual step of posting the letter on the City's website under "Top Stories."

The reaction by Barrows supporters and the City was vitriolic.. and it was premature.

HMG-CN traveled to the Los Angeles County court

cited a 2004 attorney's general archives and obtained two judicial decisions from 1988 and 1989 that invalidate the AG's opinion.

> Judge J. Kimbal Walker stated in his 1988 decision, case number SEC 66417, "When the (1988) election is had, all the council members will be ineligible to run or serve a third consecutive term."

Judge Jerold Krieger stated in his 1989 decision, case number SEC 77109, "it is adjudged and decreed that any member of the City Council of the city of Cerritos who has served more than two consecutive terms is prohibited from seeking reelection."


rulings effectively ban Barrows from running for office in April.

The judicial rulings also call into question the City Attorney's own motives and actions in not following the rulings since informing 1989, and not City personnel, including the Cerritos City Clerk's office of the court cases, while relying on an AG's opinion written fifteen years later.

Judges rulings are law; AG opinions, according to the AG's own website, are advisory.

Worse, the '88/'89 court decisions were inexplicably left out of the AG's 2004 decision.



## ARTESIA-CERRITOS WOMEN'S CLUB CANCELS FORUM

Who would dare pressure the venerable women's club?

The Artesia Cerritos Women's Club sent out an email last week cancelling it's March 22 forum that was scheduled for 7 o'clock at the Cerritos City Council chambers.

This type of cancellation has never occurred in Cerritos politics before.

The ACWC went through the usual channels in scheduling the forum, writing a letter to Cerritos City Council to be agendized with the full city council voting their approval.

The ACWC sent out a brief, cryptic, and very contradictory release saying, "The Woman's Club of Artesia-Cerritos is a non-partisan, non-denominational organization. That being said, our members are free to express their personal opinions and views on their own behalf."

"It has come to our attention that there has been some discourse between members of our club and outside sources. We do not wish this to become a distraction to the candidates nor the city election."

It was signed by the ACWC President Catherine Chu.

It is unknown what the phrase "some discourse between members of our club and outside sources" indicates, and also the phrase "we do not wish in becoming a distraction to the candidates."

The statements are unusual given that 95% of the forum is formatted to take questions from the audience.

Sources were telling HMG-CN that Barrows and Chuong Vo were

"embarrassed" at the Cerritos Chamber candidate forum when asked specific questions by other candidates as the reason the forum was cancelled.

Barrows was slammed for the RDA comment, where he somehow knew an announcement by the City of windfall revenue was coming before all the other candidates and many residents.

HMG-CN also was alerted about a relationship between Cerritos resident Chris Foster, an outspoken Barrows supporter, and Catherine Chu.

The two had a very "chummy" conversation about local politics on Facebook.

Resident Jay Gray told HMG-CN, "This is wrong, the main candidate to benefit from muzzling the residents and other candidates from the democratic process is Barrows and the other candidate supported by the majority council. This could have easily been remedied, simply do what Cerritos does for elections. Ask for volunteers from the Recreation staff to collect questions from the audience and submit to the moderator. The city and those in power were stunned by Anantha Ramachandran and his willingness to take on the establishment."

Resident Jim McMahon told HMG-CN, "forums create wise and educated voters. Very sad that the woman's club had to recall the forum. Voters big loss."

"The Republican slate knew about this RDA judicial settlement (Barrows mentioned), before the 2nd forum, but was not made available to all 7 candidates, in order to produce healthy debates."

"I'm an advocate for fair and balanced politics, not back door ambushed politics, which has leaked in to our debates."

La Mirada High School students recently attended an educational program on the devastating impacts drinking and driving can have on friends, families and the community.

"This program is a tremendous cooperative effort involving La Mirada High School, the City's Public Safety Team, Los Angeles County Sheriff's and Fire Departments, and California Highway Patrol, "says Safety Education Officer Mary Cipres.

"It aims to discourage underage drinking, especially drinking and driving."

During the first day of the program, 36 students were removed from class every 15 minutes by a member of the City of La Mirada's Public Safety Team and a volunteer dressed as the grim

The dramatic visual exit of the students leaving class with the grim reaper was meant to illustrate the National Highway Transportation Safety statistic that someone dies in an alcohol related

collision every 15 minutes.

After leaving class, the juniors and seniors were escorted to the front of the school where they

witnessed a simulated crash scene in which student volunteers were involved in a fatal pedestrian collision.

One of the students was pronounced dead on arrival, another was airlifted in critical condition, and the driver was arrested for driving while under the

influence.

After the stimulated collision, the students visited the Olive Lawn Cemetery and then spent the night at the La Mirada Activity Center.

During their night away from home, they completed alcohol education activities and viewed video programs discouraging impaired driving.

They read emotional good-bye letters written to them by their parents and also wrote good-bye letters to their parents.

The following day, all juniors and seniors attended an assembly at La Mirada High School where they heard stories from people affected by fatal, alcohol-related auto accidents.

The students also viewed the film featuring some of their classmates. The film depicts a group of teens who consume alcohol at a house party and are later involved in a fatal auto accident. It shows the fate of the teenage driver who is taken into custody and the impact on the victims' families and friends. "These incidents are avoidable criminal offenses

> and are often caused by regular, responsible people who made a poor, impulsive decision while under the influence of alcohol, " says La Mirada

Community Sheriff's Station Lieutenant Kevin Beggs.

"With this program, students are urged to make smart decisions beginning now and continuing throughout adulthood."

## A WISE FRIEND AND SELF EDUCATION

The world has been through much these past twelve months, a divisive presidential



election, splintering of the European Union, the refugee crisis and the possibility of war on the horizon. It is more important than ever to focus on what remains good and kind. Random acts

of kindness are those small, insignificant and every day acts that can change the direction of a person's life.

Benny Wasserman is an actor and producer, known for 'Hoops: It's Not Just a Game' [2010]; 'TV: The Movie' [2006] and Angels with Angles [2005]. He is an Albert Einstein look alike and celebrated author of "Presidents Were Teenagers Too, but none of this would have been possible without the help of his friend Carl Levin.

In the latest edition of Chicken Soup for the Soul: Random Acts of Kindness Wasserman recalls his childhood friend. The story begins one late afternoon in Levin's back yard. The two boys were teenagers, "We had just finished a game of stickball, and I was about to get on my bike to go home," writes Wasserman, "before I left, Carl hands me a book, Martin Eden by Jack London."

The story "A Wise Friend" follows Wasserman through his time in the Army, as he attempts to go to college, finds love and finds his calling. Flailing through life until he finally picks up the book Martin Eden and reads it.

Martin Eden although set at the beginning of the 20th century, spoke to

Wasserman. Through the struggles to rise above destitute circumstances, the books main character struggles through an intense and passionate pursuit of self-education, hoping to achieve a place among the literary elite, his main motivation being the love of his life. As for Wasserman coming from an uneducated, workingclass background, he was able to relate to Martin Eden. The daughter of jack London commented that in spite of its tragic ending, the book is often regarded as "a 'success' story, not only inspiring a whole generation of young writers but other different fields who, without aid or encouragement, attained their objectives through great struggle"

Wassermann's tale is only one out of 101 stories of compassion and paying it forward. Random Acts of Kindness delivers good news, good behavior and good deeds of the everyday man and woman. People are willing to help, but you have to ask proving that even a few well timed kind words can turn a life around.

What happened to his friend Carl? He went on to graduate from Harvard Law School becoming a Civil Rights Attorney, became a member of the Detroit City Council and was overwhelmingly elected to the Senate from the State of Michigan where he served for 36 years.





## SUBURBAN LEAGUE BASEBALL: EARLY LEAD HOLDS UP FOR CERRITOS IN SLOPPY SUBURBAN LEAGUE OPENER

Cerritos High head coach Scott Parsonage doesn't want to use the "we're young" card. In fact, he says he's tired of constantly saying those two words but the fact remains that the Dons have been struggling through the early part of the season.

It wasn't the prettiest Suburban League opener the Dons were hoping for as they visited Artesia High this past Wednesday. But Cerritos scored six runs in the first four innings and held on to knock off the Pioneers 7-5 on a windy afternoon. Cerritos improved to 8-5 overall while the Pioneers (1-7 overall) dropped their 18th straight league game and their 27th out of the last 28 league contests.

While the Dons made three errors and gave up four unearned runs, they were helped early on by having the first three lead-off hitters reach on walks with all of them scoring. In the top of the first, Artesia senior pitcher Alex Covarrubias walked sophomore left fielder Matthew Aguinaga. Two pitches later, he came home on a double from senior catcher Brett Wells.

The Pioneers would tie the game in

their half of the inning when freshman left fielder Brandon Azzato reached on an error and scored on a groundout from junior second baseman Bobby Aragon. The Dons would answer back the next inning with one out consecutive singles from freshman right fielder Alex Manibusan, senior pitcher Jonathan Estrada and freshman second baseman Raul Garcia, the bottom three in the lineup. Manibusan and sophomore center fielder Matthew Pinal, who began the frame with a walk, scored.

Cerritos added to its lead in the third inning with two more runs as senior shortstop Trevor McInerney was walked and freshman third baseman Evan Vasquez was hit by a pitch. Both would score on a two-out, bases loaded single from Estrada. The visitors extended the lead to 6-1 in the fourth when Aguinaga was hit by a pitch and touched home plate on a fielder's choice from McInerney.

Through the first three innings, Estrada had been dodging some serious threats as the Pioneers would strand five runners on base but just have the one run to show for it. But all that changed in the next inning.

Artesia, which entered the game with five runs scored in its last four games, scored four runs in the bottom of the fourth. With one out, junior right fielder Francisco Moreno hit a tapper up the left field line that bounced up and over third base for an infield knock. Senior shortstop Max Anderson reached on an error and both runners came home on a single to left from Azzato.

Senior third baseman Oscar Barragan would reach on a fielder's choice, followed by a single from Aragon and a sacrifice fly from junior designated hitter Mark Chavez. After that, Estrada settled down and allowed three runners to reach before being replaced by Vasquez in the seventh. Estrada scattered six hits and allowed one earned run while striking out three.

"He was doing fine," Parsonage said of Estrada. "We didn't help him. We booted the ball around, made stupid plays; drop a ball or something."

The Dons would get an insurance run in the seventh when Pinal was walked by Aragon, the third Artesia hurler of the game, and scored on Manibusan's second base hit. "You can't drop a game to one of those teams if you plan on making the playoffs in this league," Parsonage said. "You have to take care of people in league like Artesia."

Last season, the Dons split their first 10 games before opening league action by sweeping Artesia. They would finish the season with a 14-14 mark with a much experience team. This season, Parsonage said he isn't too surprised with the start his team has had despite fielding a club of seven freshmen and three sophomores among the 17 players on the team.

"No, not really," Parsonage said. "I figured that's where we would be around. I was thinking we would be around [8-5] and hoping we weren't going to be worse than that. But I thought we would be two or three games better. We dropped two to Costa Mesa. It was kind of like today but worse."

Both teams will meet again today with possible starting pitchers being Estrada and senior David Licea for Artesia. Licea worked the fourth and fifth innings, striking out two and giving up a hit and a run. Cerritos will then be home to Bellflower High on Wednesday while the Pioneers welcome La Mirada High.



[OS] is heading this educational effort.

Over the past five years a community vision and solid infrastructure of the program has taken shape. "We also have established strategic relationships with various organizations, however the City of Hawaiian Gardens has been our biggest supporter," says Khananashvili, "We have been able to gather significant data about the changes, not only in physical health but also in mental wellbeing. It is time to take the program to the next level."

According to the CDC the percentage of children with obesity in the United States has more than tripled since the 1970s. Today, one in five school-aged children, ages 6-19 is obese. Obesity is defined as having excess body fat. Being overweight is defined as having excess body weight for a particular height from fat, muscle, bone, water, or a combination of these factors. The Body Mass Index [BMI] is a widely used screening tool for measuring both overweight and obesity. BMI percentile is preferred for measuring children and young adults because it takes into account that they are still growing. Childhood obesity has immediate and long-term impacts on physical, social, and emotional health and this is why OS starts with kindergarten students and their families.

Currently the program serves five schools in Hawaiian Gardens and approximately 5,000 community members over the last few years. Each class can accommodate 25 individuals, "We work hand-in-hand and one-on-one to address their eating, cooking and shopping habits," adds Khananashvili, "there are many scientific studies that demonstrate a reduction in childhood obesity by up to

20 percent resulting from breastfeeding alone. Our educational program discusses the myths of buying and cooking with healthier alternatives."

In the Southern California, childhood obesity has reached an all time high. Although numerous factors contribute to childhood obesity, energy balance is the key. "Changes in the environment where children spend most of their time, home and school, are where the focus should begin," adds Khananashvili, "we can help children achieve and maintain a healthy weight by making it easier to eat nutritious foods, and that starts by educating families."

OS also discusses the fundamental flaw of current anti-obesity methodologies as uncoordinated efforts of organizations that cannot maintain the type of transformation required to change the outcome. Their approach combines the family, school, childcare facilities and physician in a sincere scientific approach to the best practices to develop, change and keep a healthy lifestyle.

"We are result oriented and our program can be easily tailored regardless of socioeconomic factors, ethnic makeup, existing curriculum and the like so it can be quickly implemented for maximum results on a short timeline," notes Khananashvili.

Activate Hawaiian Gardens has had incredible results that were widely covered by local and national newspapers including the Long Beach Press Telegram, La Opinion and the Los Angeles Times (which featured a front-page story) as well as television news broadcasts on KCBS, KNBC, FOX and KCAL. Thanks to the implementation of Activate Hawaiian Gardens, the city was subsequently recognized by Michelle Obama's "Let's Move Cities, Towns and Counties" as the best in the United States among cities with

populations under 25,000.

This success is the first installation of the OS program; the company will explore and expand into more cities. Khananashvili said, "We are confident OS can positively impact the childhood obesity epidemic.

And they were left out of Cerritos City Attorney Mark Steres' press release.

HMG-CN talked to a legal advisor who stated, "Steres should have, at the very least, considered the content of the 1988-89 judicial rulings, along with Lockyer's opinion, before writing the press release."

The 1989 court case, filed Nov. 2, saw Hydelita Soto, representing herself, go up against the powerful City of Cerritos' law firm of Brown, Winfield, and Conzoneri (Brown), who was paid by the city of Cerritos to defeat Prop H.

It was a classic David versus Goliath scene, but Soto still won the case.

From the size of the briefs, it looked as if Cerritos spent well over \$100,000 fighting Prop H, a proposition that over 60% of Cerritos residents voted for.

Soto, after winning, received \$1,364 in fees.

The case centered around the now infamous Article IV which stated "any Council member who has served two consecutive four year terms shall not be eligible for a period of two years to seek reelection."

Barrows served two consecutive Cerritos council terms, starting in 2007 and leaving office in March 2015.

In the report, HMG-CN wrote that Barrows could not "seek" office until March 2017-two years after he left officethereby disqualifying

him from the council race after Barrows filed in late January 2017.

Five days later, Cerritos's City Attorney Mark Steres sent out the release citing the 2004 opinion written by then California AG Bill Lockyer.

In his 2004 opinion, which was not a judicial court ruling, Lockyer ruled that Paul Bowlen and John Crowley could retain their council seats and that Article IV did not ban candidates from running for office in two years after serving two consecutive four-year terms.

Ironically, the ruling was in complete conflict with the vocal and extremely well funded No on Prop. H campaign, who's members obviously thought the proposition was a complete ban on running for council after serving tow consecutive terms.

The No on Prop H campaign, which spent more than \$50,000 to defeat the initiative, boldly and succinctly stated in their campaign materials, "if this amendment passes, any city councilmember in their second term cannot be a candidate for an additional term."

Days after the Lockyer's opinion, Metropolitan News-Enterprise, a well respected legal newspaper based in Los Angeles, wrote an article stating that, "Lockyer has opined that Prop. H refers to the date of the next general election, not the date that a person becomes a candidate."

Met News stated that the opinion interpreting a city charter by Lockyer was "highly unusual" and something that Lockyer "declined to do in at least two cases" earlier in the year.

Met News cited Lockyer's decision to refuse to rule on whether Los Angeles

City Attorney Rocky Delgadillo held his office in accordance with the Los Angeles' City Charter.

Several individuals, including then-Public Defender Michael Judge, had claimed that Delgadillo had not been qualified to practice law prior to taking office because he was an inactive State Bar member for a period of time.

Lockyer cited the "usual practice of not interpreting local charters and ordinances in determining Delgadillo's case."

Later, Lockyer denied to rule on a case brought by citizens of Inyo County who contended that having a single individual hold two local positions violated a local initiative.

And recently, HMG-CN sent a letter

because Soto did not present a valid case. Brown cited the 21 cases, and several articles under the constitution.

On December 11 Soto filed an Amicus Curiae. An Amici is someone who is not a party to a case and is not solicited by the party but who assists the court by offering information on the case. The decision whether to admit the information lies at the discretion of the court.

The information was later allowed by Judge Krieger.

The two people who offered advice were David Diaz of the Los Angeles City Two-Term Limit Coalition and current L.A. City Councilman Curren Price Jr. who at the time was with Inglewood Citizens for Reasonable Reform.

ambiguity should be interpreted in favor of the people."

Brown argued that local governments cannot limit the tenure of local elected officials and that State law preempted Prop. H.

Charter counties and general law cities are granted specific power by the state when not in conflict with state laws.

Charter cities, on the other hand, are granted plenary (unlimited) powers except as to those that have been preempted by the State.

Krieger ruled that the court must "look to the test for preemption set forth (in a case called) in re Hubbard."

"Is there an adverse effect of the local ordinance (Prop H.) on transient

citizens of the State that outweighs the possible benefit to the city?"

Krieger ruled that Prop. H did not have an effect on the transient citizen.

"By definition, the person who would become ineligible to run for office has been in the city for at least eight years."

"The person who votes must have been registered to vote and residents of the city for a period of 30 days."

Krieger stated that the court finds there has been no preemption meaning Prop H. was valid under the Cerritos City Charter.

"The court finds that there is no ambiguity as to the applicability of the limit in the number of terms to those council members who have served two terms as of the date of the next election."

Brown's demur was denied.

On December 27, 1989 a judgment was entered with Krieger saying, "it is hereby adjudged and decreed that any member of the City Council of the city of Cerritos who have served two or more consecutive terms is prohibited from seeking reelection

of the Charter of the city of Cerritos."

Attorney General's opinions are usually treated as authoritative by the officers and agencies who have requested them

pursuant to the provisions of Article IV

But the city of Cerritos did not request the 2004 AG's opinion, <u>Cerritos</u> residents requested the opinion.

The AG's website states, "Opinions of the Attorney General, while not binding, are entitled to great weight. In the absence of **controlling authority**, these opinions are persuasive 'since the legislature is presumed to be cognizant of that construction of the statute.(Napa Valley Educators' Association v. Napa Valley Unified School Disrict. (1987) 194 Cal.App.3rd 243, 251.)

But there was a controlling authoritythe 1988 decision by Walker and the 1989 decision by Krieger, therefore the AG's opinion is overridden.


In reality the AG, given the 1988/89 decisions, should have never opined on Article IV.

HMG-CN sent an email Wednesday to City Attorney Mark Steres and City Manager Art Gallucci alerting them that HMG-CN wanted a quote Thursday afternoon. asking the current AG to intervene in Cerritos in relation to Article IV.

The AG's office wrote, "It is our general policy that local governments are primarily responsible for citizen complaints, and that appropriate local resources should be utilized for the resolution of such complaints."

It is unknown why Lockyer ruled on the Cerritos case in 2004, when just months before, Lockyer refused to rule on two very similar cases.

His opinion becomes even more questionable given that Lockyer failed to cite the two judicial decisions in 1988 and 1989.

The exclusion calls into serious question the accuracy of the AG's opinion.

Brown spared no expense in litigating with Soto, citing 21 precedent cases, four articles from the California Constitution, four government codes, and one evidence code.

The information from the case was readily available, yet Lockyer inexplicably cited only one case from Brown list in his 2004 opinion.

The 1989 Case-David versus Goliath-

The case began in Nov 1989 with Soto, arguing in her initial brief that Prop H. should be read literally and enforced.

"Defendant, city of Cerritos, acting through city attorney Brown, has expressed its intent not to comply with the charter amendment (Prop. H), therefore a judicial declaration is necessary."

Brown subsequently filed what is called a demur 28 days later asserting the lawsuit could be quickly resolved

Diaz was attempting to amend the Los Angeles City Charter to two terms in office; Price Jr. was doing the same thing to the Inglewood City Charter.

Messrs. Diaz and Price Jr. stated, "The attack by the city of Cerritos on the initiative measure passed by the people of Cerritos challenges the power of the people to limit terms of office of their elected officials. The two initiatives presently circulating in Los Angeles and Inglewood maybe directly threatened by the first decision of the trial court in this action."

"An adverse trial court decision could also threaten initiatives currently being circulated in San Jose as well as current term limitation provisions in place in fifteen charter cities in California. The decision could have a significant effect on term limitations provisions already in place."

The two slammed Brown for their obvious conflict of interest position, "the failure of the city attorney to defend the citizens gives the appearance of a conflict of interest by supporting the position of the incumbents on the City Council who pay Brown's bills."

"They are using the resources of the city to attack the provisions that affect their tenure in office. That raises the issue of the credibility of the city's position."

"In addition, the conflict exists in the city attorney's obligation as city attorney to be a public officer. His duties include vigorous enforcement in defense of the laws passed by the people yet he is defending the legislative body that is challenging the charter amendment."

The two finished stating, "The charter provision was passed by initiative. Any
