



## HEWS MEDIA EARNS THREE LOS ANGELES PRESS CLUB AWARD NOMINATIONS, INCLUDING JOURNALIST OF THE YEAR

### STAFF REPORT

For the sixth straight year, Hews Media Group-Los Cerritos Community News, Publisher Brian Hews and staff garnered three Los Angeles Press Club finalist nominations to be awarded at the 60th Annual Southern California Journalism Awards, June 24, 2018 at the Millennium Biltmore in downtown Los Angeles.

This year, the Los Angeles Press Club received more than 1,400 entries, up 20 percent from last year.

The contest was judged by journalists at press clubs across the nation,

## HMG-CN INVESTIGATION: ABCUSD BOND ELECTIONS FIRM SUBMITTED QUESTIONABLE INFORMATION, DISTRICT OFFICIALS KNEW AND FAILED TO INFORM BOARD MEMBERS

**A** Hews Media Group-Community News investigation has found that Ann Nock, who was awarded the election and polling services contract for the upcoming ABCUSD school bond, submitted questionable information on her bid documents and used suspect references to win the lucrative public relations contract.

Even more alarming, at some point during the vetting process, ABC officials discovered the questionable information, did not inform at least three Board Members, and allowed the process to continue.

Nock submitted her bid in March 2018, part of which included a Reference List of clients whom she claimed to have worked with over the last five years.

The Reference List asked specifically

for School Districts under which Nock clearly wrote "Orange Unified."

As a reference to Orange Unified Nock handwrote, "Denise Biddle."

On another page Nock typed a description of Biddle as a "Community activist/Chair Orange Unified School Bond."



But the Orange Unified claim, the Denise Biddle reference, and the description of Biddle would all turn out to be false.

From previous articles on Nock,

HMG-CN found several issues including the list of clients on her website nearly matching those of her former long-time employer George K. Baum.

Based on those findings HMG-CN conducted research on the 2016 Orange Unified school bond and found documents that indicated Nock never worked for the OUSD.

Nock had submitted a bid to OUSD in 2015 for election services but pulled out due to "family matters."

Weeks later she was hired by a massive independent expenditure committee supporting the bond called CARE-Community Advancement through Renovation for Education.

And ABC officials who found out about the deceitful information failed to disclose that to at least three Board members.

## EXCLUSIVE: WAS THE GARCIA INVESTIGATION 'RIGGED' FROM THE VERY BEGINNING?

Some say the Assembly move was calculated - retaining a lawyer for the investigation created attorney-client privilege so the investigation documents can never be revealed.

This past week the Assembly Rules Committee ended its investigation of sexual harassment and other complaints against Assembly-woman Cristina Garcia.

The investigation was conducted by outside counsel Vida Thomas of Stoel Rives, LLP, who was retained by the Assembly.

In the end, the Thomas investigation could not "substantiate" the explicit sexual harassment allegations even after they interviewed Cerritos resident Daniel Fierro, who filed the complaint against Garcia.

Fierro told HMG-CN, "They interviewed me but they failed to interview another witness who would have corroborated my story, makes me wonder

what their methodology was, it certainly was not transparent."

That failure to interview other witnesses carried into another part of the Thomas investigation.

Thomas substantiated three lesser charges that were part of a larger set of extremely explicit accusations levelled by former Garcia staffers who had retained San Diego based attorney Dan Gilleon.

But Thomas did not interview four critical witnesses because Gilleon wanted a second independent investigator chosen by him to assist Thomas.

Without interviews, the Thomas investigation substantiated the lesser charges finding that Garcia "commonly and pervasively used vulgar language around staff; that Garcia has used staff in the past to perform personal services; and that Garcia has disparaged other elected officials."

The findings drew a strong rebuke from Assembly Speaker Anthony Rendon. But Thomas did not address the larger set of more serious allegations by Gilleon's clients.

## 49TH ANNUAL L. A. COUNTY PEACE OFFICERS' MEMORIAL CEREMONY

For the second consecutive time since the restoration of the Eugene W. Biscailuz Regional Training Center, the 49th Annual Los Angeles County Peace Officers' Memorial Ceremony was held on the facility grinder. The "grinder" is where young men and women striving to become peace officers of the future are trained and tested. It is where they will forever be reminded of the sacrifices of those from the past. A colorful, freshly-styled Memorial Wall stands erect as the focus of the outdoor venue; it exhibits the names of the 520 peace officers who lost their lives in the line of duty while serving the residents of Los Angeles County.

The annual ceremony commemorates the lives of these officers and recognizes their ultimate sacrifice. This year, we paid special tribute to honor five of the fallen heroes and their names were added to the Memorial Wall.

Most recently and regrettably, the life of one of the five peace officers honored were lost in the line of duty February 6, 2018: Deputy Steven E. Belanger, Los Angeles County Sheriff's Department. Four additional names were honored: Officer Murray F. Olsen, Los Angeles County Department of Hospitals; Policeman Frank L. Coe, Los Angeles Police Department; Motorcycle Officer Louis Allinson, Los Angeles County Sheriff's Department and Vernon Police Officer, Deputy City Marshal Maurice W. Halloran.



**DEDICATION:** The annual ceremony commemorates the lives of officers and recognizes their ultimate sacrifice. The first Los Angeles County Peace Officers' Memorial Wall was dedicated in May 15, 1970.

The path of dedication of this wall is over 50 years in the making. The first Los Angeles County Peace Officers' Memorial Wall was dedicated in May 15, 1970 at Biscailuz Center Training Academy by Sheriff Peter J. Pitchess. When the wall was first erected, there were 253 names of men enshrined and no women's names. In May 14, 1984, the Sheriff's Academy moved from East Los Angeles to Whittier and the Sheriff's Memorial followed. In the same year it was moved, Sheriff Sherman Block dedicated the second Peace Officers' Memorial. For the next 30 years, Whittier was the site of the Peace Officers' Memorial Ceremony.

When the Sheriff's Academy left Whittier and returned to its original home at Biscailuz Center, in 2014, it was decided that the memorial should return as well. Unlike the memorial in Whittier, which faced the main courtyard of the

STAR Center, this memorial overlooks the "grinder". This wall is a powerful testimony to the gravity of the profession. The peace and freedom of the people of Los Angeles County comes at a cost, and for some that cost was the full measure of their devotion.

On May 23, 2018, the newly freshly-styled Peace Officers' Memorial Wall was dedicated by Sheriff Jim McDonnell. The wall now displays the names of 520 men and women, including the five honored today.

The Los Angeles County Peace Officers' Memorial Wall serves as a constant reminder that we owe them for their noble sacrifice, a debt that cannot be fully paid. This wall is not just a place where we recognize the fallen, but where we also recognize and remember those they left behind.

## CERRITOS LED LIGHTING DEMONSTRATION

The City of Cerritos will make a second street lighting demonstration available in the residential tract south of Artesia Boulevard and west of Bloomfield Avenue Friday, May 25, 2018 through Friday, June 15, 2018.

The lighting will be displayed on Felson Street, Niagara Avenue, Sybrandy Avenue and Yosemite Street.

These streets were selected because they have mature parkway pine trees and they are within the same residential tract, which will allow residents to easily compare the different lighting options.

The community is invited to view the display and vote on a preferred lighting option to replace current residential

streetlights throughout the City.

The City is exploring replacing High Pressure Sodium Vapor (HPSV) streetlights that currently exist in all residential tracts and arterial streets with newer Light Emitting Diode (LED) technology.

The options available vary in color temperature and light levels. Conversion to the new LED technology will result in a savings to the City due to reduced energy usage.

The majority of the costs to convert the streetlights will be covered by Southern California Edison through an incentive program offered by the California Public Utilities Commission.

The public will be able to submit



# CERRITOS' HUBERT H. HUMPHREY DEM CLUB ENDORSES CRISTINA GARCIA

The man known as the Happy Warrior, Hubert H. Humphrey, would not have been happy.

Assemblywoman Cristina Garcia, who was accused of drinking and having sex with elected officials in her Assembly office, hurling racial slurs and epithets at fellow elected officials, asking staffers to play spin the bottle and go buy beer after parties, and harassing employees, has surprisingly been endorsed by the Cerritos Hubert Humphrey Democratic Club led by their Co-President, La Palma resident Larry Caballero.

Caballero sent out an email to HHHDC members this week writing, "last night we learned about the new tax cut that favors the rich and endorsing candidates. Please vote and/or support the following candidates, Assemblywoman Cristina Garcia; Assessor Jeffrey Prang."

Just days earlier an Assembly "investigation" found Garcia, "commonly and pervasively used vulgar language around staff; that Garcia has used staff in the past to perform personal services; and that Garcia has disparaged other elected officials."

"I guess that is acceptable behavior to the HHHDC, Caballero, and the Demo-

cratic Party said one local Republican.

But the Garcia investigation did not pursue other more serious allegations, and a recent article by HMG-CN called into question the transparency of the investigation.

The serious allegations against Garcia not only included the office drinking, the pressuring staff to join her in drinking, but also ordering staff to perform campaign activities in the Assembly office including fundraising and donation request calls, retaliation, and bragging about having sex in her office with other elected officials.

Sources are telling HMG-CN that the allegations of Garcia bragging about having sex in her office could implicate "other married elected officials from Central California" and is the reason why the inquiry ended so abruptly.

Immediately after the findings were revealed, Speaker of the Assembly Anthony Rendon slammed Garcia and removed her from every committee, basically leaving her only with the power to vote on the floor and no power to influence.

Nonetheless Caballero said, "She is committed to [sic] do a good job."

The HHHDC could have passed on endorsing Garcia, or anyone else, leaving the endorsement open, but Caballero

chose Garcia.

In endorsing the embattled incumbent, the HHHDC and Caballero snubbed Friné Medrano, who was recently endorsed by Senator Kevin De Leon and is also endorsed by Worker's United- SEIU, along with Ivan Altamirano, the current Mayor pro tem of Commerce who was endorsed by Norwalk Councilman Luigi Vernola.

When asked to confirm, Caballero indicated if you showed up to the meeting you would get the endorsement. He told HMG-CN, "... only Cristina showed up to speak. She is committed to [sic] do a good job, and the club was supportive."

Mario Guerra, former Downey Mayor and former President of Independent Cities told HMG-CN, "Nothing I see in California politics today surprises me anymore. Especially coming from groups that say they care about equality and social justice and yet take a blind eye to further their own political best interest. The back room deals seem to continue. I wish they would actually work with their members to take active roles in helping solve so many of our problems. We need leadership in Sacramento. Heck, it'd be nice to have representation so maybe leadership is too much to ask for?"

# HMG-CN INTERVIEW: SHERIFF ROBERT "BOB" LINDSEY

HMG-CN sat down with Robert "Bob" Lindsey recently, Lindsey is running against current Los Angeles County Sheriff Jim McDonnell.

### HMG: Give our readers your 30-second elevator speech:

### HMG: Expand on the community participation.

ceration and job opportunity programs, and restore Community Advisory Committees, who's members will directly communicate with the Sheriff on many urgent public safety issues.

Gilleon had the same negative view about the Thomas investigation that Fierro had declaring, "garbage in, garbage out."

The serious allegations against Garcia included alcohol and drinking in Garcia's Assembly office, pressuring staff to join her in drinking alcoholic beverages, harassing staff, ordering staff to perform campaign activities in the Assembly office including fundraising and donation request calls, retaliation, and bragging about having sex in her office with other elected officials.

Sources are telling HMG-CN that the allegations of Garcia bragging about having sex in her office could implicate "other married elected officials from Central California" and is the reason why the inquiry ended so abruptly.

A letter signed by Debra Gravert, Chief Administrative Officer for the Rules Committee, placed the blame of the investigation's lack of interviewing key witnesses squarely on Gilleon's shoulders.

"You advised your clients not to participate or cooperate with Ms. Thomas' investigation... even though this option was offered. Notwithstanding this limitation, Ms. Thomas endeavored to discover the validity of all your client's complaints."

"That's not quite true, an angry Gilleon told HMG-CN, "I tried to negotiate and they kept saying no, I was protecting my clients from retaliation, they did not want to be interviewed by an investigator chosen by the Assembly. With the Assembly's choice of an attorney as an investigator it created attorney-client privilege, and the fact of limitations had run out, this was a charade from the beginning."

Gilleon then produced emails between him, Ms. Thomas, and John Kennedy of Nossaman, LLP with Gilleon trying to get an additional investigator appointed.

In a Feb 21, 2018 email to Vida Thomas, Gilleon expressed his concern that the Assembly retained her, "my clients are willing to meet with you but I am skeptical of any investigation paid for by an employer who has an interest in the outcome of that investigation."

Gilleon demanded a second independent investigator, "please confirm the State's willingness to retain a second investigator to work with you, at which time I will provide you a name of our proposed investigators."

Those investigators, according to Gilleon, would not have attorney-client privilege.

Gilleon sent a follow-up email one week later and included three investigators that Thomas could choose from.

Twelve days later, on Mar. 12, Gilleon received a letter from Nossaman attorney John Kennedy denying Gilleon's demand for a second investigator.

In the letter Kennedy stated, "please send all future correspondence about this matter to me, however if your clients decide to be interviewed by Ms. Thomas, please schedule with her."

Kennedy gave Gilleon fourteen days for his clients to respond in writing to Thomas.

Gilleon subsequently questioned Kennedy and his assertion that Thomas was independent.

"Ms. Thomas, and now you, have emphasized her role as an 'independent' investigator, which seems inconsistent with your apparent order to me not to communicate with her except for sched-

uling purposes."

Gilleon continued making his case that Thomas was not independent, "your letter, cc'd to Ms. Thomas, reeks of gamesmanship and intimidation, and has opened a whole new can of worms labeled 'Conflicts of Interest.' It has only solidified my insistence that another investigator be retained to help keep an eye on the Assembly's influence over this purported 'independent' investigation."

On March 16 Kennedy answered Gilleon and confirmed that Thomas was retained by the Assembly and an attorney-client privilege existed.

"That's what I thought, said Gilleon, the Assembly has an attorney-client privilege with an 'independent' investigator, we'll pass on that charade."

The two parties could not come together, the fourteen-day window expired and Gilleon's clients were never interviewed.

Gilleon subsequently sent an email on April 25 to Thomas, "please provide an update on whether you intend to interview any of my clients, including David Kernick."

Thomas forwarded the email to Tosha Cherry, Humans Resource Director of the Assembly writing, "as you can see from the email I received from Gilleon below he is now apparently willing to let me interview his clients. I have not responded to his email. Do you have time to talk today?"

One day later, Gilleon received a lengthy email from Kennedy indicating the investigation had concluded.

"Take a look," Gilleon wrote, "I had not heard from the investigator (Thomas). I emailed her on 4/25, she did not reply. Instead the Assembly's attorney (Kennedy) responded the next day saying the investigation was complete."

Gilleon heard nothing until Gravert sent her May 17 letter that blamed Gilleon.

Gilleon fired off an email to Gravert, with a copy to Assembly Speaker Anthony Rendon and Rules Committee Chair Kevin Cooley.

"You received (and have re-stated) false information that allegedly I advised my clients not to cooperate with Ms. Vida's (Thomas) investigation. Wrong. I assume you obtained this false information from the attorney you hired (Kennedy) that repeated the same lie to me every time he had the chance."

Gilleon continued, "the record is clear that my clients were, and are, willing to cooperate as long as the Assembly is willing to take the most basic and simple steps to ensure the investigation is fair and no retaliation is permitted."

Gilleon finished accusing the Assembly attorney of malfeasance, "I made this offer very clear to your attorney, but all I got and response from him was arrogance, lies, and disregard if not contempt for fairness, truth, and integrity."

Some say the Assembly's decision to hire a lawyer to investigate was a calculated move given the fact that the statute of limitations had run out on both Fierro and Gilleon's clients.

Since the statute of limitations had run out, the Thomas investigation and all supporting documents are protected by attorney client privilege and can never be revealed.

"Attorney-client privilege would not have existed with any investigator I proposed," said Gilleon, that is why I called it a charade, it was rigged from the beginning."

TORRANCE-It was a good day for Valley Christian High athletes at the California Interscholastic Federation-Southern Section Track and Field Divisional finals last Saturday at El Camino College. Not only were the Crusaders well-represented in the number of competitors, but eight of them had among the top five marks in Division 4, headlined by seniors Gavin Fua and Jake Leue.

V.C. finished in second place in the division, picking up 68 points (Oaks Christian won the division with 81 points) and Fua and Leue were a big part of that. Fua won the discus with a top throw of 177-1 and will move on to Saturday's Masters Meet. He was tied for the fourth best mark of all discus competitors. Earlier in the day, Fua won the division in the shot put with a mark of 51-3.50 but did not qualify for Masters.

"It feels obviously really good," Fua said. "The shot put, I'm not really too disappointed about not moving on for Masters. I still threw a decent mark for how my season went. In the discus, I'm really happy with how it turned out, winning Division 4. I was coming in hoping for a [personal record], but 177 is still a pretty big mark for me."

Fua was the last of nine competitors in his division to throw and after the first of four attempts, he was one of three that did not foul. He threw 174-2 on his first attempt, then watched four competitors foul on their second attempt. He increased his mark to 175-2 after his second throw

and was still leading everyone by a wide margin.

Fua got his top mark on his third attempt, as did Leue, who threw 156-6. All but one competitor fouled on their last attempt, putting Fua and Leue as one and two by a wide margin. V.C. senior Khalil Meade finished in fifth place with a top mark of 140-3, which he accomplished in his first attempt.

"They all performed the way they are trained to do," said V.C. first-year throws coach Will Truong. "They worked very hard and they got here."

"I don't really worry too much about other peoples' throws," Fua said. "But I was really kind of thinking about the wind and mostly my own throws."

Of the combined 36 throws by the nine competitors, only 15 were good. Elsewhere in the discus, senior Madison Silva was second out of nine throwers after her first attempt with a distance of 108-02, which is a personal record. But that would be her top mark and she finished in seventh place in the division.

In the shot put, Leue finished in fourth place with a mark of 48-8.50, which he accomplished on his third attempt. Fua's mark in the shot put was the 20th best out of 36 competitors from all divisions.

"I'm not disappointed because they work hard and they got where they are and they got the titles they deserve," Truong said of Fua not going to the Masters in shot put or Leue in discus. "Why would I be disappointed for them winning the division?"

"This season has been a dream," Fua said. "I only really got into my groove at

When the California Interscholastic Federation-Southern Section Division 2 softball brackets were released on May 14, there may have been a brief smile on the face of Cerritos High head coach Kim Ensey. On the 12th line of bracket was the opponent the Lady Dons would face in the first round, one that Ensey is very familiar with-Edison High.

Ensey may have been smiling early in the week, but not so much towards the end as the Chargers scored once in each of the final two innings to pull out a 2-1 victory last Thursday. The Suburban League champions finished the season at 18-6.

"Playing the Chargers, it's not only my alma mater, but where I coached previous to being at Cerritos," Ensey said. "It's a great program and I knew it was going to be difficult just knowing the culture that's there. I knew we had our work out for us."

With Cerritos leading 1-0 entering the top of sixth inning, Bella Martinez singled and was replaced by courtesy runner Katie Volk. With one out, Volk stole second and scored on an error when Gio Liggett singled.

In the next inning, Edison loaded the bases when Grace Caswell singled, Mikalla Pancino reached on an error and Serena Starks singled. After senior pitcher Jennifer Morinishi struck out Shelby Safell and got Martinez to line out, Nancy Clyne hit a bouncing single into left field to plate Caswell.

"I don't think anything really went wrong defensively," Ensey said. "I think

they were putting balls in play and making stuff happen, and they were taking advantage of some opportunities that they had. We played pretty solid all game. But the longer the game went, they were just putting more and more balls in play."

Before those two innings, Morinishi was dodging one jam after another as the Chargers had runners on base in every inning except the second. She struck out Martinez in the third with runners on second and third and she got Bella Espinosa to ground back to her in the fifth with two outs and a runner on third. Morinishi, who will be attending Biola University in the fall, struck out seven and did not walk a batter.

"Jenny did absolutely everything she could to keep us in the game," Ensey said. "She pitched really well. She was very smart about her pitches and she threw a ton of groundball outs back at her and made some great defensive plays as well."

The Lady Dons jumped out to a quick start in the bottom of the first when Talia Hannappel walked sophomore center fielder Essence Gibbs and Morinishi reached on an error that allowed Gibbs to get to third. Jenna Bloom replaced Hannappel in the circle and despite a pair of wild pitches which sent Gibbs to open the scoring, she proceeded to strikeout the first three batters she faced. After that, Bloom struck out the side in the second and allowed two hits the remainder of the way. With two outs in the third, Morinishi singled just past third base and senior courtesy runner Sydney Arevalo moved to second on a passed ball.

## GAHR SETS THE TONE WITH THREE-RUN FIRST INNING, DOUBLES UP CHAMINADE IN OPENING ROUND

In the Division 1 baseball playoffs of the California Interscholastic Federation-Southern Section, you must always be ready to play and jump on every opportunity that comes your way, especially early in the game. While that may be true in the other divisions, the best that Southern California has to offer reside in Division 1.

Gahr High has been in Division 1 for two seasons and went 10-6 against other Division 1 teams this season. If head coach Gerardo Perez wanted to seal his ninth 20-win season in his 14 seasons with the Gladiators, his team would have needed to beat visiting Chaminade High in a first round playoff game. That's exactly what the San Gabriel Valley League champions did, scoring three runs in the bottom of the first and holding on for a 6-3 victory last Friday at Tom Bergeron Field.

"We scored three [in the first inning and] the one thing that I feel is when you play our schedule and you play the teams we have, things don't go right a lot more than when you don't play those teams," Perez said. "And you get punched in the mouth, or in the gut. You test your resiliency and if you're a competitor, which we are, you get back up. And when you get back up, it makes you better."

With two outs, junior second baseman Tyrese Turner struck out but still made it to first on a wild pitch and

advanced on an error. Patrick Collins then walked senior designated hitter Julian Mungarro and after Turner moved to third on another wild pitch, he scored the game's first run when freshman right fielder Matthew Polk was safe on an error. Four pitches later, senior third baseman Delvan Gomez doubled to left to plate two more runs.

After the Eagles scored twice in the top of the second, the Gladiators added to their lead in the next inning when Collins walked junior catcher Edward Morales, who would eventually come home on a sacrifice from senior center fielder Brandon Shiota. The lead went to 5-2 in the fourth when Shiota reached on an infield single, bringing in senior shortstop Michael Perez, who was safe on Chaminade's fourth error in four innings.

Gahr scored its final run in the fifth when junior left fielder Xavier Estrada singled with two outs and came home on a double to the left field gap by Michael Perez, who will be showcasing his talents at the University of California, Los Angeles in the fall. The Gladiators, who have had a history of playing small ball, had 17 batters reach in some fashion. Chaminade pitchers walked five, hit one and saw another reach on a wild pitch. Two of Gahr's hits went for infield singles and two more reached on errors.

"I think we had a chance to execute with either Polk scoring runners or with Delvan moving runners, and ordinarily

## VASQUEZ PEAKING AT THE RIGHT TIME, STYMIES ALTA LOMA TO PUT NORWALK IN QUARTERFINALS

The illustrious high school career of Norwalk High senior pitcher Breanna Vasquez is reaching its final days. Touted by many of her peers as one of the best, if not the best pitcher in the Suburban League the past four seasons, Vasquez put together a performance that has been so familiar since she was a freshman.

Vasquez allowed only a double to Alta Loma High's Savana Sanders in the top of the fifth inning of this past Tuesday's California Interscholastic Federation-Southern Section Division 4 second round game and the host Lady Lancers scratched together a run in the bottom of the second for a 1-0 win.

But there was much more to the University of Central Florida's success against the Braves as she struck out the first 12 batters she faced (17 for the game) and yielded only one other baserunner. Despite the staggering numbers, it's still not the best that first-year head coach David Gonzalez has seen out of her.

"No, because the last two games she's done pretty much the same thing," Gonzalez said. "She's been dominant; we're still working on getting her stamina back to where it needs to be. If you go back a month and a half, she wasn't able to finish these games. Now she's able to finish these games, and she's going to continue to get more dangerous for these teams."

And to think that Vasquez began the

season un-Vasquez-like as she was hampered with an elbow injury. The coaching staff had to make sure she didn't get worse while not sacrificing a lot of wins. Gonzalez said the biggest part was finding the balance between getting her some innings so that the team stays in games and not making the situation worse. Over the past six games, Vasquez has struck out 83 batters while allowing just four runs.

Vasquez, who has worked into the seventh inning only half a dozen times this season, reached a full count to five of the first 12 batters she faced. With one out in the fifth, and on a 2-0 count, Sanders punched her double to the right field gap. After a sacrifice from Erica Soliz, Vasquez struck out Emily Spain to preserve the lead.

"She gets better the more pressure on," Gonzalez said. "When she starts getting deep in counts...it's just her finding

**A MATERIAL MISPELLING-DID NOCK EVEN KNOW "BIDDLE"**

According to ABCUSD officials, it was Biddle who gave the glowing testimonial about AMN and Nock and how "she worked for Orange Unified."

Given the issues with Nock, HMG-CN researched Ms. Biddle and found nothing, until an internet search combining "Biddle and Orange" returned the name Denise Bittel.

Ms. Bittel, who lives in Villa Park, is extremely active and well-known in the Orange-area community and once ran (and lost) for a OUSD School Board seat in 2006.

Questionably, Nock misspelled an important reference's name twice in her document, and it somehow went undetected during the vetting process.

HMG-CN phoned Ms. Bittel who, true to form, gave a glowing testimonial about Nock's services.

Bittel indicated she "was Co-Chair of the bond" and that Nock "advised heavily on the bond."

But the investigation found that Bittel was not the "Chair of the Orange Unified Bond," as Nock had stated in her bid documents.

Quite the contrary, on the CARE website, Bittel was number twelve on the list as the Endorsements Chair of CARE.

When informed of the findings, ABC Superintendent Dr. Mary Sieu told HMG-CN, "although she referenced Orange Unified and not Orange Unified School Bond on the Reference List, we believed she listed districts where she worked on public relations related to the school bond."

Several emails into ABCUSD Board President Soo Yoo, including requesting a confirmation or denial of her knowing about Nock and Orange Unified, went unanswered.

One ABC resident, who did not want to be identified stated, "So she falsified the bid documents to get her foot in the door, and when questioned said 'oops' sorry I worked for the committee and not the district, and that was OK with the interviewers?"

**A LONG LINE OF QUESTIONABLE ISSUES**

In March of this year, prior to the award of the ABC contract, a HMG-CN investigation into AMN and Nock revealed a suspect and unprofessional website, virtually non-existent social media presence, and troubling conflict of interest relationships.

The revelations should have caused ABC Board members to question and possibly table the AMN vote and send out new requests for proposals.

But ABC President Soo Yoo, who, ac-

ording to sources did not read the March HMG-CN article, Board member Sophia Tse, and Superintendent Dr. Mary Sieu argued against tabling the vote, which would "waste precious time."

Weeks later, HMG-CN obtained AMN's bid documents through a public records request and found additional alarming red-flags.

Nock listed her company address on the bid documents as 3053 Freeport Blvd., Suite 279 in Sacramento. The investigation found the address was a UPS Store inside of a strip mall and the 279 a UPS mail box.

The bid documents also contained a very suspect AMN former client list, with Nock listing clients she serviced while under her employment with George K. Baum as her own.

The client list also fraudulently included the Orange Unified School District as a client.

**CARE MONEY**

Nock was not hurting when she missed the OUSD job and secured her job with CARE.

Campaign records obtained from the Orange County Registrar show that Nock was paid over \$58,000 from August to November of 2016.

Nock raked in \$30,000 for Aug./Sept.; \$21,000 in Oct./Nov.; and \$7,500 in January 2017.

Bittel was also paid over \$2,000.

**A HISTORY WITH I/E'S**

When school districts try to pass a bond, in almost every case an independent expenditure committee is established by residents and activists who want to see the bond passed.

Hundreds of thousands of dollars are contributed to the I/E by organizations and individuals interested in the seeing the bond passed.

Vast sums of money can be made by people involved with the I/E through many avenues; companies receiving money and providing services often add a substantial commission to the cost; many consultants and representatives are hired and paid large monthly retainers.

Companies work very hard to keep track of districts ready to offer bonds and "come out of the woodwork" hoping to cash in on the I/E bonanza and construction work from the bond itself.

Four years ago, the ABC tried to pass a bond and failed. Two years later, Al Gafford suddenly came on the ABC scene, making friends, running two board member's campaigns and attending many events.

Gafford worked with Nock at George K. Baum inside the massive Bond Election Group.

Nobody knew why he became a fixture at meetings, but he did and soon befriended many, including Superintendent Dr. Mary Sieu.

The ABC bond is proposed, bids were sent out, and despite all the issues HMG-CN pointed out about Nock, she is chosen as a finalist and wins the services contract.

Can the establishment of an I/E be far behind?

During the Coachella School District's successful attempt at passing a bond, in 2011 the I/E "IPads for CVUSD Kids, Yes on Measure X" was established.

One of the first contributors was George K. Baum for \$25,000.

Ann Nock and her Creative Director James Stolzenbach were paid as vendors.....

Then with two outs in the sixth, senior first baseman and future California State University, Northridge standout Kiara Crockett-Pope dropped a single into shallow right. But she couldn't get to second. Bloom faced 23 batters, striking out 14 of them and getting five groundball outs.

"We prepared for both," Ensey said. "We knew that Jenna Bloom was going to be very difficult; she has tons of movement. Our game plan changed in how we approached our at-bats, but she just threw a phenomenal game.

"We just talked about the fact that we did reach our goals that we set out this year," Ensey said. "Our goal was to win a league championship. Our goal was to make it to CIF and compete in CIF and I truly believe we competed in this game."

"Jay also picked a ball out of the dirt and Jay also came and got a bunt and got an out on a bunt," Gerardo Perez said. "Even though from afar J.J. offensively didn't have...he's had better games, I'm

very proud of the fact that it didn't let up his defense and his aggressiveness and his willingness to kind of make up for that."

The Gladiators would edge Mira Costa High 2-1 this past Tuesday to improve to 21-8 and advance to the quarterfinals for the first time since 2014 and fourth time since 2005. Gahr will visit third ranked Orange Lutheran High Saturday at Hart Park.

Senior Bailey Torres finished in second place in the 300-meter hurdles at 40.22, a personal record, and in seventh place in the 110-

meter hurdles with a time of 16.62.

Senior Marion Ledesma came in fourth place in the 800-meter run with a time of 2:17.19 while in the 300-meter hurdles, sophomore Kathryn Tamminga was sixth with a time of 48.23. The V.C. girls were 14th in the division with 15 points.

Elsewhere, Norwalk High senior Misty Diaz, running in Division 2, finished in second place in the 1600-meter run with a time of 4:55.45. Diaz, who was sixth in the division at the CIF-State Cross Country championships this past fall, also ran the 800-meter event where she came in eighth place with a time of 2:22.57. Diaz did advance to the Masters in the 1600, claiming the last of the automatic spots and is scheduled to run at approximately

1:17 p.m. on Saturday.

Also, in Division 2, Cerritos High senior Destin Flucas is moving on to the Masters again in the high jump. Flucas was second with a mark on 6-4, which he accomplished on his third jump. He missed on three tries to get to 6-6. He is scheduled to jump at approximately 11:30 on Saturday.

Cerritos sophomore Nicole Blue finished sixth in the 400-meter run with a time of 57.80 and claimed the same spot in the 200-meter run with a time of 25.43.

Finally, Whitney High senior Justin Hogenauer came in seventh in the 800-meter run with a time of 2:00-33 while senior Angelina Crittenden took eighth in the 100-meter run with a time of 12.71.

SUMMARY OF ORDINANCE NO. 581U OF THE CITY OF HAWAIIAN GARDENS, CALIFORNIA, ADOPTING AN INTERIM URGENCY ORDINANCE RELATING TO ACCESSORY DWELLING UNITS PURSUANT TO GOVERNMENT CODE SECTION 65858

Pursuant to Government Code Section 36933 (c), the following constitutes a summary of Ordinance No. 581U ("Ordinance"), adopted to extend an interim urgency zoning ordinance pursuant to Government Code Section 65858, and approved by the Hawaiian Gardens City Council on May 22, 2018, at its meeting held in the City Council Chambers, 21815 Pioneer Boulevard, Hawaiian Gardens, CA 90716.

The purpose of the Ordinance is to extend the temporary development standards for new "accessory dwelling units" ("ADU" or "ADUs") in the City of Hawaiian Gardens ("the City"), as such standards were originally established on April 10, 2018. In substantial part, the Ordinance:

- Allows one ADU per lot in residential zones (R1:10,000, R1, R2, R3, or R4), provided the subject residential lot is at least 7,500 sq. ft., and provided there is a single-family home on the lot;
Specifies both the minimum and maximum height and setback requirements for ADUs;
Absent specified conditions, requires a minimum of one (1) off-street parking space for each bedroom in an ADU
Requires property owners to be an owner-occupant of the ADU or single-family dwelling on the lot, and prohibits ADUs from being rented or leased for periods less than thirty (30) days;
Prohibits ADUs from being sold separately from the primary single-family residence; and
Adopts and imposes various building standards and requirements associated with structures meant for human habitation.

Any application for an ADU that does not comply with the Ordinance will be denied.

A certified copy of the full text of the Ordinance is posted and available for review in the City Clerk's Office at 21815 Pioneer Boulevard, Hawaiian Gardens, CA 90716. As an interim urgency ordinance, the Ordinance became effective immediately upon adoption, and will expire on April 10, 2019, unless after a public hearing the City Council elects to further extend it. The Ordinance was adopted by the City Council on May 22, 2018, by the following roll call vote:


Garcia appeared to have been drinking heavily at a fundraiser at the de Veres bar in Sacramento.
