LA MIRADA'S MEASURE I
CITIZENS' OVERSIGHT
BOARD PRESENTS
ANNUAL REPORT

The Measure I Citizens' Oversight Board presented its fifth Measure I Annual Report to the La Mirada City Council during the September 11 Study Session meeting.

The five-member Board was created to review and report on revenues and expenditures of Measure I funds, the City's one-percent transactions and use tax approved by voters in 2012.

Measure I officially expired on March 31, 2018. It generated more than \$29 million over the five year term, exceeding original estimates ranging from \$20-\$25 million. The monies generated by this measure fully funded four phases of neighborhood street improvements with a fifth and final phase starting construction in the fall.

The City of La Mirada is exploring alternative revenue

CERRITOS' SHERIFFS HOST 2ND ANNUAL CAR SHOW
The outreach effort started as a deterrence to street racing

The Cerritos Sheriffs and the Los Angeles Sheriff's Department co-hosted their second annual Motorsport Scholarship Car Show at the Cerritos Sheriff's Station located on Bloomfield this past Saturday September 15, 2018.

Twenty years ago two Los Angeles County Sheriffs Deputies developed a community outreach program combining their passion for racing cars and helping the community. The program was originally developed to deter illegal street racing, drug abuse and gang involvement. From those humble beginnings, LASD Motorsports evolved into the largest law enforcement racing and outreach team in the United States and has received the Award of Merit from the National Sheriff's Association for "Innovative Community Program".

It didn't take long to realize the race cars were an effective means to attract an audience. "It's no secret, kids like cool cars," says Detective Erik Reynolds, "kids are inquisitive and drawn to our vehicles. This gives us an opportunity to interact with

young people in a more subtle, non-authoritative setting. Our experiences in racing generate real stories we can share about team spirit, hard work, humility, overcoming challenges, dealing with disappointment, and achieving goals."

Although the initial target audience was geared towards kids, many adults are fascinated by the vehicles, people of all ages stop to talk about the cars, the spon-

sors, law enforcement, or to simply say "hello". The outreach efforts then expanded to include public safety programs, issues affecting the community, and developing a mutual trust within the community.

As the audience grew, so has the show. More deputies have joined the team over the years bringing with them a variety of race vehicles. Saturday's car

ABCUSD MEASURE BB CAMPAIGN KICK-OFF EVENT DRAWS HUNDREDS OF SUPPORTERS

ARTESIA — It was standing room only as enthusiastic supporters of Measure BB, a \$258 million safe schools bond slated for the Nov. 6 ballot, gathered Thursday at the Artesia DES Halls’ Portuguese Hall.

Members of the Yes on Measure BB for Safe and Modern Schools in ABC campaign committee welcomed ABC Unified School District employees, students, parents and interested members of the surrounding community to rally for a successful campaign.

“You all are the hope for our kids and grandkids, and you being here shows you are passionate about doing right by them, and how important it is to get behind the passage of this bond,” said Maynard Law, ABCUSD board member and chairman of the campaign committee.

The bond will finance upgrades to campus safety and security, technology, and 21st century learning environments.

“We are one of the top districts in the nation, with 21,000 K through 12 students and another 10,000 adult students, with unbelievable academics,” he said. “Now, we need to upgrade our facilities.”

The bond would fund the improvements encompassed in the district’s Facilities Master Plan, including safety and security, technology, state-of-the-art improvements; parity and sustainability issues.

Each school would receive from about \$4.5 and \$6.5 million to pay for the upgrades.

Law emphasized the bond money would be strictly monitored.

“Not one dollar will will go to pay for

teachers’ salaries of the district’s operating expenses,” he said.

ABCUSD Superintendent Mary Sieu called Measure BB a bold plan and a critical point in the district’s history.

Inspired by the words of Martin Luther King Jr., she said “this is not the time for the status quo, but a time to make history.”

Recent Cerritos High School graduate, Matthew Scammahorn, spoke in support of Measure BB, as did a group of current Artesia High School students.

They said that safety, a 21st Century learning experience, upgrading classrooms and making campuses greener were important.

“As a first-time voter, I am enthusiastic about voting for this bond,” said Scammahorn, who is s student at UC San Diego.

The improvements did not happen overnight, as Brad Beach, chairman of the Facilities Master Plan committee, said.

It was a process that took more than a year to identify the needs for each campus.

As a father of two young daughters — one of whom is an ABCUSD student and the other a future one — he supports the bond, especially the upgrades pertaining to safety.

Part of the event also included volunteer sign-ups for phone banking and walking precincts.

Some elected officials in attendance included: Assemblywoman Cristina Garcia, Cerritos Mayor Mark Pulido, Cerritos Councilman Frank Yokoyama, Artesia Councilmen Ali Taj, Victor Manalo, and Miguel Canales, and ABCUSD Board President Soo Yoo.

KEEP CHILDREN SAFE AS THEY HEAD BACK TO SCHOOL

Cerritos is home to some of the best school districts in the country, including the ABC Unified and Bellflower Unified School Districts.

This year the ABC Unified School District was honored as a 2018 Exemplary School District by the California Department of Education.

Cerritos, Elliott, Gonsalves and Leal elementary schools were honored as 2018 California Distinguished Schools.

As the father of two children attending schools in Cerritos, school safety is of the highest importance to me and my wife. With thousands of local children now back to school, the Cerritos Sheriff's Station/Community Safety Center and the National Safe Routes to School Program encourage the community to heed the following school safety tips:

- Parents and children should hold hands in parking lots.
- Never allow children under age 10 to cross streets alone. Adult supervision is essential until you are sure a child has good traffic awareness and judgment.
- Children should walk on direct routes with the fewest street crossings.
- Make sure children know to cross 10

feet in front of a school bus, never behind, and to wait for adults on the same side of the street as the school bus loading or unloading zone.

- Teach your child never to run out into a street for a ball, a pet or any other reason.
- Slow down and obey all traffic laws and speed limits. This may be the most important safety tip to observe around schools.
- Comply with school drop-off and pick-up procedures. Many schools in Cerritos have student valet or parking lot transition programs and should be used if possible.
- Avoid double parking and stopping in crosswalks or in people's driveways to let children out of the car. Do not allow children to cross the street mid-block, and teach them to use crosswalks. Cerritos Sheriff's deputies have been directed to issue citations for these violations.
- Stop for a school bus when red overhead lights are flashing or a stop sign has been activated on the street side of the bus. Violating this law may result in a very expensive citation.
- Watch for children crossing streets near schools or at nearby corners. Pedestrians have the right-of-way when in marked or unmarked crosswalks. (Any intersection has an unmarked crosswalk unless a posted sign says otherwise.)
- Watch for children on sidewalks when backing out or entering a driveway.
- Pay attention to the directions of crossing guards, and take the time to thank them occasionally. These guards put themselves at risk every day to protect the kids.

Thanks to the work of the crossing guards in the city, I can rest assured knowing that the children of our community are

in good hands while navigating the streets around their schools. The work that our crossing guards perform throughout the year is invaluable in helping to ensure the safety of all of the children and families in our community.

There are 25 crossing guards in the City whose years of service range from months to 37 years. Regardless of their number of years served, their spirit and professionalism contribute to the City's outstanding reputation. Our crossing guards are part of the unsung, everyday heroes who help make Cerritos safe and livable for all.

The crossing guards who work for the City of Cerritos and their years of service are: Angie Bednar, 37 years; Gene Hanners, 21 years; Dan Clark, 18 years; Patricia Knight, 17 years; Gloria Vargas, 17 years; Jim Hauser, 16 years; Michael Wheeler, 15 years; Lynden Lischer, 14 years; Catherine Corbett, 11 years; Barbara Murphy, 11 years; Gary Bozeman, 11 years; Trina Burrell, 10 years; Victor Aguilar, 10 years; Donna Vena, seven years; Mark Hayes, seven years; Edward Johnson, four years; Shirley Hall, four years; Gladstone Barnes, three years; Pat Kinney, two years; Dave Lance, two years; Belen Romero, one year; Steven Bougher, one year; Fengrui Xu (substitute guard), one year; Patricio Evidente (substitute guard), one year; and Matthew Coley (substitute guard), four months.

I would like to thank and recognize each and every one of our City crossing guards. CAMPUS SECURITY IN THE ABC UNIFIED SCHOOL DISTRICT

On May 25, 2018 CNN reported that just 21 weeks into 2018 year, there had been 25 school shootings nationwide. And, while only three of those tragic events were in California, student and staff safety and security are in the forefront of all our minds.

Wherever a school tragedy occurs in the nation, it affects all of us in ABCUSD. Parents trust their students

to us to learn, grow and dream, but more importantly, they expect their loved ones to be safe. ABCUSD takes this responsibility very seriously. Over the past several years, the District has made many improvements in our schools to improve the health and safety of our students and staff. Below are some examples of our efforts to date:

- Installed security cameras at all high schools and in the process of installing security cameras at all middle schools
- Modified the drop-off and pick-up areas to improve traffic flow congestion at 8 (out of 30) of our schools
- Installed privacy slats in the kindergarten areas at elementary schools
- Installed additional external lighting at some of our schools
- Trained administrators and staff regarding Active Shooter
- Partnered with local law enforcement to review and update the schools Emergency Operations Plans

In addition, the Maintenance & Facilities staff, along with security experts, visited our schools and met with the principals, to assess specific security improvements projects at each of our 30 school sites.

More than two years ago, the Board of Education formed a Facilities Ad Hoc Committee to evaluate our school facilities and update the District's Facilities

Master Plan. After 18 months of work, involving more than 1,000 students, staff, parents, and community members, the 28 member Facilities Ad Hoc Committee has identified School Safety and Security as the number one priority for ABC USD.

Many ABC schools were built over 50 years ago in a very different era. Given what we have learned on school tragedies, our schools need security improvements. Annually, the Board of Education budgeted \$2 million to address safety & deferred maintenance projects. In the 2018-19 school year, the Board approved an additional \$3 million to be used for school safety and security projects.

But, these funds will only go so far, and it will take a very long time (up to twenty years) to perform all identified safety and security projects. Our schools have security improvement projects that needed to be addressed immediately, and unfortunately, the State of California does not provide sufficient funding security improvement needs.

Based on the recommendations of the Facilities Ad Hoc Facilities Committee, on July 17, 2018, the Board of Education approved Measure BB – Safe and Modern Facilities, a general obligation bond measure to be placed on the November 6, 2018 ballot. Measure BB, if approved by voters, authorizes ABC USD to issue up to \$258 million in general obligation bonds to A) Enhance school safety and security; B) Build classrooms for Science, Technology, Engineering, Arts, and Math (STEAM) and C) Create interactive learning environment. Measure BB is estimated to cost \$49.50 per \$100,000 in assessed value property taxes (not market value) annually.

WITTMAN CELEBRATES THE BIRTHDAY OF THE U.S. CONSTITUTION

Monday, September 17, 2018 marked the 231st birthday of the Constitution of the United States. Constitution Day, also known as Citizen Days, commemorates the formation and signing of the U.S. Constitution by thirty-nine men on September 17, 1787, recognizing all who are born in the U.S. or by naturalization, have become citizens.

Wittmann Elementary School held their second annual Constitution Day featuring guest speakers Cerritos Mayor Mark Pulido, Superior Court Judge Mrs. Laura Walton, and ABCUSD Superintendent Dr. Mary Sieu.

Principal Miguel Marco stated the guiding premise to holding this event, “On Constitution Day, we explore how and why the U.S. Constitution was created. In today’s political atmosphere, there are many discussions about government, public service and the laws of our land.”

Marco continued, “It is always important for us to provide our students with the context as to how the Constitution plays a pivotal role in their lives. At Wittmann we want our students to know and understand how their local community and government function and how our public officials uphold and interpret the Constitution.”

Each speaker talked about their job and background, why they choose their career path, and the relationship between their job and the U.S. Constitution. Questions ranged from how each speaker choose their path to what they would or change if they ran for President.

Each speaker related to the students the hard ships that they faced growing up. Pulido had to overcome a sever speech impediment, Dr. Sieu could only speak Chinese as a child and had to learn a new language, and Walton was ridiculed as a child because she wanted to be lawyer at an early age.

Addressing the fact that each one of us has issues to overcome, even those who hold public office, seemed to resonate with 4th, 5th and 6th grade students. “We had to do a report on a career day when I was in fourth grade, I did my report on being a lawyer,” told Walton, “ I had a great fourth grade teacher, and teachers make all the difference, she read my report and encouraged me to become a lawyer. Even in the segregated South, I would get laughed at. I remember being frustrated – but I pursued

my dream and it paid off.”

A student asked what the hardest part of their jobs was, Dr. Sieu responded by saying, “ The hardest part of my job is that ABCUSD serves five cities, and the biggest challenge is knowing everyone that works in these cities. That means knowing all the staff in 30 schools, with 21,000 diverse students and over 2,500 teachers and staff members. My job is to make sure that each one of these is represented. And that’s a lot of people!” The hardest part for Mayor Pulido and Judge Walton were having to make hard decisions in difficult situations.

The question about being fair was asked. “Every time we have a City Council meeting there is also a time for public comment, where anyone can come up and speak to the Council. This is the right to free speech and the right to assemble, this is the first amendment of the Constitution,” states Pulido, ”I may not agree with what the person is saying, but they have the right to express their views. I have taken an oath to uphold the Constitution. In a free society we should be able to express our concerns and not be afraid that someone will hurt us or our family because of it.”

After a short break, the second portion of Constitution Day was to bring in the 1st, 2nd and 3rd grade. Their questions were straight forward asking what it was like to put someone in jail or fire an employee.

The most popular answer was to the question, what is your favorite book, to which Dr. Sieu replied, ” My most favorite book of all time is ‘Oh The Places You’ll Go’ by Dr. Seuss.” To which there was a loud burst of laughter and applause.

sources to help complete the final phase of Measure I neighborhood street improvements, including SB 1, gas tax and Measures M and R.

Phases 1, 2, and 3 of Measure I work are complete. Phase 4 is substantially complete, and Phase 5 is designed and will go out for bid in the fall with construction following shortly thereafter.

“The Oversight Board has verified that the Measure I funds used during the July 2017 through June 2018 reporting period were spent as intended to improve the City’s infrastructure,” said Chairman Scott Watkins who presented the information to the City Council.

“If maintained properly, these improvements should allow City streets to stay in good condition for the next 20 years.”

During the reporting period, a total

of \$10,446,441 in Measure I funds were spent on neighborhood infrastructure improvements. Some \$4,439,327 was spent on Phase 3, \$5,504,251 was spent on Phase 4, \$179,022 was spent on storm drain repairs connected to the City’s neighborhood street rehabilitation projects.

Over \$323,000 was spent on the design work for Phase 5, which is expected to begin this winter. Phase 5 will include similar neighborhood improvements in all residential streets bounded by Imperial Highway, Biola Avenue, Stage Road, Valley View, and Milan Creek. This phase will also include extensive storm drain work.

The Measure I Annual Report will be placed in the upcoming issue of the City’s newsletter and on the City’s website.

The new stormwater capture system at Bolivar Park includes a small 10' x 14' windowless building that contains equipment for sending stormwater from the flood control channel to the new reservoir under Bolivar Park.

To make that building more attractive and to fit into the neighborhood, the city designed a plastic wrap to go around the building and make it look like a Lakewood-style house. The graphic wrap was installed on September 10.

Work continues on the final adjustments to the Bolivar stormwater project. The grass field north of the swimming pool is now looking better and is open for use. It will get re-seeded in the near future to look even better. The field will be closed during that re-seeding time. All three of the new picnic shelters installed at the park are now open for use. The most westerly shelter will be closed temporarily when the field next to it is re-seeded.

What is Measure BB?

Measure BB is a \$258 million general obligation bond measure that will provide our students and community with improved and upgraded school facilities that are safe, secure, and modern.

How will Measure BB support the Facilities Master Plan (FMP)?

Measure BB will provide funding to support the five key goals identified in the FMP - the acronym is STEPS.

- **S** (Safety/Security): Improve student safety and campus security systems including establishing a single point of entry, visitor management, security fencing, security cameras, emergency communications systems, smoke detectors, fire alarms, and sprinklers.
- **T** (Technology): Keep instructional technology up-to-date and provide instructional network, infrastructure, and furnishings.

Will Measure BB improve instruction?

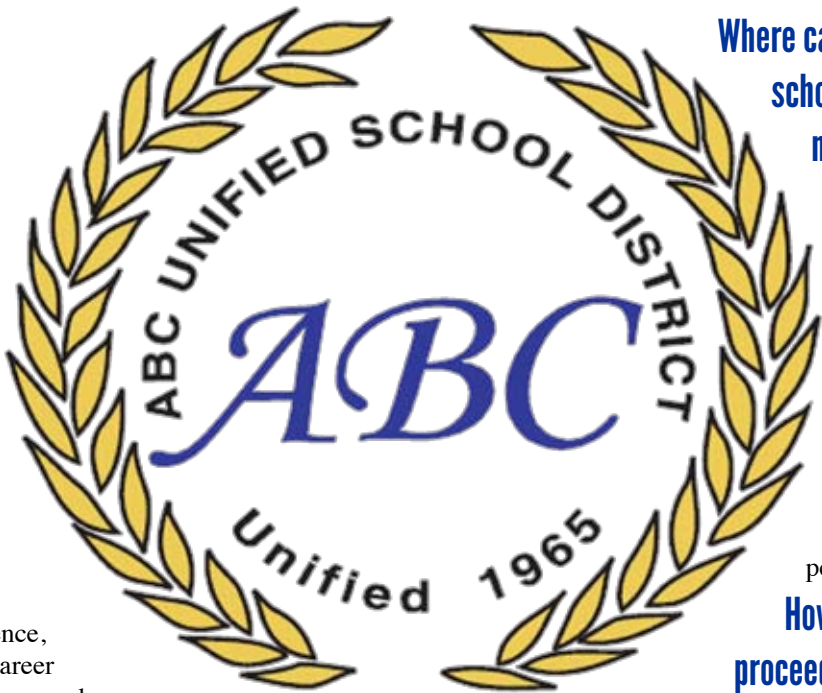

The Oversight Committee will review all expenditures and construction projects to ensure accountability.


Who can vote on Measure BB?

All registered voters living within the ABC Unified School District boundaries will be able to vote on Measure BB as long as they are registered by October 20, 2018.



Historically, the same area football and girls volleyball teams have advanced to the CIF-Southern Section playoffs consistently year after year. That would be Gahr High, Norwalk High and Valley Christian High for football and Cerritos High, Gahr, Norwalk and Valley Christian for volleyball. But as the midway point approaches, there may be a changing of the guard on the gridiron while one volleyball team, Cerritos, seeks a long-awaited league championship.

El Dorado High (2-2) @ Artesia (3-1)-Senior quarterback Heder Gladden continues to carve through the opposition as he scored three more touchdowns on the ground and threw for two in last Friday night's 52-27 win over Vasquez High. El Dorado edged El Modena High 29-27 last time out and the Golden Hawks have alternated wins and losses. While the Pioneers have scored 54, 51 and 52 points in their last three games, El Dorado has 62 points on the season. One more win will match Artesia's total of last season and only twice since the 2013 season have the Pioneers had a winning season.

John Glenn High (2-3) @ Hawthorne High (2-2)-After winning two straight games in which they scored 49 and 46 points, the Eagles stumbled to a 42-28 loss to Western High last Friday night. The Cougars lost to Leuzinger High 50-44 last Friday and like Glenn, can score in bunches. Hawthorne is averaging 40 points a game, five more than what Glenn is averaging. Hawthorne is led by quarterback Kyle Williams (40 of 70, 771 yards, nine touchdowns, two interceptions) and Joseph Taylor III (50 carries, 631 yards, seven touchdowns). The Eagles will need to kick it in gear if they

are to match and exceed last season's 5-5 mark. But, they can't be looking ahead to next week's meeting with crosstown rival Norwalk.

Norwalk (0-5) @ Norte Vista High (3-1)-The Lancers are going through their worst start to a season since 2011 when they lost all four non-league games and ended with a 3-8 mark. They were man-handled by California High 45-0 last Friday night and have just seven touchdowns on the season. On the other side of the field, the Braves blasted Corona High 49-22 Friday and have back to back games of at least 42 points. Norte Vista is a run-oriented team, having rushed for close to 1,300 yards. The Braves have five players with over 100 yards rushing, three over 200 yards and two over 300 yards. One more loss will be Norwalk's first losing season since 2011 and unless it can win at least two Suburban League games, the Lancers will not be going to the playoffs for a 12th straight season.

La Salle High (0-5) @ Valley Christian (1-4)-Here's a chance for the Defenders to get a win before tackling the Olympic League competition. V.C. fell to rival Ontario Christian High 40-17 last Friday, the third straight game it has yielded at least 40 points. The Lancers are dismal, scoring just 13 points while being shutout 64-0, 56-0 and 78-0. Three different quarterbacks have combined for 313 yards and the Lancers have rushed for 157 yards. The Defenders got another touchdown from senior running back Curtis Walhof (90 carries, 476 yards) and another touchdown pass from senior quarterback Hayden Ericks (43 of 98, 588 yards, five touchdowns).

Like Norwalk, the Defenders are in jeopardy of missing the playoffs, which would be the first time since 2012 and are on the verge of a non-winning season for

the first time since 2013.

Gahr is in a very good position to win the San Gabriel Valley League for the second time in three seasons as the Lady Gladiators improved to 12-6 overall and 4-0 in the circuit following a sweep against Paramount High this past Tuesday. Gahr visited Downey High on Sept. 20 and will travel to Dominguez High on Tuesday before meeting Lynwood High at its place two days later.

John Glenn has also struggled in the new 605 League, dropping to 2-12 overall and winning once in four league matches.

The Lady Eagles host second place Whitney High today and Oxford Academy on Tuesday.

Norwalk hosted Mayfair High on Sept. 20 with first place on the line in the revamped Suburban League schedule. The Lady Lancers entered that match at 4-5 overall but 2-0 in the circuit as the first of three rounds ended. Norwalk will visit La Mirada High on Tuesday before hosting Bellflower High on Thursday.

Valley Christian began its tournament on a good note, going 2-1 in pool play action last Friday and defeating Sonora High in the first playoff game last Saturday morning. But the Lady Defenders were then swept by St. Joseph High and Millikan High, then failed to win a set at Whittier Christian High this past Tuesday. V.C. (15-10 overall, 1-2 in the Olympic League) will visit Maranatha High on Tuesday and Village Christian High on Thursday in its final regular season road match.

LONG BEACH-Gahr High head coach Greg Marshall said he wasn't discouraged of his team's 1-3 record because the problems can be fixed. Those problems, among others, stem more on the defensive side of the ball which have prevented the Gladiators of potentially having a 4-0 mark.

While Gahr's offense has mustered one second half touchdown in each of the last three games, the defense has blown half-time leads in the last two contests, including a five-point advantage to St. Anthony High last Friday night at Clark Field. In fact, the Gladiators led 20-7 but was edged by the Saints, again, when Xavier Hernandez scored on a fourth and goal sneak with 6.3 seconds remaining to rally the hosts to a 31-28 win. Two seasons ago, on the same field, in a CIF-Southern Section Division 10 first round game, Gahr had a 21-7 lead before falling in the final seconds on a field goal following a crucial fumble inside the red zone.

"They're all the same," said a frustrated Marshall. "We're still trying to find a defense. This is the second week of a new defensive personnel, so we had guys going both ways. That had a lot to do with the second half. The problem was we missed too many opportunities in the first half when we should have been up [more]."

Gahr found itself down 7-0 just over five minutes in when Blake Banks picked off senior quarterback Jordan Simpson and went 70 yards the other way. But on Gahr's next play, Simpson redeemed himself when he found senior wide receiver Marcelous Hayes for an 80-yard score. The extra point was missed but the Gladiators were back in the game. That was especially true early in the second quarter when they stopped the Saints on downs following a 14-play drive that lasted over

seven minutes. Gahr took advantage and went up 13-7 on a Simpson 70-yard scoring strike to senior running back/wide receiver Micah Bernard.

Despite a fumble on Gahr's next possession, the lead expanded to 13 points on a 62-yard score from Simpson to junior wide receiver Aaron Okoro. Gahr's defense continued to dominate the half as senior linebacker Evan Smith recovered a fumble four plays later and the visitors were looking for more points.

But with 2:38 left in the half, senior kicker Carlos Sandoval saw his 29-yard field goal attempt go right. St. Anthony took advantage and cut the lead to 20-15 on a 13-yard pass from Lucas Lehmar to Hernandez with 46.9 seconds remaining. Gahr had the ball for less than nine minutes and ran 23 plays in the first half. That would change for the final 24 minutes.

On Gahr's first possession of the second half, a bad snap on a punt attempt put the ball at the seven-yard line where two plays later, Lehmar scored from a yard out. But the Gladiators regained the lead almost three minutes later when Simpson threw his fourth touchdown pass of the night, this one to Sandoval for 36 yards. Simpson would end the night 11 of 24 for 391 yards and all but one of his completions went for at least 12 yards.

"He is still inconsistent," Marshall said. "He could have had a big night; he kept missing guys. And that was a big problem in the first half, and in the second. He's okay, but he's not executing at a high enough rate for us because we can't stop anyone on defense."

The Gladiators were still looking somewhat good early in the fourth quarter when Eamon Pool-Harris couldn't get a field goal attempt off because of a bad snap. But starting at its own four-yard line, they could only get to the 27-yard line before punting. However, another bad



snap resulted in a safety and a 28-23 lead with 8:25 left in the game.

"He just snapped it over his head," Marshall said of his center. "He's been fine all year, then he had a semi-bad one last week and then [tonight], he snapped two over his head."

After gaining 392 yards in the first half, the Gladiators were limited to 60 yards in the second half. Simpson completed only two passes and was sacked four times after halftime.

"We were out there all night, number one," Marshall said. "Then number two, we got tired because all those guys were playing both ways for the first time. We used all our linemen both ways."

On paper, this seemed to be a cross-roads game for both teams. The Saints, who won the division championship two seasons ago, were coming in winless

Behind a solid performance from senior outside hitter Samantha Oh and junior outside hitter/middle blocker Nicole Blue, the visiting Lady Dons swept upstart Whitney 25-13, 25-14, 25-19 this past Tuesday afternoon in the new battle for top dog in the new league.

"That's what it was," said Cerritos head coach David Cuthbert of the battle. "We were both undefeated [in league] coming into today and we're not much more than a mile apart. The kids know each other, so, it's a big game. There's always going to be a big game. It was a point of emphasis to make sure that we came in with the right frame of mind, from the players to the bench to my lower levels being loud in the stands."

Cerritos, the seventh ranked team in the CIF-Southern Section Division 5 poll, never trailed in the first set, building a 7-2 lead, then expanding it to 14-5 following an ace from sophomore outside hitter/middle blocker Karina Gatewood. The Lady Wildcats (10-5 overall, 3-1) never strung consecutive points together until the end when sophomore setter Nika Fedorova had a pair of kills around a block from sophomore middle blocker Chizaram Izima. But a kill from Blue and an ace from Gatewood ended the set.

It was a little easier in the second set



as once again, Whitney never tied or led. At 11-6, a kill from Blue gave the serve to junior setter Emily Pasion, who reeled off six straight points. The hosts managed back to back points once, and not until it was 19-8. But the Lady Wildcats made it interesting in the third set.

They took their first lead at 3-2 on a kill from junior outside hitter Skye Garcia and held their largest advantage at 6-3 on an ace from senior setter Crystal Wang. But the Lady Dons (16-3, 4-0) tied the set on back to back Gatewood kills. There would be five more ties until Oh had her 10th kill, then served three straight aces to make it a 19-16 lead. After Izima had a kill and a block, Cerritos iced the set, and match, with five straight points.

Cerritos had won 11 straight matches until falling to St. Joseph High in the championship match of the Gold Division of the Valley Christian Tournament last

team, they ensure a well maintained and beautiful Artesia, this award recognizes their outstanding performance.

Rawlings also reported that the City is moving quickly through the tree trimming plan, moving into the fourth district of the city for the next two weeks. The Norwalk Boulevard project has been moved up to begin this fall and the design for Pioneer Boulevard [Northern border] is almost complete.

The street will be repaved and re-stripped, additional parking and a cross-walk will be added, with work scheduled to be completed within 60 days.

A presentation was made on the West Santa Ana Branch Transit Corridor Project by Julia Brown, the Metro Community Relations Manager for the Gateway Cities Region. Brow reported on the feedback that was gathered in the latest meetings. Most recently the committee conducted another round of meetings where the community feedback was gathered once again. The project overview is 20 miles long with 15 new stations passing through 20 individual cities. The area covered currently has 1.4 million people residing in the study area which is five times higher than Los Angeles County. Over one thousand comments have been collected regarding the north-south alignments, with two alignments being chosen. One alignment will take passengers into Union Station and the other takes riders to 7th and Metro. City Council had numerous questions regarding the proposed terminal station, the ridership analysis will be considered as well as bus connections and traffic circulation patterns.

The Draft DAR will be released in 2020. After this release public hearing will be made and a locally preferred alternative will be considered.

Downey based Park Water addressed Council regarding general rate case and utility increases, Park serves 63 customers in northern Artesia. Park reported they have replaced nearly 2,000 feet of water mains, replaced 38 services and installed two new fire hydrants.

Park told the Council that they offer, at no charge to customers, delivery and installation of ultra high efficiency toilets, home water use surveys, water saving devices, and consultations with Water Conservation Coordinators.

A public participation meeting will be held this fall to discuss the increase in rates with a “modest” rate adjustment expected in 2019, 2020 and 2021.

gan in early March when HMG-LCCN exclusively reported on a lunch meeting at Pico Rivera’s Dal Rae restaurant.

The meeting was attended by Armenta, Mayor Gustavo Camacho, two “potential city vendors,” former City Manager Rene Bobadilla, and former Assistant City Manager Ben Cardenas.

During the meeting, Armenta ordered Bobadilla to illegally terminate the City’s contract with LEBA Inc., the long-time operator of the Pico Rivera Sports Arena.

Bobadilla objected to the termination arguing that LEBA was not in violation of their contract.

An angry Armenta stood up from the meeting and reportedly yelled, “if that is the way you want it, then we will do some-

thing else.”

Brown Act Violation?

Days later, Armenta ordered Bobadilla to attend a meeting that Greg Salcido “unexpectedly” attended.

Bobadilla was told that Armenta, Salcido, and Tercero would vote to terminate him from his City Manager position and gave him until the close of business March 7 to resign.

HMG-LCCN reported on the scheme, forcing the three Councilman to postpone the bogus resignation until the next Council meeting.

Before the meeting, Armenta, Salcido, and Tercero, without public input, voted 3-2 in closed session to approve a “separation agreement” with the City, with sources telling HMG-LCCN that Bobadilla received nearly \$500,000 in severance pay.

Following Bobadilla’s departure, the three then set their sights on Community Development Director Michael Garcia.

Garcia saw the writing on the wall and resigned to accept a similar position in Norwalk.

Following the Garcia resignation, Assistant City Manager Ben Cardenas resigned to accept a finance position in the private sector.

Resident John Albitre, who protested the forced resignations, told HMG-LCCN, “What Armenta pulled along with Tercero and that military hating Councilman Salcido was absolutely criminal. Those three colluded together in advance to fire a good man. Furthermore, Salcido and Tercero aided and abetted Armenta in the criminal act of extorting a government employee [to terminate the LEBA contract], forcing him to choose between committing a crime or saving his job.”

After Cardenas’ resignation, Armenta and company then set their sights on Enriquez who finally succumbed to the pressure and resigned yesterday.

The resignations of Enriquez, Garcia, and Cardenas leave the City Manager, Director of Public Works, and the Director of Finance management positions vacant, with no one to take charge.

Finding a replacement will be challenging; according to sources, the City has been blackballed by recruitment firms due to the toxic culture inside City Hall.

Councilman Bob Archuleta did not mince words telling HMG-LCCN, “The loss of [James] Enriquez is a huge blow to the City. He was pulling double-duty serving as our Interim City Manager and Director of Public Works. This resignation stings especially when considering that we also recently accepted the resignation of Cardenas. Both had stepped up to serve the city well.”

“Enriquez” resignation will present major challenges on a scale the City has never seen before.”

With the recruitment blackball, Archuleta has taken the lead and asked City Attorney Arnold Glasman to locate and hire a qualified City Manager to fill the position.

But even that could be problematic.

Sources have told HMG-LCCN that Armenta is attempting to fire Glasman, after the Council voted 4-0 to deny paying Armenta’s legal fees in the upcoming lawsuit filed by LEBA.

The LEBA lawsuit was first reported by HMG-LCCN.

In his comments, Archuleta made his sentiments clear that the three-member voting bloc of Armenta, Salcido and Tercero had caused the current City problems when they “forced Bobadilla out.”

Archuleta, who is the front-runner to be elected to the State Senate representing the 32nd District in November, told HMG-LCCN that he was adamantly against the removal of Bobadilla and firmly believes that the firing of Bobadilla “could have been a political vendetta.”

ABC FAMILIES FOR BETTER SCHOOLS-YES ON MEASURE BB CAMPAIGN OFFICIALLY KICKS OFF

ABC Families for Better Schools-Yes on Measure BB campaign committee (ABC), FPPC number ID# 1407078, supporting the badly needed infrastructure bond for the ABC Unified School District, has officially kicked off its' campaign sending out an informational full-color flyer to resident's in the district that will be hitting mailboxes beginning this Saturday.

The committee is co-chaired by four ABC Board Trustees including Vice President Leticia Mendoza, Clerk Olga Rios, and Board Members Ernie Nishii and Christopher Apodaca.

Cerritos resident Daniel Fierro of Presidio Strategic Communications, who is also a product of the ABC school district and a graduate of Whitney High School, is the general consultant of the committee.

Fierro told HMG-LCCN, "This is the beginning of a long campaign to educate ABC voters about the benefits of Measure BB."

"This is a school improvement measure that will let us invest in the long-term academic excellence of our district, and will come back to voters in increased property values and community services."

The flyer touts that Measure BB "will increase academic performance, improve student attendance, retain high quality teachers and staff, and enhance property values."

ABCUSD currently serves over 21,000 students but its schools are in need of major improvements and upgraded facilities.

The flyer states, "Measure BB will help provide a safer, cleaner, and highly-

functional 21st century learning environment so students will continue to have a competitive edge and all the resources they need to succeed."

ABC will have their website finished by Sunday, Fierro told HMG-LCCN, the address will be www.measurebb.org.

The 2018 bond, like the 2014 bond, will charge one-half of one percent on the assessed value of ABC homes.

If a house stands at \$200,000 assessed value, the increase will be \$100 per year or \$8 per month.

At \$330,000 assessed value, the increase will be \$165 per year or \$13.75 per month.

At \$600,000 assessed value, the increase is \$300 per year or \$25 per month.

There have been rumblings from the small Measure BB opposition, mostly centered in Cerritos, that the monies from the Measure will be spent on salaries and other expenses.

By law, Measure BB funds can only be spent to fund projects itemized in the ballot measure.

Bond funds cannot be used for administrators' salaries or pensions.

An Independent Citizens' Oversight Committee, mandatory audits, and public reports will ensure funds are spent properly. The Oversight Committee will review all expenditures and construction projects to ensure accountability.

Residents can find a detailed list of improvements for each school based upon the comprehensive Facility Master Plan conducted by the Facilities Committee over an 18-month period on the District's website <https://www.abcusd.us>.

ROTARIAN MILWARD INJURED WHILE PRACTICING FOR RACE, URGES DONATIONS TO FIGHT TO END POLIO

A serious biking accident will prevent La Mirada Rotarian Paul Milward from being among thousands of cyclists riding this November to raise funds to end polio -- a vaccine preventable disease that still

threatens to paralyze children in several parts of the world today.

Milward broke numerous ribs, his clavicle and shoulder while training for the 106-mile Tour de Tuscon ride against polio. Although injured, Milward is adamant he will continue local efforts to raise funds for the fight against polio. He is asking friends, businesses and concerned individuals to donate to support those who will still be riding to end polio.

Last year alone, Milward raised more than \$2,000 for the fight against polio. He then travelled to Tucson, Arizona at his own expense, and rode in the annual ride against polio. Milward has made the 106-mile ride as a tribute in memory of his father, Charles Milward, a Santa Fe Springs businessman who suffered from the effects of childhood polio.

“No child should have to suffer from this terrible disease,” says Milward. “While polio is now largely unseen in the United States, it is really just a plane ride away from our shores.”

Eradication of polio has been Rotary’s top priority since 1985, and its progress towards this goal has been impressive. Since Rotary and its partners launched the Global Polio Eradication Initiative some 30 years ago, the number of polio cases has plummeted by more than 99.9 percent,

from about 350,000 a year to 37 confirmed cases in 2016.

More than 16 million children around the world are estimated to be walking because of the success of the polio vaccine.

Rotary became involved with the El Tour de Tucson in 2009. By 2016 Rotary

cyclists riding in the race and in gyms and health clubs around the world raised \$13.5 million bringing the total at that time to more than \$35 million. Since it costs 60 cents to immunize a child, Rotary officials indicate that participating cyclists have raised enough money to purchase more than 58 million doses of polio vaccine.

Other organizations partnering in the fight to end polio are: The Bill and Melinda Gates Foundation, the Atlanta-based U.S. Centers for Disease Control and Prevention (CDC); the World Health Organization (WHO) and the United Nation’s Children’s Fund (UNICEF). To sustain this progress, and protect all children from polio, experts have said \$1.5 billion is needed. Without full funding and political commitment, this paralyzing disease could return to previously polio-free countries, putting children everywhere at risk.

Rotary has contributed more than \$1.6 billion to ending polio since 1985, including matching funds from the Gates Foundation. The Rotary Club of La Mirada and members of the local community have supported the campaign against polio.
