## 9TH CIRCUIT SAYS CITIES CAN'T PROSECUTE PEOPLE FOR SLEEPING ON STREETS

The U.S. 9th Circuit Court of Appeals has overturned a district court decision in favor of the City of Boise, Idaho ruling that cities could not arrest and prosecute homeless individuals for sleeping on the streets when they lack access to shelters or alternative housing.

The ruling could have major implications for local governments across the United States and in California in particular.

The case dates back to 2009, going before the appeals court last year. The plaintiffs, formerly homeless Boise, Idaho residents, alleged that laws prohibiting them from sleeping outdoors within city limits amounted to cruel and unusual punishment and violated their rights under the Eighth Amendment.

The appeals court opinion from Judge Marsha S. Berzon reads, in part:

Turning to the merits, the panel held that the Cruel and Un-

usual Punishments Clause of the Eighth Amendment precluded the enforcement of a statute prohibiting sleeping outside against homeless individuals with no access to alternative shelter.

The panel held that, as long as there is no option of sleeping indoors, the government cannot criminalize indigent, homeless people for sleeping outdoors, on public property, on the false premise they had a choice in the

## ARTESIA HOSTS STATE OF THE CITY

The annual Artesia State of the City luncheon was held this past Friday September 6, 2018 in the sparkling new events room of the Artesia Library.

Mayor Sally Flowers addressed businesses and local leaders on the City's efforts to offer increased public safety, special events, recreation programs, and the "sharper focus on requests from property owners."

"The city has worked diligently to increase non-tax City revenue over the years – including \$3.3 million that was used to increase financial stability and expenditures on public services, with no financial impact to our residents," said Flowers, "to further increase our services, the City has successfully sought and received grant funding for city projects to the tune of \$3.5 mil-

lion."

The City has approved investments in rehabilitating and replacing its' infrastructure including 56 new street lights, 14 new stop signs, repaired and installed new storm water facilities and widened sidewalks, improving 83 percent of the arterial streets of the City in the last four years.

The quality of life for Artesia residents has greatly improved. Overall crime rates are down 27 percent in the last year alone. The focus on bringing smart development to Artesia has resulted in nearly \$700,000 in new revenue from projects such as Artesia Live I, Artesia Christian Home Memory Care Facility, Jollibee, the Serenity Project, Popeye's Chicken, and 7 Leaves Café.

Further emphasizing the City's stability, Council and Staff

## HIGH SPEED RAIL MEETINGS ON LOS ANGELES TO ANAHEIM ROUTE STARTING SATURDAY

Beginning this Saturday, there will be five community open houses concerning the proposed high-speed rail line from Anaheim to Los Angeles.

The meetings will take place in Montebello, Santa Fe Springs, Los Angeles, Anaheim, and Buena Park.

The line is part of the 800-mile high speed route that is proposed to connect to San Francisco and would run from Union Station to the Anaheim Regional Transportation Intermodal Center.

At first, officials were angry that the California High-Speed Rail Authority wasn't listening to them, but last year, following meetings, the officials backed down. The plan includes grade separa-

tion, a station for Norwalk and Santa Fe Springs, and fencing that would keep the train walled off from communities.

Officials are expected to provide information to new and existing grade separations, train station relocations, and other features.

The first meeting is in Montebello this Saturday 10 a.m. to noon at the Senior Center, 115 South Taylor Ave., Montebello.

The next meeting is 5:30 to 7:30 p.m. this coming Wednesday at Gus Velasco Neighborhood Center, 9255 South Pioneer Blvd., in Santa Fe Springs.

A third meeting will occur in Los Angeles from 5:30 to 7:30 p.m. on September 17 at Nishi Hongwanji Buddhist Temple, 815 E. 1st St., Los Angeles.

A fourth meeting will occur on September 20 from 5:30 to 7:30 p.m. at the Brookhurst Community Center, 2271 West Crescent Ave., Anaheim.

Finally, the last meeting will be on September 24 from 5:30 to 7:30 p.m. at Buena Park Community Center, 6688 Beach Blvd., in Buena Park.

## CERRITOS LIBRARY LAUNCHES NEW RFID SYSTEM

The Cerritos Library now offers an upgraded radio frequency identification (RFID) system, including new self-checkout stations, security gates, RFID tags, circulation desk equipment and system software.

The new system allows self-checkout of materials and provides security for the collection.

The new self-checkout stations allow patrons to check out multimedia items, such as CDs, DVDs and Blu-Ray discs, as well as books.

The self-checkout stations are integrated with the cloudLibrary digital book service, allowing eBooks and eAudio-books to be immediately added to a patron's digital shelf.

The self-checkout stations also allow for the payment of fines and fees by credit card.

The self-checkout stations offer patrons the option of selecting from different languages for the on-screen display, including Chinese, English, Hindi, Hmong, Korean, Spanish, Tagalog and Vietnamese.

Cerritos Mayor Mark E. Pulido said, "The City of Cerritos is pleased to offer Cerritos Library patrons a state-of-the art system for the self-checkout of materials.

The Friends of the Cerritos Library is to be commended for the organization's support for the project though a financial contribution and many hours of volunteer service to help re-tag the collection."

The new RFID system replaced the original system that had been operating since 2002.

The original system worked with proprietary RFID tags that are no longer manufactured.

The City Council awarded a bid in the amount of \$115,885.62 to Biblioteca, LLC for the new system.

As part of its mission to support the

Cerritos Library, the Friends of the Cerritos Library generously contributed \$15,000 toward the system replacement cost.

Friends members also volunteered their time to help Cerritos Library staff and Volunteers place new RFID tags on approximately 268,772 items in the collection.

## DOWNNEY AMBULANCE OPERATOR GIVEN 'DNA' AWARD AFTER SAVING INFANT

On August 20, 2018 Glendale Fire was called out for the delivery and resuscitation of a new born infant. During this delivery the umbilical cord had to be unwrapped from the infant's neck.

After the delivery Mike Sevillano had to cut and clamp the cord and begin to perform resuscitative measures in order to save the baby's life. While on the way to the hospital the baby boy began to breathe on his own.

Sevillano had just taught a class on child birth and neo natal resuscitation to fire fighters and they were able to put those techniques into practice "Every day these firefighters teach and prepare us for situations such as this," stated Sevillano.

At the Tuesday night City Council meeting, Downey Mayor Sean Ashton presented Downey Fire Ambulance Operator Sevillano with the Downey DNA Award. Sevillano is a Paramedic Intern working with Glendale Fire Engine 25.

A graduate of the Santa Ana College Fire Academy Class 167 he also completed the Emergency Medical Certification Program. Sevillano has served as an Ambulance Operator for the Downey Fire Department; a reserve fire fighter for the city of Morongo Valley Fire Department; and was later sponsored by the Downey Fire Department to attend the UCLA Daniel Friedman Paramedic Program and completed his internship with the Glendale Fire Department and will graduate this month.



## CERRITOS MAN CONVICTED OF MANSLAUGHTER


Steven Gerard Cruz of Cerritos was convicted Tuesday of vehicular manslaughter in a drunk driving crash that killed 82-year-old La Mirada resident William Bradford Parker on Mother's Day 2015 in Buena Park.

Parker was driving his 2000 Toyota Avalon with his wife and their daughter as passengers on May 10, 2015, as they celebrated Mother's Day together at an El Torito restaurant, when Cruz slammed his 2006 Nissan Titan pick-up truck into Parker's car.

Parker's wife and daughter sustained broken ribs among other injuries in the crash, Feldman said.

Cruz faces up to 12 years and eight months in prison.

## What is Measure BB?

Measure BB is a \$258 million general obligation bond measure that will provide our students and community with improved and upgraded school facilities that are safe, secure, and modern.

## How will Measure BB support the Facilities Master Plan (FMP)?

Measure BB will provide funding to support the five key goals identified in the FMP - the acronym is STEPS.

- **S** (Safety/Security): Improve student safety and campus security systems including establishing a single point of entry, visitor management, security fencing, security cameras, emergency communications systems, smoke detectors, fire alarms, and sprinklers.

- **T** (Technology): Keep instructional technology up-to-date and provide instructional network, infrastructure, and furnishings.

- **E** (Evolution): 21st Century Learning environments, computer labs, and media centers
- Provide the classrooms, labs, and facilities needed to support high quality instruction in Science, Technology, Engineering, and Math, as well as Career and Technical Education classes so students are prepared for college and in-demand jobs in fields like health sciences, engineering, technology, and skilled trades.

- **P** (Parity): portable replacement, new facilities - Upgrade older schools so they meet the same academic and safety standards as newer schools. Make necessary repairs and upgrades to our 34 sites, including Child Development and Adult Education.

- **S** (Sustainability): solar arrays, energy management, irrigation, finish materials, and fixtures

## Will Measure BB improve instruction?

Yes. ABCUSD is an award-winning District with a reputation of Academic Excellence. Families move to ABC because of the outstanding reputation of our District. Our goal is to provide all students with access to the education they will need to be successful in college, jobs, and careers after they graduate from high school. Safe, modern school facilities, and education technology are essential to maintaining quality schools and giving our students a competitive edge. As school facilities are improved, teachers and students will benefit.

## Where can I find a detailed list of school improvements planned for my neighborhood school?

## How much will Measure BB cost?

The projected tax rate is \$49.50 per \$100,000 of assessed property value (not market value) annually. The median assessed home value in ABCUSD is \$305,000. Therefore, the project tax rate for the median home is approximately \$151.00 per year.

## How can I be assured that the Measure BB proceeds will be spent on the designated projects?


By law, Measure BB funds can only be spent to fund projects itemized in the ballot measure. Bond funds CANNOT be used for administrators' salaries or pensions. An Independent Citizens' Oversight Committee, mandatory audits, and public reports will ensure funds are spent properly. The Oversight Committee will review all expenditures and construction projects to ensure accountability.

## Who can vote on Measure BB?

All registered voters living within the ABC Unified School District boundaries will be able to vote on Measure BB as long as they are registered by October 20, 2018.



The ribbon cutting was to celebrate the official completion of two major construction projects: an all new Outpatient Building and the expansion to the Jacqueline Perry Institute (JPI) inpatient facility.

Ole Nervik is now in his 12th season as the head coach for Whitney High's girls volleyball team and already is having his best season by far. In fact, he has never guided the Lady Wildcats to a winning season, and only came within a game of a .500 record just once.

But after his team eased past visiting Artesia High 25-12, 25-13, 25-13 this past Tuesday afternoon, the surging Lady Wildcats improved to 9-4 overall and 2-0 in the 605 League. It's the first time Nervik has won the first two league matches as the now-defunct Academy League had always been rough for the Lady Wildcats. The nine wins are the most for the program since 2012 when Whitney finished 9-10 and the last time the school has experienced a winning girls volleyball season came in 2001 (15-8).

"I'm not really surprised because we have a lot of raw talent," Nervik said of the rare winning mark. "We're a little inexperienced, but we've been working pretty hard. Our defense is pretty strong, but our offense is still lacking a little bit. We have a couple of good hitters outside. But once we get the two of them together, I don't know what the limit is."

One of those hitters that Nervik is talking about is junior outside hitter Skye Garcia, who constantly tormented the Artesia defense. Garcia had a match-high 15

kills with nearly half of those coming in the first set. The Lady Wildcats bolted out to an 11-3 lead in the opening set, then senior outside hitter Taylor Genera reeled off the final eight points as she, Garcia and junior middle blocker Ola Ogan combined for all those points. In the second set, those three again were the main forces, combining for a dozen kills.

"Let's take Oxford [Academy] as an example, another really strong defensive team," Nervik said about Garcia. "She's what tips the scales because she's going to be able to put the balls away for us. With her and Taylor hitting outside, we've got a pretty good offensive fuel there."

In the second set, the Lady Wildcats raced to a 6-1 lead but Artesia (0-10, 0-2) stormed back and trailed 10-9 following a solo block from sophomore middle blocker Oriana Monis. She was a key part of Artesia's comeback as she recorded back to back kills moments earlier. But with the score 17-12, Whitney scored five straight points. Then in the third set, sophomore libero Reese Guitche served nine straight points as the Lady Wildcats opened an 11-1 lead and never looked back. Ogan added 10 kills while Genera pitched in with seven kills while the Lady Pioneers were held to 17 kills with Monis leading the way with four.

Artesia, which has been swept in all 10 of its matches, will compete in the Valley Christian Tournament today and tomorrow, then host Oxford Academy on Tuesday. Whitney visits Oxford Academy today before hosting Cerritos High on Tuesday in a battle for first place.

In other girls volleyball action, Cerritos has won four straight matches, all by sweeps entering its Sept. 13 road match at Pioneer High. The Lady Dons (8-2, 2-0) will also compete in the Valley Christian Tournament today and Saturday.

In the first two games of the young season, not much was coming out of John Glenn High junior running back Edwin Udengwu and the Eagles stumbled to a 0-2 start. But the past two games were more to his liking as well as that of head coach Vince Lobendahn.

Udengwu rushed for 217 yards on 34 carries and scored twice while senior quarterback David Sanchez completed 12 of 21 passes for 152 yards and a pair of scores as Glenn dismantled University High 46-19 last Thursday night at Excelsior Stadium. The Eagles, who have won two in a row by nearly identical scores, racked up 449 yards of total offense.

"We've ironed out some of our offensive stuff," Lobendahn said. "If you looked at our first game, there were some stalemate, bad red zones. So, we really focused on our short game, getting play action set up better, setting our run game up to help out our passing."

After falling behind 6-0 on University's opening drive of the game, Udengwu put the hosts in front for good with a 16-yard run with 3:15 left in the first quarter. Glenn then controlled the clock on its next possession, running 15 plays in over four and a half minutes, culminated by a one-yard run from senior Brian Christian.

Later in the stanza, the Trojans parlayed a Glenn turnover into a 75-yard pass from Thomas Keeling to Austin Lake and just like that, University was down 15-13. But on the ensuing kickoff, senior Jourdhin Smith returned the pigskin 70 yards and on the next play, Udengwu cashed in from 15 yards out and the Eagles went up 22-13. By halftime, he had already rushed for 112 yards on 17 touches.

"I feel comfortable; his weight room

ethic has been what put us at the running back versus the secondary," Lobendahn said. "And we felt behind that we would have opportunity. That's where we put ourselves."

Both teams were silent until late in the third quarter when Sanchez tossed a 25-yard touchdown pass to junior tight end Francisco Ruiz. After the Trojans answered with a 56-yard scoring strike from Keeling to Daniel Fernandez, Glenn's special teams enabled the hosts to go up 39-19 as Smith returned the ensuing kickoff 96 yards. Those three touchdowns came in a span of 66 seconds.

The final score of the game came with 1:38 remaining in the contest when Sanchez found senior wide receiver Tim Stevenson for 38 yards. He would catch five passes for 81 yards as Sanchez found five different targets.

"The difference for us is that he was looking to have his receivers more active," Lobendahn said of Sanchez from the first two games to the last two games. "But they were working to be a part of the run game. That's kind of where it was offset with that."

Sanchez also picked up 49 yards on nine carries while on defense, senior free safety Ivan Ramirez and senior linebacker Jorge Ruiz each had 10 tackles while junior linebacker Christopher Roca added seven tackles.

The Eagles will host Western High tonight at Excelsior Stadium. The Pioneers enter the contest at 3-1 and are coming off a 48-0 win last week against Anaheim High. They have outscored their opponents 211-95, but 173-47 in their victories. In addition, Western is ranked second in the CIF-Southern Section Division 11 poll. The Pioneers are led by quarterback Anthony Munoz, who has completed





have presented a balanced budget for the past five years, reduced its operational costs each year, while increasing City reserves from zero to 120 percent.

Reducing the carbon footprint has been another top priority for the Council. The city has been able to reduce its emissions by planting 115 new trees throughout the City. Energy consumption and electrical costs have been reduced by 60 percent, interior lighting in all City facilities has been converted to LED bulbs, the 30-year-old vehicles in the Maintenance Department were replaced with new trucks, and the City has earned an achievement award from the Beacon Program for its reduced

electrical consumption.

The City's increased financial stability has allowed for the award of several mini grants to nonprofits through the Community Benefit Grant Program including a resolution enabling residents to take advantage of the Property Assessed Clean Energy Program (PACE) to make improvements to their property, offering a \$500,000 grant program for income qualified residents.

Artesia funds 58 special events for its residents, "it has been said, that the most diverse state in the nation is California and the most varied county is LA County, however, out of all the cities in the county, Artesia is the most diverse with 51 ethnic heritages being represented," said Flowers. "We are a City on the move," commented Flowers.

the Pioneers as they came away with a 51-24 win over the Lions last Friday night. Artesia improved to 2-1 and has reached 50 points in both of its victories.

"They're really well-coached and they do a lot," Olmstead said of Westminster. "I knew going in that with their different formations, it would give our kids a little trouble just adjusting to it. Then once they adjusted, we were fine. But I knew going in, it would take a little bit of time to get adjusted, and then finally they did and then we played well."

The night belonged to Davis and Gladden, who combined for nearly 97 percent of Artesia's offense. Gladden rushed for a game-high 282 yards on 19 carries and scored five touchdowns. He also completed four passes for 86 yards and the one touchdown. Davis added 173 yards on 14 carries while senior wide receivers De'jon Major caught three passes for 39 yards.

Artesia struck first when senior Romel Burgos booted a 37-yard field goal four and a half minutes into the contest. But the Lions quickly had an answer and took an 8-3 lead on a three-yard run from Malachi Mesa with 2:03 left in the first quarter. He would end the game with over 300 yards passing. On the first play of the second quarter, Gladden scored from two yards out before the visitors regained the lead on a 29-yard field goal from Sergio Vega.

After that, it was all Artesia as Gladden scored again, a 26-yard run, with 3:32 left in the half. He would have five rushes of more than 20 yards in the first half and ended the game with three straight gains of at least 25 yards. Davis would be held in check in the first half with his biggest gains being 34 and 35 yards. But he would have a stronger second half.

"They're good," Olmstead said. "We know they were good and we knew what we were getting into. Heder is a good football player; there's no doubt in that. Travis is a good football player too. They're

a couple of kids who have experience and they've started since they were sophomores. We really have to lean on those guys and we need the other seniors to play just as well as them."

The Pioneers began the second half on a long 10-play drive that lasted 4:17 and ended with a Gladden one-yard sneak to increase the lead to 31-11. That would be the lone score of the third quarter as Artesia's defense buckled down and limited the Lions to 60 yards on 11 plays in the stanza.

Both teams would combine for three touchdowns within the first 3:23 of the fourth quarter. First, Gladden scrambled for a 39-yard jaunt, then Mesa connected for a 35-yard score to Jose Diaz. Three plays later, Gladden added a 25-yard score. The last Artesia touchdown came with 3:32 left in the game when junior LaQuan Ware-Morales picked off Mesa and returned the ball 40 yards the other way. On the first play following the pick six, Ware-Morales would intercept another Mesa attempt.

"Our defense, early...they didn't play very well," Olmstead said. "They kind of get stuck in a wander mode, where they're not really focused on what they're doing. Then once we kind of get over that hump, then they play well."

The Pioneers, in the middle of three straight home games, will host Vasquez High tonight, which is 1-3 and has scored 64 points. Artesia is hoping to improve to 3-1 and stay right there with the other three teams in the 605 League. Pioneer High leads the way with a 3-1 mark while Cerritos High and John Glenn High are both 2-2. While the first league contest isn't until Oct. 12, the new league is what everyone had hoped, which is to make it equally competitive for the quartet who are enduring long playoff droughts.

"That's why we got into it," Olmstead said. "Those four teams, any game can go back and forth at any moment. That's what everybody in that group wanted, was just something that's just a little more competitive, year in and year out in every sport."
