ABCUSD TEACHER ACCUSED OF MOLESTING STUDENT, MOTHER ALLEGES COVER-UP

Last week the ABC Board got an email as a follow up to an issue classified by the ABCUSD Superintendent Dr. Mary Sieu "as a personal matter" and that the issue was being followed up by ABC personnel including the Superintendent and ABC Board President Soo Yoo.

A few days later, during last night's Board meeting, the remaining Board members found out exactly what the personnel issue was, and at least two members were extremely upset.

A sobbing mother approached the dais for public comment and accused the District of withholding information on alleged sexual assault of her daughter

and implicated the District in a cover-up. She said her 13-year-old daughter was forced to have "inappropriate interactions" with a non-permanent substitute teacher, told a high school principal, and that the District did nothing about it.



Sources have told HMG-LCCN that the sister of the molester works for the District also and that the mother has been telling the District for weeks.

The sources said that a memo was written after the incident by Artesia High School Assistant Principal Rosie Gomez who forwarded to AHS Principal Sergio Gomez who forwarded the memo to Assistant Superintendent of Human Resources, Gina Zietlow.

Thousands of families, local and international authors, a speakers attended the OC Children's Book Festival this past weekend at Orange Coast College. The annual book festival encourages children of all ages to explore the wonder of science, the love of engaging education and the joy of reading.

One of the guest speakers was former NASA Astronaut Nicole Stott, who, aboard the 2009 International Space Station, was the first person to paint in space. The artistically-inclined Stott was inspired to take the watercolor set to space after the support staff at NASA asked her what she would do with her free time. "I thought it would be kind of cool to paint in space," she recalled. "At that time, I did not know that no one else had painted in space."

Shawn Wayans was also a speaker at the Festival; many do not know the talented family with nine siblings also produces children's books and a cartoon series.

The Boo Crew is a series of children's books and television specials that focuses on the adventures of a gang of neighborhood kids of different ethnic cultures known as "The Boo Crew."

"We grew up in New York city," said Wayans, "our neighborhood had black kids, and brown kids and yellow kids and

LA MIRADA OFFERS FREE FLU VACCINES

The City of La Mirada and the Los Angeles Department of Public Health are partnering to offer free community-wide flu vaccinations on Wednesday, October 31 from 9 to 11 a.m. at the La Mirada Activity Center.

Influenza (flu) is a contagious respiratory illness caused by influenza viruses, which can cause mild to severe illness.

Flu viruses are most common in the fall and winter months. To prepare for the upcoming peak in the flu season, the Department of Health recommends the flu vaccine as the most effective way to protect against the flu.

Flu vaccines will be available at the flu clinic on a first-come,

first-served basis to people of all ages. Pre-registration is encouraged to participate, however walk-ins are welcome. Flu vaccines are limited.

Community members interested in obtaining a free flu vaccine are encouraged to pre-register by calling the Activity Center at (562) 902-3169. No insurance is required for service.

Transportation to the flu clinic is available through La Mirada Transit. To schedule a ride, call (562) 943-6776.

It is easy for me to share with you why Cerritos is one of the best places to live. I have been a Cerritos resident since 1976, and have benefitted greatly from all of the wonderful things that Cerritos has to offer.

Cerritos is home to two of the best school districts in the country: the ABC Unified and Bellflower Unified School Districts. This year the ABC Unified School District was honored as a 2018 Exemplary School District by the California Department of Education. Cerritos, Elliott, Gonsalves and Leal elementary schools were honored as 2018 California Distinguished Schools.

The City also offers residents and non-residents the best recreation opportunities possible. Approximately 1.6 million people are served by the City's parks and programs every year. Cerritos has 25 parks and recreation facilities, including neighborhood parks, community centers, the Cerritos Swim & Fitness Center, the Cerritos Iron Wood-9 Golf Course and the Cerritos Sports Complex. I have enjoyed being a volunteer coach for our youth sports programs.

The City is currently on a mission through 2021 to revitalize and upgrade all of the parks throughout the City. The updates include installa-

tion of new playground equipment and surfacing. The most recent parks to be upgraded are Bettencourt, Jacob, Liberty, Brookhaven, Friendship and Loma parks. All of these parks now feature colorful slides and swing sets and fresh rubberized surfacing.

Earlier this year, the City announced a new, upgraded online registration system for recreation, library and senior

center activities and services. The new system, RACER Powered by CivicRec, provides excellent processing speed and capacity, so patrons will not experience a delay in the online registration process.

The City easily has one of the most impressive libraries in the country with the Cerritos Library, which was dedicated in March 2002. It features an outstanding selection of books and electronic resources as well as educational programs for patrons of all ages, and serves more than 1 million patrons each year.

Over the past few years the Cerritos Library has introduced new digital services such as the Cerritos Library To Go app, Hoopla media streaming and the cloudLibrary™ digital book service. The library also now has a new radio frequency identification system, which includes new self-checkout stations, security gates, RFID tags, circulation desk equipment and system software.

Cerritos is also fortunate to have its very own Sheriff's Station, which opened in 1997 to provide a full range of safety services for the community, 24 hours a day, seven days a week.

This past year, my Council colleagues and I approved the use of seven ALPR vehicles to aid our Cerritos deputies in their daily crime suppression efforts. ALPR stands for Automatic License Plate Reader technology, which enables these vehicles to automatically photograph and check the license plate number of every vehicle that passes within proximity of the cameras. The system immediately notifies a deputy if that plate belongs to a stolen vehicle or person of interest.

A new crime abatement strategy, "Operation Night Light," was launched last year to dissuade would-be criminals from targeting Cerritos neighborhoods at night. Residents are encouraged to turn on their porch lights from dusk until dawn to send the message that they are part of an active Neighborhood Watch program.

The Community Safety Division and Cerritos Sheriff's Station are presenting a Public Safety Town Hall meeting on Wednesday, October 17 at 7 p.m. in the City Hall Council Chambers and I encourage you all to attend.

Here in Cerritos, we have our very own world-class theater, the Cerritos Center for the Performing Arts. Since 1993, the CCPA has brought cultural enrichment and entertainment to the community. In addition, the theater has brought valuable revenue to the sur-

rounding local businesses.

This season we opened with Country music superstar Martina McBride. Other amazing performers to be presented include Kenny G, Shirley MacLaine, Penn & Teller, Jerry Lee Lewis, LeAnn Rimes, Smokey Robinson and Don McLean.

We are proud to offer an Arts Education Program that is sponsored by Los Angeles County Supervisor Janice Hahn and serves 10,000 kindergarten through 12th grade students from ABC Unified, Bellflower Unified and surrounding school districts. This season the CCPA will present eight daytime educational performances that will expose young people to high-quality arts experiences. I want to personally say "Thank You" to our Supervisor Janice Hahn for her continued support of Cerritos and the CCPA.

Cerritos has a beautiful Senior Center, which has provided a welcome space for seniors in our community to socialize and participate in educational and recreational activities since 1994. This past year, the façade at the Senior Center was enhanced with the completion of maintenance to the wood features.

The community is also served by the convenient fixed-route Cerritos on Wheels bus service. Seniors, age 55 and older, and residents with disabilities can also receive transportation assistance through the City's Dial-A-Ride service.

The City's commitment to protecting the environment and promoting sustainability also makes it a special place. From opening the nation's first solar-powered City Hall to constructing a 22-mile recycled water distribution system, the City has been in the vanguard of environmental preservation.

The City continued this green tradition with the construction of two photovoltaic systems with high capacity solar panels at the Cerritos Corporate Yard.

In 2016, the City extended its recycled water service to Forest Lawn in Cypress with funding from the company and a state grant. This innovative project generates approximately \$50,000 per year in revenue for the City and saves thousands of gallons of drinking water.

Many exciting business developments have taken place in Cerritos during the past year, adding to Cerritos' appeal. The City welcomed Sprouts Farmers Market to the Lincoln Station Shopping Center, P.F. Chang's to the Los Cerritos Center and the City's first and only drive-through Starbucks in the College Square Shopping Center. HomeGoods, a popular kitchen, bath and home furnishings retailer, recently opened at the Cerritos Towne Center. Also now open in the Plaza 183 Shopping Center is Eureka! restaurant, an All-American scratch kitchen and craft beer bar specializing in gourmet burgers.

The quality of life in Cerritos is also greatly enhanced by the hundreds of volunteers who help make the City's recreation, library, safety and theater services possible. Dedicated community organizations also make a significant contribution to the vibrancy of Cerritos.

Since its beginnings as Dairy Valley, the City has continued to grow and develop in ways that benefit all who live in and visit Cerritos. All of these things, and more, make Cerritos one of the best places to live.

Years ago Steve Cisneros, a 17 year old formed an organization that has inspired nearly 500,000 teens in Southern California, by using theatre as a teaching tool. Phantom Project Theater Group brings literary classics to the state at the La Mirada Theater for the Performing Arts, along with original plays that undertake hard hitting topics that relevant to today's youth and in today's society.

'Pay What You Can Day' is a special that will be held October 13, 2018, "We make all shows in our season available at any price to anyone," says Producing Artistic Director Steve Cisneros, "The price of a ticket shouldn't prevent someone from seeing a live performance." Phantom Projects is allowing anyone to pay what they can for one day only, for any show in the season. "The idea that anyone might not be able to be in the audience because of financial limitations pains me greatly. We are a non-profit, yes, and ticket sales are crucial, but at the end of the day, the educational element of what we do is far more important. We want to remove any excuse as to why someone can't be a theatregoer," commented Cisneros.

The month of November brings to stage Afflicted: Daughters of Salem. In this one day only performance comes the untold story of The Crucible and the untold tale of the girls of Salem, who meet deep in the dark woods of Puritan New England at night. Denied all outlets for imagination and all hope for the future, the girls unite in a secret society. Allies are found, promises made and broken, power taken. As these young people try to find themselves and each other, the sadness of sophistication begins to reach them, and change them.

The new year [2019] will see Phantom Projects explode onto the national scene when Jargie heads to Washington State and DC in March as well as Charlotte's Web School tour and the presentation of Wonder at La Mirada Theatre. Season tickets are now on sale for the 2018/2019 season.

Wayans, Knotts and Stott all agreed that being kind to each other was the most important thing that anyone could be. Kindness is defined as the quality of being friendly, generous, and considerate. Affection, gentleness, warmth, concern, and care are words that are associated with kindness. "You know sometimes people think that if you are kind that means that you don't know a lot or that you are weak," says Wayans, "Being kind means saying something nice, giving a stranger a smile, opening a door or helping out. Being kind takes courage and strength."

Next year's Festival will once again be held at Orange Coast College September 28, 2019.

MEASURE BB: AN INVESTMENT IN THE COMMUNITY

As many of you may remember, in 1997 the ABC Unified School District requested an investment from the community for the purpose of improving our school facilities and enhancing the educational opportunities for our children. That investment took the form of a \$59 million General Obligation Bond. That bond was structured consistent with how other school district bonds were structured at the time and was similar to all of the other bond measures put forth around the State of California. The community needed to pay interest on the bond, and the total cost of both of the principal and interest on

the bond will be \$167 million. It still has about \$28 million in principal remaining to be paid and about \$77 million in interest to be paid. This will be paid off in full by 2034. Again, this is similar in respects to paying off a mortgage. Since 1997, the voters of almost every other school district locally in Los Angeles County have agreed to make additional investments in the education of their children while the voters of ABC have not. The chart below shows those local Los Angeles County communities which have made educational investments since 1997 compared with those which

have not. Someone might say that now is not the time for an additional investment in our children's future. They might say that we should wait until 2034 until the old 1997 bond is paid off before we contribute anything further. The chart above shows many communities feel differently! If we as a community do nothing until 2034, how many generations of ABC youngsters will be deprived of a quality facility due to unsafe conditions or a lack of modern science buildings? What will our property values be like in 2034 if all of our neighboring communities make

repeated investments in education? Will ABCUSD just sit and wait for 2034 to arrive? What homeowner would refuse to invest in the upkeep of their home because they have not yet paid off their original 30-year mortgage? What homeowner would not install wifi, upgrade plumbing or remodel the kitchen for 30 years just because they still have a balance on their original mortgage? That is why the ABC Unified School District Board of Education placed Measure BB on the ballot this November. If not now, then when?

NEW ATTITUDE HELPING GAHR GIRLS V-BALL INCH CLOSER TO SAN GABRIEL VALLEY LEAGUE TITLE

The Gahr High girls volleyball program hasn't seen a season like the one it's having right now since 1998. In that season, with former longtime head coach Sonny Okamoto at the helm, the Lady Gladiators went 17-5, won all 10 San Gabriel Valley League matches and went to the semifinals of the CIF-Southern Section playoffs.

Since then, Gahr has advanced to the semifinals once, and has gone 9-1 in league action once, which came two seasons ago. But after the Lady Gladiators swept struggling Warren High 25-14, 25-19, 25-16 this past Tuesday, it looks as if the team can be better than that 1998 squad. Gahr, winners of seven straight matches, took an overall record of 17-6 into its road match with Paramount High on Oct. 4. A win there would clinch at least a share of the program's third league title in 21 seasons. Last season, Gahr went 8-13 overall, but 7-3 in league play.

"I think in the offseason, our team got really serious and we met every day for conditioning," said Gahr head coach Iris Najera. "We did a lot of team bonding and we set goals early in the preseason. The attitude from the girls is one of the best I've ever seen. They really care for each

other, they enjoy each other's company and I think because they have a mutual respect for one another, they're playing really well."

Gahr jumped out of the gates in the first set with junior setter Louisa Black serving the first four points. Minutes later, junior setter Afioga Tone reeled off six consecutive points, including four aces. Later in the set, senior libero Yaneli Guzman served three aces to bring Gahr's total to 10 in the set. The Lady Gladiators would add five more aces in each of the next two sets, just one area of Gahr's success against the Bears.

"I can give credit to my assistant coach, Gerryn Claxton, who has been helping the girls to practice their serving," Najera said. "The girls have really stepped up in that component of their game."

Another area that propelled Gahr's win came from the play of junior middle blocker Mariah Uini, who was virtually silent in the first set, but turned in on in the second and third. Uini pounded down a match-high 14 kills with half of those coming in the third set. In addition, she served three straight aces in the third set to put Gahr in front for good at 9-7. With Gahr trailing 7-5, she had a kill before serving the aces. Junior outside hitter Hunter Thomas (nine kills) and senior middle blocker Nneoma Izima (seven kills) ended the rally with kills as Gahr never looked back.

"She is one of our all-around players, and I like that she brings the team together and she inspires others to play better," Najera said of Uini.

Gahr will wrap up the regular season at home against Downey High on Tuesday. The Lady Gladiators knocked off the Vikings in four sets on Sept. 20.

In other girls volleyball action, three

One look at several John Glenn High players and a few coaches following their game with crosstown rival Norwalk High last Friday night told the whole story. There were tears, but these were happy tears, and no one would ask why they were crying.

It was very evident why they were so emotional as the Eagles smashed the Lancers 48-7 to win the Mayor's Cup, the trophy that goes to the victor of this rivalry. It was Glenn's first win over Norwalk since 2002. There hasn't been much to be happy about or cheer for as it relates to Glenn football the past 15 seasons. Against the purple and gold, the Eagles were blanked three straight times from 2004-2006 and six times overall. They lost games by scores of 41-0, 64-7, 63-0, 60-6, 59-0 and 56-0. Some were even wondering why it was still a rivalry when Norwalk was clearly the dominant team in the area.

"There's been a bad vibe at Glenn and it's just perpetual with the years," said Glenn head coach Vince Lobendahn. "So, that has been here for a while. It's been stuck in this rut and they've tried. It's just a lot of kids committed to what we were doing; the weight room, the off-season and then it led to just...my kids are muscle memory. They know their plays because we do it over and over and over."

During the same 15 seasons, Norwalk has had eight winning seasons, has finished no worse than third place in the Suburban League 10 times and has advanced to the CIF-Southern Section playoffs 11 straight times. But, the tide could be shifting in the city and all points sign for better days ahead for the school that lies on the far east side of town. Norwalk is 0-7 as it enters its bye week and could miss the playoffs when league play begins on Oct. 12. The Lancers face Mayfair High and Bellflower High on the road, both of whom have a combined record of 11-3. Meanwhile, Glenn is 4-3, winners of four of its last five and is an offensive juggernaut 194 in those four wins. One more win will match the total set last season as well as 2009. And since 1998, the Eagles had been the laughing stock of the Suburban League, going 22-102. The program endured four winless overall campaigns and two more seasons of one win.

Now, no one is laughing at Glenn. One victory over Norwalk has already erased all the bad memories from as

far back as 1964, the first year the two schools played each other. Norwalk won that game 13-7. In fact, before Norwalk's 15-game winning streak over the Eagles, it still -led the series 22-16.

But Glenn has had good memories back in the days. They went to the play-offs seven times prior to that 2002 team and won a pair of Inland League championships as well as a pair of Suburban League titles. Yes, this win over Norwalk was bigger than many will ever know.

"Because it means so much to us," said junior running back Edwin Udengwu. "To everyone on this team, this Mayor's Cup, this game against Norwalk means everything to the players and even to the coaches who don't even play on the field."

Udengwu scored a total of four touchdowns against the Lancers and leads the Eagles with over 1,000 yards on the ground and 16 rushing touchdowns.

"Well, this one is special for me," Lobendahn said. "I had a brother who coached here, Allen Salanoa, and he was only a year here and he went 0-10. He died a year ago and I went to his funeral in Hawai'i. I spoke at his funeral and I brought him to John Glenn from eastern Arizona, Thatcher. He was the offensive coordinator there. And when he went 0-10, I was the freshman coach and we went 9-1. He wanted me to come up with him and I said I can't right now. I wanted to work with my kids. So, this means a lot to my family as well as [former head coaches] Joey Parra, Ken Mason, Anthony Wilson, Willie Norman.

"I'm thankful that throughout all the years I've gotten to know...in the 20 years I've been here, what we've been through," he continued. "So, to carry all those guys out there with me every year, it's nice to be able to help and reward them."

Glenn is ranked ninth in the Division 12 poll and will face a trio of 605 League teams that also have long playoff droughts but have a combined mark of 12-6. Artesia High last made the playoffs in 2008. Cerritos High hasn't played an 11th game since 2001 while Pioneer High has had 11 losing seasons since 2004 and has won 40 games since that time before this season.

If Glenn is happy right now, just think what it will be like when the Eagles get back to the playoffs, and/or win a playoff game.

JOHN GLENN FINALLY TURNS THE TABLES ON CITY RIVAL, KEEPS STRUGGLING NORWALK WINLESS

Emotions were running high in the 2018 installment of the Mayor's Cup, which signifies the yearly tilt between the John Glenn High and Norwalk High football teams. The latter had come in winning 15 straight games, most of them uncontested. But this one would be completely different.

had Glenn scored at least 30 points against Norwalk prior to last Friday. Norwalk still leads the overall series 37-17 with the victor of the 1982 game unavailable.

senior quarterback David Sanchez, junior running back Edwin Udengwu and a stingy defense that allowed 114 yards and recovered two fumbles, the Eagles gave their coaches, student body and alumni something to remember for a lifetime. Glenn blasted the winless Lancers 48-7 last Friday night at Excelsior Stadium. It's the largest win by the Eagles in this long-standing rivalry and the most points Glenn has scored against Norwalk since Oct. 16, 2009 when it fell to the Lancers 42-35. Only five times

65 yards for a score with 4:36 left in the first quarter. Early in the second quarter, Udengwu made it 21-0 with a 34-yard run and by now, it was clear to most in attendance that Norwalk was in trouble.

"Coming into this game, we knew it was going to be a hard game," Udengwu said. "We knew it was going to be a very emotional game. But we just stuck through it. Throughout the week, we said no matter what happens, we have to stay focused. Last year we came within six points. This time, we wanted to get the win for sure. I mean, 48-7, I'm pretty sure we did our job."

Five plays after the touchdown, Glenn senior lineman Chris Gonzalez recovered a fumble and almost two and a half minutes later, Udengwu scored from two yards out. But the Eagles were not done as Sanchez found senior wide receiver Tim Stevenson wide open for a 51-yard score and the rout was on at 34-0.

But when you've been bullied around for the past 15 years, it's had to keep your emotions in check when you have such a big lead at the break. That's what Lobendahn was facing in the locker room.

"It was difficult because we took on some comments on the way in and my kids were getting sidetracked," Lobendahn said. "I said, 'hey guys, all this stuff means nothing. We're at halftime, in the middle of a game and any guy can come out and change this game'. I had to refocus them on our points."

After Norwalk went three and out to begin the second half, Udengwu capped off his night with a 58-yard touchdown run following a four-yard gain. The touchdown would be the last time he touched the ball as he ended the game with 159 yards on 15 carries and three touchdowns, plus the touchdown pass he caught earlier in the game.

"I have to give it to the lineman on the three rushing touchdowns," Udengwu said. "They opened holes for me which is incredible. And, throughout the game, the coach made excellent play calls; he gave me the ball and from there, I just had to trust my eyes and trust my teammates around me."

"Most of his success came in the weight room as he played safety the year before," Lobendahn said. "The weight room showed us that if he can take the pounding, he would be able to give us what we needed behind the front that we have. As the plays started in the spring, we looked and we said, 'behind this line, this guy might break some stuff'. That just started into summer and it led to where we started [the season] with him and it's just really opened up."

The score remained 41-0 until an interception from Norwalk junior safety Joel Alarcon in the final seconds of the stanza paved the way for a one-yard sneak from

sophomore quarterback Christopher DeLeon early in the fourth quarter. Sanchez would tack on the final score with 36.2 seconds remaining on a 19-yard run. He would finish with 80 yards on eight carries.

"It means that I accomplished something in life," Sanchez of the win. "It took four years to do this and we all worked hard for it."

"It was really more just spirit this year; that everyone had confidence," Sanchez later said. "The coaches kept reminding us what happened last year and that just fueled our bodies."

"It was really important to us, not just me, but to the seniors, too," Udengwu said. "It's what we've been talking about since January. We wanted to get this win."

After the first quarter, the Lancers had one drive of over five plays. That would come in the third quarter when an 11-play drive ended in a punt. They had four drives in the second quarter on a combined 16 plays and one drive of three plays in the fourth quarter. Sophomore running back Warren Stevens-Tayou led Norwalk with 91 yards on 21 carries.

"I looked in the backfield and thought if that guy gets a few touches back to back, he could be a yard gainer," Lobendahn said. "I've seen him bust a few. He carries enough weight below that it's not going to be an arm tackle that brings him down. It's going to be a complete wrap."

Both teams will have tonight off before jumping into action of their respective leagues. Norwalk, which has scored 56 points this season, will visit Suburban League favorite Mayfair High (5-2) on Oct. 12 while Glenn, which improved to 4-3 and was bumped up to ninth in the CIF-Southern Section Division 12 polls, plays its first 605 League contest against Artesia High, also on that date.

"My eyes are on Artesia," Lobendahn said. "I'm prepared to break down film and watch their game against Western and see what I have to do to get going in [the 605 League]."

"We have to celebrate this win first, but it's on to next week and on to Artesia," Udengwu said. "[It's] time to rest up and then time to go to Artesia for our start to the 605 League."

The daughter described to her mother how the teacher forcibly put her hand on his penis and said he was in love with her and that he would go over to the girl's house drunk trying to take her out.

HMG-LCCN did learn that there was an internal investigation after the allegations surfaced, and that the teacher was terminated, but that was the extent of the investigation.

And that could land everyone involved who knew about the issue in legal hot water.

The ABC investigation did not call for law enforcement to intervene, even though sources are telling HMG-LCCN that the teacher allegedly had additional interactions prior to the 13-year-old exchange.

HMG-LCCN has also been told that the teacher had been transferred twice between ABC schools.

This was all a surprise to the six remaining ABC School Board members, including ABC Board Vice President Leticia Mendoza.

Usually the Board President will inform the Vice President of any serious issues, especially sexual assault and then immediately report the incident.

As the mother sobbed at the dais, President Yoo reportedly attempted to move the meeting along, but Board Member Chris Apodaca would have none of that.

Apodaca grabbed a box of tissue and left the dais to comfort the mom, and gave her all the information she needed to properly report the issue.

The mother gathered herself and de-

scribed her daughter's state-of-mind and that she had to move the child to Texas to get her away from the teacher.

HMG-LCCN could not obtain information on the teacher other than he was classified as a "para-educator;" para-educators usually start at elementary schools then work their way up to middle schools, but for some reason the teacher was transferred from Haskell Middle School to Cerritos High School.

HMG-LCCN has sent emails to Dr. Sieu and President Soo Yoo, as of publication time they had not responded.

A partial transcript from the emotional mother's testimony, "You have a problem in your district and I'm speaking about a sexual predator you have in your district and I'm the mother of the child. I had to send her away to Texas to protect her and I feel you guys are holding on to the criminal evidence that would put this man behind bars. I am separated from my daughter, she is a mess because she thinks she is in love with this guy. He was a para educator at Haskell and then he worked at Cerritos, you guys suspended him 2 1/2 weeks ago I have not seen my daughter in 2 1/2 weeks. I want to know if you guys are mandated reporters can somebody answer me you're a mandated to report abuse and molestation?"

The mother then suggested that a cover-up by the District had occurred.

"I have left messages for the Superintendent (Dr. Mary Sieu) which I never got a callback. I have a police report. I can't get any cooperation, all I hear is 'I understand I understand where you're coming from' no you don't!"

"I have tried to do this the legal way, I'm asking you guys for help because you hold the key to locking this man up because I tell you what, this was not

his first rodeo. He was too comfortable with what he was doing. He works for one of your junior high schools last year (Haskell) and he's at Cerritos High this year, they won't tell me if you guys fired him, I know he was suspended."

"Everybody is protecting this man."

"I am asking you tonight to turn over the report from Artesia High school that says this man put took my daughters hand and put it on his penis and that he was kissing her, that's what I'm asking for because that's when the law-enforcement will act."

"This has been a nightmare, our family has been in the ABC district for over 50 years. I have begged everybody, I can't sleep at night, my daughter can't sleep at night my whole life has been ripped and nobody is listening."

"Can the board please turn over that evidence so you can take it down to Lakewood Sheriff's department and have this man arrested and jailed where he belongs."

"The response to my request from the district was 'he's not working for our schools anymore he won't be around children.'"

"You guys hold that information, if you guys would've took that and done your job that day after she reported it to Artesia High, and you should've reported it to the sheriffs, we would've already had an arrest and I can have my daughter back where she belongs."

President Soo Yoo, who knew about the assault allegations, then asked Board member Apodaca to return to his seat.

Yoo said, "we thank you so much for coming to us, we thank you for coming and sharing with us we know this is difficult."

The mom then interrupted, "have you not heard about this."

Yoo answered no.

"The mom then snapped back, "did you get the phone call I left for you last week because you never called me back. So you can't say you don't know about it, don't say you didn't know about it."

Superintendent Dr. Mary Sieu then said, "excuse me first of all we're not to engage in dialogue with people who have made public comment I will follow up with you tomorrow."

The mom then held up a picture of her daughter, "this is my daughter, do you see her, because I don't."

Yoo then interrupted her saying, "we thank you for coming I know this is hard for you."

Yoo then completely ignored the comments and quickly move to the next speaker.

The District along with Yoo, Sieu, and anyone else who knew about the issue could be in violation of the several California Penal Codes under the Mandated Reporters section which would place the District and those who knew in legal jeopardy.

Under the Codes, Mandated Reporters include teachers, teacher's aides, administrators, and employees of public or private schools.

Yoo and Sieu are clearly under the category administrators.

California Code §§ 11166; 11165.7 states, "a report is required when a mandated reporter, in his or her professional capacity or within the scope of his or her employment, has knowledge of or observes a child whom the reporter knows or reasonably suspects is the victim of abuse or neglect."

Cerritos High clinched at least a share of the first 605 League championship after sweeping Pioneer High 25-10, 25-13, 25-19 this past Tuesday. The Lady Dons, ranked seventh in the CIF Southern Section Division 5 poll, improved to 20-3 overall and 8-0 in league. They will host second place Whitney High today with a chance to win the league outright, then travel to Oxford Academy on Tuesday before hosting Paramount High on Thursday. Whitney, which will finish in second place in the 605 League, swept Oxford Academy this past Tuesday to improve to 13-6, 6-2. The Lady Wildcats, who won six matches last season, will host John Glenn High (5-15, 3-5) on Tuesday. This is Whitney's best record since going 15-8 in 2001.

Norwalk High was swept by Mayfair High 25-18, 25-16, 25-19 this past Tuesday to drop to 5-8, 3-3 in the Suburban League and for all purposes, will battle Bellflower High second place. The Lady Lancers, who hosted last place La Mirada High on Oct. 4, will travel to Bellflower on Tuesday before hosting Mayfair on

Thursday.

Valley Christian High got past Heritage Christian High 25-19, 25-14, 25-18 this past Tuesday evening to improve to 17-11, 3-3 in the Olympic League. The Lady Defenders, who hosted second place Whittier Christian High on Oct. 4, will wrap up the regular season with a home encounter against last place Maranatha High on Thursday. Most likely, the Lady Defenders will finish in third place in the league.

FOOTBALL

Western High (5-1) @ Artesia (4-2)-Artesia had its four-game winning streak snapped by Segerstrom High last Friday night in a 54-13 setback. It marked the first time Artesia has been held to under 20 points this season while the 54 points are a season-high allowed. The 'other' Pioneers come in hot, winning four in a row and having scored over 40 points four times. Two of those came against teams Artesia will see in 605 League competition-Cerritos, a 69-33 win on Aug. 17, and Glenn, a 42-28 conquest on Sept. 14.

Western, the top-ranked team in Division 11, thrives on the passing game as Anthony Munoz has passed for over 2,100 yards and 29 touchdowns opposite just four interceptions. He is completing nearly 71 percent of his passes. In addition, Western is effective on the ground with just over 800 yards and another

10 touchdowns. Artesia senior quarterback Heder Gladden has already rushed for over 1,000 yards for Artesia and has found the end zone 17 times. Senior running back Travys Davis and senior wide receiver Marcel Bowman are also key offensive threats.

Cerritos (3-3) @ Ocean View High (6-0)-The Dons should be well-rested after having their bye last week. But what is greeting them is a team that has scored no fewer than 35 points in any game and shutout Dana Hills High 38-0 on Sept. 21 and yielded one touchdown in each of its other five games. The Seahawks, ranked second in Division 11, love to run and is led by Dezmond Doxey (443 yards, four touchdowns) and Noah Hickman (423 yards, 11 touchdowns).

Cerritos will look to either junior quarterbacks Stacy King or Nick Lightell, both of whom have combined to throw for over 1,400 yards and 19 touchdowns. Senior running back Tye Anderson is still the main force on the ground with 643 yards, 11 touchdowns.

Lynwood High (0-4-1, 0-1 in the San Gabriel Valley League) @ Gahr (2-4, 1-0)-Records were shattered last Friday night when Gahr began SGVL action against Dominguez High. The Gladiators roughed up the Dons 72-40 to not only stop a four-game losing streak but score the most points since blasting Cerritos

63-8 on Sept. 9, 2016. Also, in that season, the Gladiators blanked Dominguez 48-0 and has won three straight over the Dons. It's the third league game in which Gahr has scored over 50 points, having done it at Lynwood on Nov. 4, 2011 (57-32) and at Warren High on Nov. 2, 2012 (54-21). In addition, it's also the fifth time since 1998 Gahr has eclipsed the 60-point mark in a game. Lynwood has scored 42 points, but 28 came in a tie against Los Angeles Jordan High. The Knights have allowed 200 points, which means the Gladiators should feast on their defense as Gahr has scored 218 points.

Valley Christian (2-5, 0-1 in the Olympic League) @ Maranatha High (3-3, 0-0)-The Defenders found it tough going against league favorite Heritage Christian High last Friday night in a 25-10 loss. V.C. has allowed at least 19 points this season. On offense, the Defenders have been limited to five touchdowns and five field goals in their five losses. The Minutemen are coming off their bye but have been an up and down team thus far and have shutout a pair of opponents while losing twice by a combined 12 points and getting blown out in the other. Enrique Garza has thrown for 1,151 yards and 17 touchdowns with one interception while the Defenders have been paced all season long by senior quarterback Hayden Ericks and senior running back Curtis Walhof.


