Artesia's Urban Forest Plan Continues With \$900K Grant for 1,000 Trees



ENGINEERS planted trees at Artesia Park, AJ Padelford Park and Baber Park. Residents can request trees for their sidewalk grass.

The trees planted will be a variety of species approved by Cal Fire.

The City of Artesia recently planted 26 new trees at all three City parks beginning March 1, to officially kick-off a multi-year tree planting campaign, funded by the California Department of Forestry and Fire Protection. This is part of the City's efforts to expand the tree canopy coverage in the City and bring benefits to Artesia residents.

Cal Fire will oversee the planting of these more than 700 new trees in public areas and just as many fruit trees distributed to Artesia families over the next few years.

Artesia Park received 20 trees; AJ Padelford Park had five planted and one tree was placed at Baber Park.

The trees planted were from a variety of species approved by Cal Fire, chosen because of their low water use, climate adaptability, and suitable size for their location.

These trees are the first to be planted under a grant received by the city of Artesia.

In 2019, the City was awarded almost \$900,000 grant

Vaccine Inequity Hits Hawaiian Gardens

Only 9% of residents are vaccinated, compared to 18% in Lakewood and 27% in Cerritos.

The effects of the vaccine inequity are being felt in the tiny town of Hawaiian Gardens. The closest vaccination site and it's 10 miles away in Downey and that's causing problems for many residents in the city.

As of this week only 9% of Hawaiian Gardens residents have been vaccinated compared to 18% in Lakewood and nearly 27% in Cerritos.

LA County Public Health Director Barbara Ferrer is in favor of providers giving out the shots instead of "putting a vaccination site in every neighborhood. Our strategy has been to figure out ways to help them build their capacity."

But that has not happened in Hawaiian Gardens.

Trying to get a site has been met with the usual red tape. Hawaiian Gardens Councilwoman Myra Maravilla

and the other elected officials have asked for help from Congressional representatives, LA County Supervisors, local elected officials, and the county's Department of Public Health, so far no answer.

Maravilla says Ferrer's strategy won't work in the city "To say we will partner with local providers is no good, there's really not much here, we are one square mile. In larger cities you can go through your doctor, but a lot of people here don't have a doctor."

That is a reflection of the city's income demographic, which sits around a median of

Disenfranchised Cities in Southeast L.A. County Join Forces to Form SELA United

The collaborative scored 2,000 vaccines from FEMA and state as its first action, looks forward to bargaining.

Given the vaccine inequity and other factors that cause S.E. Los Angeles cities to always be the "shoemaker's stepchild," city leaders in the area are collaborating to bring more bargaining to the table starting a new coalition called SELA United.

For now SELA counts its members as Bell, Bell Gardens, Cudahy, Commerce, Huntington Park, Lynwood, Maywood and South Gate.

But they are thinking of expanding to help similar cities not in SELA, including working with city leaders from Hawaiian Gardens, Montebello, and Paramount.

Cudahy Vice Mayor Elizabeth Alcantar told

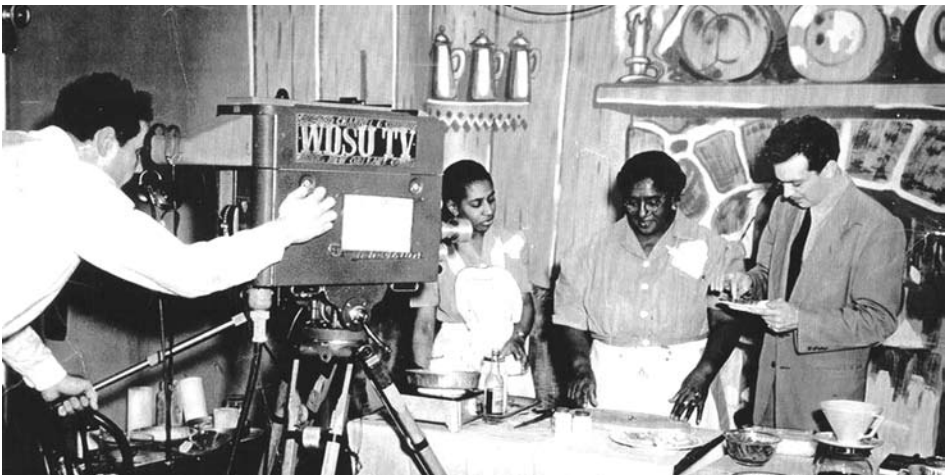

WOMEN'S HISTORY MONTH

The Smithsonian Highlights Famous Women Chefs

Highlights include a look at Lena Richard and Julia Child's careers.

Smithsonian Affiliations held a webinar in celebration of International Women’s Month on March 10, 2021 taking a closer look at pioneering chefs Lena Richard and Julia Child. Through their cookbooks, teaching, and television programs, these extraordinary women inspired generations of people to take cooking seriously. They challenged perceptions and stereotypes of women in their respective eras and made lasting contributions to culinary history. Their

stories, reflective of their very different backgrounds, reveal insights about women, race, food, and culture in 20th-century America.

In 1949, Lena Richard, an African American Creole chef, went live on EDSU-TV for the first time. “Her reputation was very fine,” said Marie Rhodes, Richard’s daughter and sous chef, “everybody used to call her Mama Lena.” Richards shaped the public awareness of New Orleans cuisine by showcasing and celebrating the black roots of Creole cooking during a time when racial stereotypes surrounded the food industry.

The show titled “Lena Richard’s New Orleans Cook Book” was one of the earliest offerings on the station and became so popular that her show began airing twice weekly. “Richard’s ability to share her recipes on television, in her own words and as the star of her own program, was an important and exception departure within the media culture at the times,” said Ashley Young, Historian and Curator at Smithsonian’s National Museum of American History.

Richard owned and operated a catering business, eateries, a fine dining restaurant, cooking school and an international frozen food business in the racially segregated South. She understood culinary training as a tool young African American cooks could use to build a better life for themselves. In 1937 she opened a cooking school specifically for Black students and envisioned it as a place ‘to teach men and women the art of food preparation and serving in order that they could become

capable of preparing fine food for any occasion, putting themselves in a position for higher wages.” She taught her students recipes for resilience based on professional development and how to navigate the race and gender based barriers.

In the 1950’s educational television programming consisted mainly of lectures, book discussions and classical music performances. Julia Child changed the stuffy atmosphere in 1962 with her book review and took husband Paul, a copper bowl, whisk, apron and eggs launching the WGBH-Boston hit series, “The French Chef.”


The first TV program was shown on what came to be known as PBS in 1963 and remained on the air for a decade. It brought Child national and international recognition. She also won a Peabody and Emmy Award for the program. She went on to publish several more cookbooks, including a second volume of Mastering the Art of French Cooking.

From 1963 to 1973 her program broadcast 300 episodes form Child’s kitchen.


In 1948, while her husband was stationed in Paris, Child enrolled in the Le Cordon Bleu cooking school where she met Simone Beck and Louisette Bertholle. Together the three women published ‘Mastering the Art of French Cooking’, bringing the art to the American public.

She also hosted several other television series, including Cooking with Master Chefs and Julia Child & Jacques Pépin Cooking at Home, for which she won a Daytime Emmy Award. Quite literally, she brought home the original empowering philosophy of The French Chef: “You can do it!”


Through their cookbooks, teaching and television programs, these extraordinary women inspired generations of people to and made lasting contributions to culinary industry.

ABC Partners with Albertsons/Vons to Vaccinate Teachers

Nearly 500 ABC Unified School District teachers and staff received vaccinations on Wednesday, March 10, 2021, at Cerritos High School.

The vaccination clinic was a partnership between the school district and Albertsons/Vons pharmacies.

Teachers and staff who will likely be returning to schools first were prioritized, and others were slotted into appointments as they became available.

“This vaccination clinic is just another step to reopening our schools safely,” said Superintendent Dr. Mary Sieu. “We have spent a great deal of time preparing our facilities for returning to schools, and now we are preparing those who will teach our students, run our schools, clean our campuses, and drive the busses getting our kids to school.”

Screening tables, lines with teachers and staff spaced six feet apart, and vaccination

stations filled the Cerritos High School gym. Running from 11:00 a.m. to 3:00 p.m., the clinic was run efficiently and effectively, and 456 ABCUSD teachers and staff members received their first to two vaccine doses.

“We are so pleased to bring vaccinations to our employees,” said Board President Sophia Tse. “As a nurse, I know the importance of being vaccinated and how it will benefit our employees now and our students soon.”

The school district will run another vaccination clinic in about a month, providing the second dose of vaccine to those who received their first dose at this clinic.

ABCUSD has also joined several other local school districts to offer vaccinations at PIH Whittier Hospital. The district’s board of education will meet on Tuesday, March 16, 2021, at 7:00 p.m. to consider reopening plans.

16 to 64, Serious Health Conditions, Now Vaccine Eligible

LA County residents ages 16 to 64 with certain serious underlying health conditions are now eligible for the COVID-19 vaccine.

This includes those who have:

Cancer (current and with a weakened immune system);

Heart conditions; such as heart failure, coronary artery disease, and/or cardiomyopathies;

Type 2 diabetes with hemoglobin A1c level > 7.5%;

Sickle cell disease;

Chronic kidney disease, stage 4 or above;

Down's syndrome;

Severe obesity (BMI of 40 or higher);

Chronic pulmonary disease, oxygen-dependent;

Pregnant women and unhoused people are also included in this new expansion.

Visit the Department of Public Health's webpage to view the full list of qualifying conditions. Other groups currently able to get the vaccine:

65 and older; Teachers and school staff ; Health care workers; Long-term care facility residents and workers; First responders and other emergency services workers; Grocery store workers, restaurant staff, and other food service workers; People living or working in congregate living facilities; Janitorial, custodial, and maintenance services workers; Transportation workers.

Hynes D.E.S. Portuguese Hall Celebrates 98 years

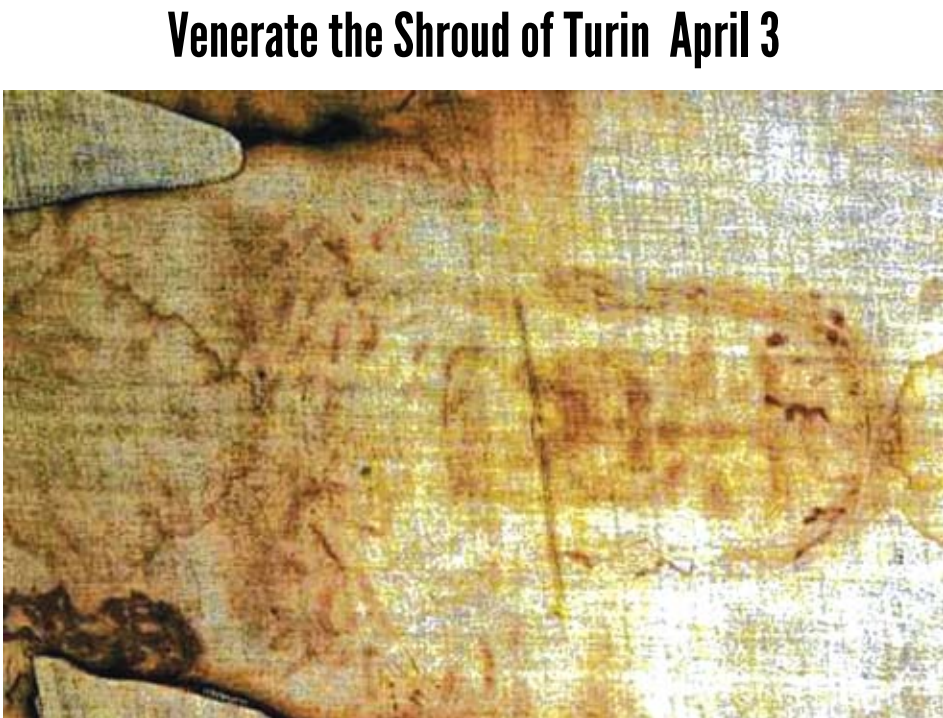
In the latter part of the 19th century, Portuguese immigrants came to the United States, with some settling in California. Predominantly Catholic, they soon re-established their celebration of the “Divino Espirito Santo” or the Holy Spirit. Paramount was previously the City of Hynes.

This religious celebration originated with Queen Saint Isabel, daughter of King Aragon, who married a young monarch, Diniz, in Portugal. She was known for her religious devotion, her compassionate heart, and her service to the poor

Legend has it that during Queen Saint Isabel’s reign there was a terrible famine. in Portugal. The Queen depleted all of her funds while seeking food for her people. She had no financial resources left and at Mass she promised the Holy Spirit, “I will give my crown to the church if you will send me a miracle, so my people will be relieved of the hunger.” After she left the church, she saw ships coming into the harbor loaded with wheat and corn! For 700 years the Portuguese people have celebrated and honored this event in the Festa do Espirito Santo or Feast of the Holy Spirit with mass and sopas meal.

This year marks the 98th year that Hynes D.E.S. will celebrate its annual Hynes D.E.S. Festa honoring the Holy Spirit. Due to the Pandemic, there will be no Public Celebration this year; however, there will be three fundraiser meals and the annual mass. The Festa mass will be held

THE SHROUD has gone on public display four times since the year 2000, the last time it was presented to the public was in 2015.

For the second time, the Shroud of Turin will be exposed for veneration on social media and websites on Holy Saturday, the archbishop of Turin has announced.

The Shroud, which bears the image of a crucified man and has been venerated for centuries as Christ’s burial cloth, will be displayed via live stream on April 3.

“The Shroud is a reality that concerns everyone. The Shroud image that Turin has preserved for almost five centuries testifies to pain and death, but also to resurrection and eternal life,” Turin’s Archbishop Cesare Nosiglia said in his March 3 announcement.

“In front of the Shroud we can exclaim with our hearts turned to the Lord: ‘your love is forever.’”

Nosiglia will also preside over a liturgy on Holy Saturday, which will be live-streamed from the chapel of the Turin cathedral, where the Shroud is kept in a climate-controlled vault. Young adults from Turin will present reflections on the theme of hope.

It will be the second time that the Shroud of Turin has been exhibited over the internet after it was displayed amid the coronavirus pandemic and Italy’s national lockdown on Holy Saturday 2020.

But this time will be different, according

to Nosiglia. “It is not the simple repetition of the one celebrated in 2020,” he said, because at the time the pandemic was still new and not yet understood, while today we are “aware of the difficulties to be faced and the commitments that we can take.”

A public display of the Shroud was supposed to take place from Dec. 28, 2020, to Jan. 1, 2021, during the 43rd international meeting of the Taizé Community, but both events had to be postponed due to the coronavirus restrictions.

“The exposition of the Shroud was proposed by the Turin Church to all young people, and we hope to be able to conduct it because the path is an opportunity to show [we are] ‘fratelli tutti’ [all brothers],” Nosiglia said.

The Shroud has gone on public display four times since the year 2000.

The last time it was presented to the public was in 2015. Pope Francis prayed before the relic during a visit to Turin on June 21 that year. Afterward, he described it as an icon of Christ’s love.

“The Shroud,” the pope said, “attracts people to the face and tortured body of Jesus and, at the same time, urges us on toward every person who is suffering and unjustly persecuted.”

L.A. County Junior Lifeguard Program is Back

The Junior Lifeguard Program is offered to all children, ages 9 through

“This is one of those programs that really opens up doors for kids,” said Supervisor Hahn. “You would be surprised by how many of our LA County Lifeguards got their start as Junior Guards.”

Solanki, Vo, and Barrows Refuse to Cap Third-Party Delivery Fees Cerritos

Since HMG-CN opined two weeks ago on the lack of action to cap delivery fees - by a majority of the Cerritos City Council, one formed in violation of the Brown Act open meeting laws - an increasing number of cities in Los Angeles and Orange Counties and the nation have limited fees third-party food delivery apps, like Doordash and Uber Eats, can charge restaurants.

California has proposed a bill, along with New York and red state Texas, and Washington and Oregon have already passed laws limiting fees.

Yet Mayor Solanki, Mayor pro tem Vo, and Councilman Barrows sit on their hands doing nothing, shooting down any proposal by Councilman Frank Yokoyama.

A social media post from one restaurant showed an invoice from money-grubbing Grubhub. After being docked for commissions and fees, all that remained of the pizza joint's \$1,042 in pickup and delivery sales was a measly \$376.

Mayor Solanki, could you operate your supermarkets at 36% gross operating margin before deducting food, payroll and other expenses?

Before the shutdown, Anca Caliman,



co-owner of Lemon Poppy Kitchen in Glassell Park, told the L.A. Times that less than 15% of her restaurants' revenue came through apps. Now it's more than half, which means her profit margins are thinner.

"The fees are just too high. Restaurant profit margins are maybe 5% on average. Then to have a delivery service charge between 20% and 30% is just crazy. And the way they present themselves: 'You're going to get so many more orders.' Yeah right, 1,000 orders at 30% off does not

help."

Kevin Vaughan, who runs seven Irish bars and restaurants in Chicago complained that GrubHub, which has monopolized search results for his restaurants, takes 35 to 40 cents for every dollar customers pay. "You can't survive on those kind of economics in the restaurant business," Vaughn said. "I'm not one for caps. But I really think they are hurting a lot of small businesses out there. I think it is time for government to step in, at least during the pandemic, to

limit some of this inappropriate behavior. Artesia, Hawaiian Gardens, Los Angeles, Montebello, Buena Park, Pasadena, San Diego, San Francisco, Seattle and many other cities sympathize with these owners.

Solanki, Vo, Barrows? They are like three Sergeant Klinks from Hogan's Heroes, "I see nothing, I see nothing!"

Now Huntington Beach is thinking of cracking down on these types of fees limiting them to 15%.

Councilwoman Natalie Moser said, "A lot of restaurants avoided working with food delivery apps before the pandemic because the costs to their business was too high."

The smaller mom and pop restaurants have to endure high fees because they have little negotiating power like Taco Bell or McDonald's.

"In this moment in time, we're just trying to do anything that we can do to help our small businesses and our restaurants," Moser told the OC Voice.

Yes help, which is what local governments are supposed to do when businesses in the city are taken advantage through no fault of their own.

ACLU: Whittier to Allow Live Public Comment at Meetings

without the support of Supervisor Hahn, who has been committed to this project and has worked with our City to articulate a vision and a design that reflects the needs of our community. This complex and sports fields will be a legacy to younger generations that health matters to us. Our youth matter! I’m looking forward to its completion and the many years of use and recreation.”

In 2016, the Board of L.A. County Supervisors approved the Rancho Los Amigos South Campus Sports Project.

Hahn has remained committed to the project and continued to encourage county staff to work with city staff to complete the design and layout of the

multi-use fields. The development of this includes three synthetic soccer fields, with the largest field being able to host football and Lacrosse play, a parking lot, 3,000 sq ft building that includes meeting space, fencing and drought tolerant landscape.

The project is budgeted at \$12.2 million, of which \$10 million will be from Supervisors Hahn’s 4th District discretionary funding and the additional \$2.2 million will come from the City of Downey covering the synthetic turf, office space and multi sports scoreboard. The project is estimated to be completed on a very aggressive timeline of November 2021.

New Playgrounds at Bellflower's Caruthers Park

The new Caruthers Park playgrounds officially opened this past Monday, March 15, 2021.

As part of the Caruthers Park Stormwater and Urban Runoff Capture Project three new play areas have been refurbished and new playground equipment installed.

A new small enclosed play area has been designated for toddlers ages two through five. The play ground is surrounded by wrought iron fencing and monitored for occupancy. A swing set with four regular swings and two adaptive swings are adjacent to a castle structure fit to climb and conquer or sit and slide.

The larger playground is outfitted for rougher play and children age’s five

to twelve. A larger swing set has been added to accommodate four regular seats and also two adaptive swings, ADA compliant for children in wheelchairs. The structure in this area has five slides, a double turreted castle also with climbing features.

And last but not least is the new Splash Pad area highlighting numerous water features, with water play set in 15 minute water loop intervals. This new area replaces the outdated wading pool and will be monitored by staff with a maximum of 25 children within the fenced area. The new Splash Pad is set to open April 2021.

The completed storm water project is set to be finished with grass areas and picnic tables sometime in the fall of 2021.

Metropolitan State Hospital Transfers Patients Out of CYA

Norwalk, CA – Metropolitan State Hospital officials notified the City of Norwalk that patients housed at the California Youth Authority (CYA), had been transferred out as of February 11th.

City officials were also notified that the facility will be used solely as a transitional facility for patients prior to being transferred to the Metro State Hospital (MSH), with a maximum stay of 14 days. On Feb. 17, 2021, there were 27 patients admitted to the facility, they were transferred to the MSH two weeks later.

Norwalk City officials have made several attempts to ensure that residents are fully aware of the DSH’s use of the facility. Starting in September 2020, a public information campaign was coordinated by City officials and the DSH to inform residents of the plans for the use of the facility on Bloomfield Avenue. “We coordinated two virtual town-hall meetings in collaboration with the Department of State Hospitals and the Metro State Hospital. It was important to the City Council that residents were provided with details and given an opportunity to voice any concerns regarding the use of the facility,” said Mayor Jennifer Perez.

Per a signed agreement negotiated between the Metropolitan State Hospital and the City of Norwalk, patients that may be housed temporarily at the annex will have to pass a background check. Both the local Sheriff’s Department and Metro Police will continue to monitor the facility.

Spectrum1,"Our residents ride the Metro, they walk, they utilize that system, but they don’t yet have a seat at the table that really advocates for them to have better service, to have new improvements and to have projects coming to our area.”

That is very true, any advertising placed aiming at those in the demographic that take public transit are consistently placed in publications they do not read, such as the Los Angeles Times. Federal funds got to the wealthier cities first, leaving crumbs for the cities in SELA.

South Gate Councilwoman Diaz echoed that fact, "We are the donut hole of L.A. County. Funding tends to go outside neighboring cities and not here," she explained.

SELA is proving that there is strength in numbers, securing 2,000 vaccines from Governor Newsom for their region.

Lynwood Mayor Marisela Santana said she’s watched SELA cities be ignored and is happy a group of cities is getting together to do something about it.

Similar to Hawaiian Gardens, Mayor Santana said less than 10% of residents in Southeast L.A. are vaccinated, so they fought, and recently secured a mobile vaccination site.

"Our communities are very resilient and hardworking, but we have been constantly disenfranchised and overlooked," Diaz said.

Now they have a loud voice that will constantly work to get federal attention and obtain funding for their communities.

Ventana Wildlife Society's efforts to save endangered California Condors viewable "live"

After a wildfire all but destroyed their rescue sanctuary months ago, the Ventana Wildlife Society rose out of the ashes to continue saving the endangered California condor.

Ventana Wildlife Society is a nonprofit based out of Monterey. Before rescuing condors, they successfully reintroduced bald eagles into the wild in Central California. It has been since 1992, that Ventana Wildlife Society has helped protect and repopulate California Condors, according to Kelly Sorenson, who has been executive director since 2003, after starting with the

organization in 1991.

After a wildfire all but destroyed their rescue sanctuary months ago, the Ventana Wildlife Society rose above the ashes to continue saving the endangered California condor.

"We own an 80-acre parcel of land in the Ventana Wilderness where we reintroduce California condors to the wild," Sorenson said. "The Dolan Fire last August, destroyed our entire infrastructure (i.e., roads and buildings) essential to our work so we are rebuilding."

Though condors might not seem important to some because they are "obligate scavengers that feed mainly on dead mammals," eating their carrion or dead flesh, Sorenson sees them in a vital and broader light.

"Their importance extends beyond the ecological niche they fill because people all over the world care for these birds and the ideal of restoring nature," he explained.

One condor, "Iniko," whose name means "born in troubled times," was just a fledgling when the Dolan Wildfire raced through the Big Sur facility last August. She and her mother, "Redwood Queen," survived but her father, "Kingpin" perished



in the fire.

Iniko's mother struggled to feed and protect her but could not be in two places at once. A few months later, another condor named "Ninja" moved into the territory, harassed Iniko and forced her to leave the nest, but she fortunately was prepared to depart. A few days after Ninja occupied her father's territory, Iniko had a possible leg injury noticed by Ventana Wildlife Society biologists. They decided to rescue her, and she was taken to the Los Angeles Zoo. If all goes well, she will be released into the wild sometime this year.

They are the largest bird in North America, considered endangered by the federal government in 1967, and in California in 1971. At the time in 1971, only few dozen remained in the wild, according to www.wildlife.ca.gov/Conservation/Birds/California-Condor.

"California Condors are still critically endangered, and as of Dec. 31, 2021, there were only 504 condors living, of which 329 were in the wild and 175 were in captivity," Sorenson said. "Condors are being reintroduced to several areas where they are native, including Central and Southern California, Arizona, and Baja California, Mexico."

"When condors are back to being self-

sustaining, meaning when their level of mortality is reduced, they will once again fly free without the need for us," he added.

For the time being, the Ventana Wildlife Society stands by. With one innovative way, by starting a free non-lead ammunition program, they hope to increase the condor population. Half of all known condor deaths are caused by lead poisoning, with spent lead from ammunition being the biggest source, according to Sorenson.

"As a result, we started the free non-lead ammunition program, and have given out more than \$250,000 and 10,000 boxes of high-performing copper ammunition as way to encourage a switch," he said. "This is a top priority."

Sorenson explained that when a substantial number of hunters and ranchers switch to copper munitions in regions condors inhabit, the species will breed more in the wild and grow in numbers to be self-sustaining, no longer in need of human interventions.

"It is not the fault or problem of hunters or ranchers [though], but rather that they are a part of the solution," he said.

For the present, Ventana Wildlife Society continues to conduct periodic releases of young birds to greater support their populations' growth.

VENTANA WILDLIFE SOCIETY'S work is to save endangered species such as this majestic California condor in flight over the Big Sur coastline.

They currently are assisting the Native American Yurok Tribe and the National Park Service to establish a condor release site at Redwood National Park on the coast near the California-Oregon border. It is anticipated to expand condors into Northern California and possibly beyond, according to their website.

Since first releasing condors in 1997 from their sanctuary along the Central California coast in Big Sur, they created another release site at Pinnacles National Park in Central California. Recently, they also began releasing near San Simeon. Two adult condors recently established their territory in the area and are the first to nest in San Luis Obispo County in more than 60 years, according to Ventana Wildlife Society's website.

Though they have no formal way of educating others they do have a few ways including monthly Condor-Zoom Chats where 200 or 300 people attend to learn about condors and their recovery. <https://www.ventanaws.org/zoom-chats.html>

Prior to COVID-19, they would take 1,200 youth to the outdoors annually to learn about the environment and how to

protect it.

Their website, Ventana Wildlife Society offers three solar powered "live" webcams (which when low on power show previous video). Two come from their Big Sur sanctuary with a third in San Simeon, all on private property. Most condors are active late morning to early afternoon. To help viewers identify a specific condor, they can access a "Condor Spotter" online at www.ventana.org and input the color and number of the wing tag. Viewers might also see mountain lions, bobcats, black-tailed deer, golden or bald eagles, ravens, or blue birds. Webcams are accessible at www.ventanaws.org/condor_cam.html through www.explore.org.

"I'm excited to share that our audience now includes more than a dozen countries and every state in the Union," Sorenson said.

Looking back and towards the future, he feels Ventana Wildlife Society's successful efforts such as with the bald eagle and California condor have served and continue to serve as an international model of success for others to follow Ventana Wildlife Society's example.

"We can co-exist with wildlife if we just try to make a little effort and we believe the condor is worth saving for a variety of reasons, including the restoration of the niche they fill and the joy it will provide to people all over the world who care about protecting our natural world," Sorenson said.

605 LEAGUE CROSS COUNTRY TIME TRIAL

Cerritos High hosts first 605 League cross country event

It may have been an unconventional form of a cross country event, but for the 64 runners who came out to Cerritos High last Saturday morning, they just wanted to run. The 605 League finally started their very brief boys and girls cross country season with a time trial run around the high school, most of which took place on the back end of the school.

“It was definitely exciting just to see the athletes have an opportunity to get on the course and race,” said Cerritos head coach Jason Watanabe. “Even though it wasn’t head to head, they still compared times and even just with each other, they can have that competition that they didn’t have before.”

Instead of the popular cluster meets or even a dual meet, the 605 League decided to have each school run separately, roughly 50 minutes to an hour apart from the next school, and in alphabetical order. While there were no team scores, the times of each runner were still kept and at the end of the race,

those times were placed in order, just like a normal cluster meet. Cerritos was the only school to have at least six varsity runners for both its boys and girls teams and each league school had at least two varsity runners.

The three-mile course began on the south end of the soccer field just behind the first base dugout of the softball field and made its way north around the baseball field, along the blacktop and back towards the track where the runners would go about 300 yards before exiting the track to run alongside the west end of the tennis courts, running behind the track and back to the baseball field. The one-mile mark was just past the start line and after making a second trip around the baseball field, the runners would make a right turn on the blacktop just before the track and make their way towards the parking lot off Bloomfield Ave. Once they reached the end of the east gymnasium, they would turn left and run through the school to the back side of the front office, turn left and head towards the other parking lot. The two-mile mark was once the runners reached the blacktop for the third time. From there, they would make another loop around the gymnasium and through the school again before going around the baseball field and athletic fields in the opposite direction before finishing the race behind the bleachers of the softball field.

“Since this was a time trial, there’s really no team concept to it,” Watanabe said. “It’s just learning the course and getting the opportunity to run. I just really enjoyed the fact that they could come out here and be in a jersey and run the course.”

Watanabe said it took him longer to set up the race because of the recent rain. But he said a decent amount was set up last Tuesday. Last Friday, the Cerritos coaches spent another three to four hours setting up the course and another hour last Saturday morning prior to the six Artesia High runners making their way to the campus. This will be the same course that the league will run for its meet on Saturday as well as the last one on Mar. 27. And, while one school

is running, the next school is warming up in the baseball field.

For the girls, Cerritos senior Sofia Vasquez and sophomore Sydney Romero had the fastest times at 19:55 and 22:58 respectively. After a pair of Oxford Academy runners had the next fastest times, Whitney High senior Julianna Lee finished with the fifth best time at 23:29, followed by Cerritos sophomore Sofia Padilla at 23:51.

Whitney sophomore Layla Lacorte, who is also an up and coming star on the basketball team, had the eighth best time (24:46) before Cerritos juniors Kailah Usi and Tara Wang finished next at 25:21 and 25:22, respectively. The top Artesia runner, who had the 11th best time, was junior Lizabeth Ortega (25:55) and the lone John Glenn High female runner was senior Kaitlyn Martinez, who had a time of 28:10.

The other three area girls who were part of the 16 varsity runners were Cerritos junior Annabelle Bernardo (12th, 26:30), Whitney senior Kritika Pantha (14th, 27:43) and Artesia senior Marissa Hernandez (16th, 28:26).

For the varsity boys, the second, third and fourth best times were run by Cerritos junior Michael Rafael (17:15), senior Anrei Giordano (17:28) and junior Andrew Hwang (17:37). Following a pair of Oxford Academy runners, the next three times were all from Cerritos-senior Chris Amaro (18:23), junior Kevin Hamakawa (18:30) and senior Eric Perez (18:55). The seventh Cerritos runner to compete was senior Jayson Malhi, who had the 13th best time at 19:43.

The top Artesia runner was junior Jareth Navarro, who had the 10th best time at 19:04 while the lone Glenn runner, with the 14th best time, was sophomore Javier Reynoso (20:07). Sophomore Agam Makkar paced Whitney with the 15th best time (20:14).

Artesia had three other varsity runners-junior Angel Buenrostro (12th, 19:35), junior Fernando Gonzalez-Gallo (17th, 20:32) and junior Michael Jaydan (23rd, 24:58) while the other four Whitney varsity runners were freshman Steven Cao (20:28), senior Jeffrey Fernandez (20th, 20:49), sophomore Colin Choi (21st, 21:14) and sophomore Ethan Choe (22nd, 24:43).

“If the weather gets warmer, the times may not get faster,” Watanabe predicted for Saturday’s second league meet. “But definitely, athletes will get to strategize a little bit more and figure out [how to] be more aggressive. They can shave off 30 seconds to a minute for some of them.”

Spring season sports underway as athletic directors still working to find non-league contests

It’s been so long since Cerritos High, and other high schools across the Southland, hasn’t had any sporting events. In fact, co-athletic director Robert Adams can’t remember the last event the Dons had before schools were shut down March 12.

The last game for the Cerritos softball team was Mar. 5 and the last baseball game was Mar. 9 while badminton, boys golf, swimming, boys tennis, track and field and boys volleyball, the other spring season sports, had events scheduled the week of Mar. 9-13.

The same is true for a lot of high schools, especially the public ones, but when Cerritos hosted a 605 League cross country time trial race last Saturday, there were plenty of smiles on the faces of the athletes, athletic directors, coaches and other school personnel.

“It’s great to have the kids back on campus to see their enthusiasm and do that stuff,” said Cerritos High co-athletic director Robert Adams. “Obviously, some of the remote training has worked, at least for some of our athletes and I look forward to seeing [the cross country team] run against Gahr [on Wednesday].”

For months, athletic directors have been putting together master league schedules in addition to their own school’s spring sports schedules in conjunction with the dates put together by CIF-Southern Section when it released the athletic calendar last July. Even when the CIF-SS gave schools the green light to start what was left of the winter season and proceed with the spring season, athletic directors all around have been adding and deleting non-league events day to day.

“The most frustrating thing athletically related is the constant change and updates and planning,” Adams said. “Since we started really working on some sort of return to activity starting in late May-early June last year, there’s an awful lot of spending hours and hours and hours to make a set of plans that four days later are obsolete and have to be adjusted. I’m thankful that it’s starting to smooth out. It’s not avoidable; it’s an unavoidable issue that we have that happen because if we don’t do some of the planning, then we’re way too far behind.”

While high school athletes have returned to play for the tail end of the fall season and the remainder of the condensed spring season, there is still a lot of planning ahead for the summer months and into the 2021 fall season, which figures to start on time and as early as Aug. 14 with girls volleyball.

Adams thinks that part of the frustration is going to be how quickly do schools move back towards what everyone wants, which is some type of normalcy. He added that the closer it gets to the beginning of the 2021-2022 school year, the difficulty level rises, including the summer, in which there are still a lot of unknowns.

“They’re not quite as extensive as the unknowns of last June,” he continued. “But they are extensive for us to be able to try to figure out how do we get the school to start operating again. Basically, operating a school along with an athletic department in a completely different way...how close to the way we were doing it before are we going to transition back? I’m sure it will



not go all the way back.”

Another obstacle that Adams and Cerritos will face for the next three months, which has been one of the biggest hurdles all along, is transportation. Even though teams won’t have as full of a schedule they’re used to, there are more sports in the spring season as the CIF-SS put the traditional winter sports-boys and girls basketball, boys and girls soccer and wrestling-in the spring season. Adams said that transportation is still a difficulty because of the density issues and needs the community and families of the athletes to be open-minded with and try to help out whenever they can. He added that at Cerritos, it hasn’t been too big of an issue, but cautioned that it will get more complicated before it improves as the ABC USD begins to bring the elementary students back to the classroom and eventually the middle & high school students.

While the CIF-SS cancelled its fall sports championships in December, it appears that the spring sports will have an opportunity to play for a championship in May and June. But, when it comes to the 605 League, Adams said it will not declare league champions for any sport this year.

“Obviously, though, if there is CIF competition, seeded teams have to be submitted,” Adams said. “I think it’s going to be a combination of [non-league] play and probably [league] just to confirm that what we are looking at in results of the different sports match up what the 605 League feels is appropriate to submit as CIF sports.”

FOOTBALL

A few area schools will play their first football games within the next week highlighted by a Mar. 18 tilt between La Mirada High and Orange High. The Matadors went 7-4 in the 2019 season, finishing in second place in the Suburban League and falling to Downey High 12-7 in the first round of the Division 4 playoffs. Orange won the Orange Coast League in 2019 and advanced to the Division 10 semifinals before the Panthers fell to Simi Valley High 30-14.

On Friday, Norwalk High, which went 3-7 in 2019 and finished in last place in the Suburban League, is scheduled to play a road game at Downey, the third place representative from San Gabriel Valley League in 2019. After knocking off La Mirada, the Vikings fell to Camarillo High 28-27 in the quarterfinals to end their season at 5-7.

Finally, Gahr High is scheduled to begin its season on Thursday against SGVL foe Dominguez High. The Gladiators went 3-8 and finished in fifth place before falling to Santa Barbara High 44-0 in the first round of the Division 8 playoffs.

Cerritos Centenarian Marcy McMahon Passes Away

Marcy Kroupa McMahon, long time Cerritos resident who had recently been honored by city council for her 100th birthday passed away March 14, 2021. “I remember the night her mother passed away, our grandmother, it was raining. It rained here too on Sunday evening,” recalled her son Jim, “She died peacefully in her bed in her Cerritos Cottage garden home at approximately 10:53 p.m. My brother Ken had just left to go to work, I believe she waited for him to leave because he couldn’t handle such things.”

Emergency vehicles had been summoned to the McMahon home in February due to complications from the CoVID-19 flu shot. That along with increasing dementia and an AFIB heart, Marcy’s health began to decline. “Her vitals were strong, but the muscle had left her body and her joints were painful. I had to massage her body because she refused to take her medication,” said Jim, “you could tell her organs were shutting down.”

Marcella Kroupa McMahon celebrated her 100th birthday on December 10th, 2020. The City of Cerritos bestowed a proclamation to McMahon honoring this grand life achievement. Born Marcella Kroupa in Jackson Minnesota in 1920, she moved to Los Angeles after graduating with honors from college in Twin Cities, Minnesota, met her husband Raymond, and was married in 1948, being blessed



with four sons. “She really wanted to try and make it to 105,” added Jim.

There were only two people Marcy continued to ask for, her sister Eleanor and her brother Wisely, Jim added, “Mom kept repeating something at the end, ‘I give everyone a big love hug’ and then she closed her eyes. It was reported that she said the rosary, very well just a few hours before her death.

Jim remarked that he has lost his rock, card playing partner, patio sitter and great conservationist but was glad that he was able to be there for his Mother through these past twelve months of the pandemic and the riots.

HMG was fortunate to cover her 100th celebration of life in December. Since the pandemic hit, life had been quiet for her. “It almost reminds me of the Great Recession in the 30’s and staying under cover during WW2, when we had to keep most of the interior lights off to secure our homes from air attack,” Marcy recalled. “When God is ready for me to come home, Orange County will be my final resting place, alongside my husband,” she stated, “fewer than one percent of Americans live to be centenarian like me. I’m not going to worry about anything or anybody. Cheers!”

Marcy’s wishes were to be cremated, and her urn will rest at Holy Sepulcher in Orange.

increase in anti-Asian American Pacific Islander (AAPI) attacks across the nation, with over 2,800 attacks since March 2020 being reported by the Stop AAPI Hate Reporting Center, while also recognizing the California Democratic Party’s commitment to supporting “a just and inclusive society by speaking out with a public and unified voice against all forms of racism, discrimination, harassment, hatred, and violence directed at racial and ethnic minorities”, as stated in the Equality of Rights and Opportunity plank of the California Democratic Party’s 2020 Platform;

Whereas, Asian American Californians, who account for approximately one-third of the nation’s Asian American population, are all vulnerable to the growing number of xenophobia-fueled attacks, which continue to be fueled by former President Trump and his supporters. This is exemplified by a now-broad use of the racist reference to COVID-19 as the “China virus” despite the World Health Organization’s guidelines in disease naming;

Whereas, the history of California and the United States as a whole relating to our Asian

American population is one of discrimination, restriction, and xenophobia, as seen in the passage of the Chinese Exclusion Act of 1882, the internment of Japanese Americans in World War II, the formation of the “Asiatic-Barred Zone” in the Immigration Act of 1917, and more;

I’m outraged and saddened by the alarming rise in hate attacks upon the Asian American Pacific Islander (AAPI) community across our country. Asian Americans and Pacific Islanders are not responsible for the pandemic. We must join together in condemning violence against Asian Americans and Pacific Islanders. #StopAsianHate #StopAAPIHate."

that has funded an updated tree inventory for the City.

The urban forest management plan is currently in development with the planting of 383 new trees placed in public areas.

This grant project and an additional Cal Fire grant will provide an additional 325 trees for public areas and 675 fruit trees for distribution to qualifying and

interested residents.

Over the coming months, the LACC will be conducting outreach throughout the City to provide information to residents about tree planting and to find residents that are interested in having a tree planted in the parkway in front of their house.

Davey Resource Group, the company creating the City’s urban forest management plan will also be conducting an outreach to expand awareness of the benefits of trees and gaining input from the community on developing the plan further.

City staff appreciates all the input residents have offered in the past as part of this ongoing process.

uncertainties of the time, it was expected that the City, like many government agencies, would face a deficit. In fact, the City’s General Fund was adopted with a projected operating deficit of \$1.8 million.

While the last year has been difficult, the City of La Mirada’s financial situation has remained sound. During a recent Council Study Session meeting, staff presented a mid-year budget update that conservatively anticipates a surplus of at least \$2.7 million. The improved budget situation is largely the result of the City’s traditional revenue sources remaining stable, the strong local tax base, and prudent planning and financial management. These same factors have resulted in La Mirada routinely being named among California’s most fiscally healthy cities according to the State Auditor.

During the past year, the City provided programs to assist residents and businesses adversely affected by the pandemic and is exploring potential uses of funding from the recently approved American Rescue Plan to do even more. The City was able to provide grants of up to \$4,000 to eligible families for mortgage/rental assistance. Nearly 50 families benefited from this program. Additionally, through the small business grant and relief programs, nearly 40 local businesses received up to \$10,000. Combined, these programs generated over \$530,000 in direct funding to support the community. We also supported local businesses through the emergency temporary outdoor dining and commercial programs to help restaurants

and other important businesses operate in compliance with public health orders.

Unfortunately, all Theatre programming was suspended and most Community Services recreational programming was limited or postponed during the past year. While this has resulted in some cost savings to the City, it also eliminated the revenues from ticket sales and participation fees. We look forward to the return of Theatre programming in the fall and plan to offer many recreation programs, including operation of the Buccaneer Bay Waterpark, this summer based on guidance received from the state and LAC Health Department.

The City has also continued to invest in updating our infrastructure. Some \$8.43 million will be spent this year on neighborhood street improvements, Alondra Boulevard street rehabilitation, Valley View Avenue median landscaping replacement, HVAC improvements at the Community Gymnasium, and the completion of new mat-rider and tube slides at Buccaneer Bay Waterpark. Additional improvements to keep our community safe and attractive will be planned for next year.

The City remains committed to prudent fiscal management practices and financial stewardship. As we begin to prepare the budget for next year, we will plan to provide essential programs and services to meet the community’s needs and enhance the quality of life in La Mirada. Also, remember to #ShopLaMirada and #DineLaMirada and continue to support our local businesses and economy!

\$50,000 with many classified as essential workers.

Hawaiian Gardens officials have been asking for mobile sites but health officials have been slow.

“We’ve asked for the mobile unit sites several times, no one has answered, it’s like the Wild Wild West,” said Maravilla.

Meanwhile, shots will remain scarce, with Long Beach and Orange County both having their own health departments,

and access to the vaccine that Hawaiian Gardens residents don’t.

For some reason shots from HG doctors are few and pharmacies have it, but they’re not on the state’s appointment portal.

Maravilla said, “It’s vaccine inequity, as witnessed by smaller community’s high infection rates, it’s a direct correlation with the health department’s local strategy. The spotlight is on equity, but not much is going on. They talk of inequity, but there is little action to correct the problem.”
