TWO CANDIDATES REMAIN FOR WATER REPLENISHMENT DISTRICT SEAT

Hews Media Group-Community News has learned that the race for the open Water Replenishment District Division Five seat left open by the resignation of Albert Robles is essentially down to two candidates, one of which will be appointed by the Board on Saturday.

WRD Division Five encompasses the cities of Bellflower, Carson, Compton, Downey, La Habra Heights, Norwalk, Paramount, Pico Rivera, Santa Fe Springs, and Whittier.

In 2016, District Attorney Jackie Lacey filed for leave to sue Robles under incompatible office statutes, also known as quo warranto.

The lawsuit alleged that holding the job of mayor and director of the water agency at the same time was a conflict of interest and violated state law.

The civil complaint alleged

which is part of the Mendocino Complex fire, is increasing on the north edge, with a mandatory evacuation order issued for Glenn County. Evacuation orders are already in place.

The blaze is the largest wildfire ever recorded in California and has currently consumed close to 400,000 acres with 157 residences and 120 other structures destroyed, while 1,050 structures remain under threat.

The River fire has been 100 percent contained, while the Ranch fire is 74 percent contained.

The Northern California fire was created when two smaller fires, the Ranch Fire, and the River Fire merged, full containment is expected by September 1

Meanwhile, the Holy Fire burning in Orange and Riverside

A group called the Artesia Coalition for Responsible Cannabis Sales, "comprised of residents, business owners and stakeholders in Artesia, and who have a strong interest in the approval of regulated and licensed cannabis businesses in the City," have gathered an impressive 305 signatures in support of their movement.

Artesia currently prohibits the establishment and operation of medicinal cannabis retail shops or any other commercial marijuana activity within the City.

Commercial activity is defined as the cultivation, possession, manufacture, distribution, storing, testing, transportation, delivery or sale of marijuana and

The oldest operating McDonald's is located on the corner of Firestone and Lakewood in the City of Downey and is one of the main tourist attractions in the area. This past Saturday the Downey Conservancy held a grand celebration for their 65th anniversary. Mayor Pro Tem Rick Rodriquez stated," For those of us who live here, these golden arches have become part of the legacy we hold so dear."

The celebration continued throughout the day with presentations made by the Downey City Council, the Downey Con-

servancy and Charles Phoenix, the father of Americana.

Guest speaker Alan Hess, is responsible for qualifying several landmark buildings for the National Register of Historic Places, including Downey's McDonald's. Through his writing, lectures, and educational outreach, Hess has shown light on many forgotten and neglected styles of postwar American architecture. The Los Angeles Conservancy calls him 'the preeminent authority on Southern California Modernism'. "This is not just a Downey landmark, but a national treasure," says Hess, "after some research, this site is the oldest remaining original building from the McDonald's restaurant chain, dating back to 1953."

Charles Phoenix is an American pop culture humorist, historian, author and chef

whose work explores and celebrates 1950s and 1960s kitsch and Americana, has included Downey's McDonald's in his latest book, "Addicted to Americana". "How much do we love this building, this place, this piece of history ... behold the glory!!!" announced Phoenix, "we are gathered here to today because this restaurant turns 65 today. This is more than just a landmark, it is more than just a masterpiece of modern architecture or culture – this is a world class treasure. You could bring the Queen of England here. You want to show her American ingenuity, you want to show off American greatness – show here McDonalds!"

The McDonald brothers had been in the restaurant business for several years when they invented the "Speedee Service System" to automate and optimize food production at their San Bernardino drive-in restaurant. They commissioned Stanley Clark Meston, a commercial architect from Fontana who specialized in auto show-rooms and had once worked for architect Wayne McAllister, to design a new building in Downey that could be replicated by franchisees.

Completed in 1953, the Googie-style building features two thirty-foot-high parabolic arches made of sheet metal that pierce the stucco wedge of the shed roof and were originally outlined in flashing pink neon. Since the brothers were so proud of their food preparation techniques, they revealed their operations with canted plate glass surrounding the kitchen, allowing inspection from all sides. In 1959, the original stock neon sign was replaced with a custom model featuring the original mascot Speedee running atop a 60-foot golden arch.

Most other historic McDonald's franchises were demolished or significantly altered over time to comply with the com-

pany's overarching design requirements, but the Downey location survived intact because it was franchised not by the Mc-Donald's Corporation, but by the McDonald brothers themselves.

Downey Councilman Alex Saab, expressed why McDonalds is so special to the Downey community, "It represents so much of our culture and ingenuity. The

brothers really did change the way the food industry developed, they not only began the fast food culture put the added to the classic car traditions. This really is a celebrated icon."

Phoenix called this classic structure the architecture of happiness, "To all of you who saved this piece of Americana culture, you are heroes to us!"



marijuana products, whether or not for profit.

During the June 11, 2018 regular Council meeting, members of the coalition spoke during public comment and requested that the Council consider removing the general ban on medicinal cannabis sales within the City.

In response to this request, Councilmember Miguel Canales requested that staff place a discussion item on the agenda for the August 13, 2018 meeting.

The initial Aug. 13 meeting discussion encompassed the laws passed by California and the federal laws that affect the state.

The floor was then open to Council comment and Councilman Canales was first to speak.

"I brought this to the Council's attention to address the individuals who have circulated petitions for medical marijuana in the City. We need policy, direction, and ideas for the community. Marijuana is controversial, but it is accepted in many Western states. However, the controversy in California is separated between municipalities. We are in a position to write policy, I want to have a conversation whenever we have a chance to increase revenue for the City."

Resident Margaret Saito took the opportunity to publicly comment and talked about the banking regulations. The federal government classifies pot as a major drug therefore banks that are under the FDIC umbrella cannot accept cash from dispen-

"The gangs are going to come into Artesia and rob the dispensaries," Saito said.

Currently there are start-up companies offering payment kiosks that do not allow employees to handle cash. The money is picked up by an armored truck agency and deposited using credit unions, who are not under the federal umbrella.

Mayor pro tem Tony Lima asked about the complicated licensing plans and enforcement concerns that both the state and cities have, for example, there are two different licenses for non-store front retail stores and store front retail stores.

Non-store front does not sell to the public but delivers the product to purchasers, store fronts can have walk-in business.

"We would have to hire more police if we had more shops," Lima commented.

Councilman Manalo asked about verification of licenses issued to dispensaries. "If someone wants to open a store they can apply to the state, how does the state know we do not allow the dispensaries?"

"The state sends the City Clerk a notice that a license was applied for, the clerk then sends the ordinance and the state denies the application," said City Attorney Serita Young.

"There are many people who are concerned, and many on both sides of the iscome in and open a cannabis business," said Manalo.

Manalo then asked, "if the Council were to consider lifting the prohibition and regulating the businesses, how long would that take?"

"Set up an ad-hoc committee to bring the process up for discussion," said Young, "also allow the process to go through the individual commissions for public comment."

The process would take months and move very slowly according to Young.

Councilman Ali Taj wanted to start a town-hall meeting process to discuss the issues "to make sure the whole process was transparent."

Mayor Flowers was against any discussion. "I don't share the same interest as my colleagues, I don't think it is best for the City. Flowers called for a motion to proceed in the discussion of dispensaries in sue, I want people to know you can't just the City; the motion passed on a 5-0 vote.

the two positions were "incompatible because the WRD and the city of Carson have overlapping territory, duties and responsibilities, and a clash of duties is likely to arise in the exercise of both offices simultaneously."

Robles lost the lawsuit and was forced to resign his WRD seat.

Initial Vote Last Week

The candidate voting occurred last week with each of the four Board members given three votes for a total possible vote count of twelve per candidate.

Former Carson Councilperson Elvira (Vera) Dewitt garnered seven votes total, with Division One Director Willard H. Murray Jr. giving DeWitt three votes, and both Division Four Director Sergio Calderon and Division Two Director Rob Katherman giving her two.

Yvette Martinez tallied five votes, two from Division Three Director John D.S. Allen, two from Katherman, and one from Calderon.

HMG-LCCN was told that Compton Councilman Isaac Galvan, who did not attend the meeting, received two votes, one from Calderon and one from Katherman.

Former Downey Mayor Luis Marquez tallied two votes, one each from Calderon and Katherman.

The remaining candidates received zero votes including Jim Dear, Central Basin Director Leticia Vasquez, and Pico Rivera Councilman David Armenta.

It was reported that Armenta did not at-

tend the meeting.

The Board will meet this Saturday for a final vote. HMG-CN has been told that leading candidate Yvette Martinez secured an endorsement from Vice Chair of the House Democratic Caucus Congresswoman Linda Sanchez.

Mayor Dear called for DeWitt to be arrested for assault, with Sheriffs arresting her after the meeting.

DeWitt was immediately released after her arrest.

Current Lakewood Councilman and Los Angeles Sheriff's Capt. Todd Rogers told the Daily Breeze about the hit, "It was an intentional act of violence against another person. We're investigating it as a

Asked whether Schaefer's reaction seemed delayed, Dear told the Breeze that Schaefer appeared "stunned."

"It looked like a senior citizen who unexpectedly got hit on the head by a hostile person," said Dear. "It upset her to the point where she actually fell forward and lost her balance and fell onto the ground due to the hit on the head."



A coyote education forum was held in the Royal Palm Room in La Palma to provide residents with information about coyotes and the best practices to use if and / or : when they enter your property.

- Never feed or attempt to tame coyotes. The result could lead to deadly conflicts with pets or livestock or serious injuries to small children.
- Although, chiefly nocturnal, coyotes are active both day and night. Do not leave small children or pets outside unattended.
- Install motion sensitive lighting around : the outside of the home or building.
- · Trim ground level shrubbery to reduce hiding places. • Be aware that coyotes are more active in
- the spring, when feeding and protecting their young.
- If followed by a coyote, make loud noises. If this fails, throw rocks in the animal's direction. Never run. This triggers 'the prey' sense in the coyote and they will follow you.
- Put garbage in tightly closed containers that cannot be tipped over.
- Remove sources of water, especially in : dry climates.
- Bring pets in at night and do not leave pet food outside, even bird attract rodents, which will in turn attract coyotes.

After going 3-7 for three straight seasons, Gahr High won eight games in back to back seasons. It was the program's best two-year span since at least 1998. But as head coach Greg Marshall enters his 16th season at the helm of the Gladiator's program, this one will certainly remind him of the one less than five seasons ago.

"Last season went pretty much the way it was supposed to go," Marshall said. "We got a new quarterback, so we didn't know what he could do. [But], everything went as scheduled once we figured what we could do offensively. We knew, defensively, we were going to be pretty good because of the kids coming back."

For the Gladiators to have the same success of the past two seasons, they will

have to do so with a relatively young and inexperienced team. Gahr had close to 30 seniors on the 2017 squad and will begin this season with 19 seniors, 12 juniors and nine sophomores.

OFFENSE

Gahr scored 383 points last season with most of those coming from the legs of running back Micah Bernard, now a senior. He is just one of three returning players on offense and it will take a lot for Gahr to scoring in bunches as it did the past few seasons. Gahr scored over 40 points four times and over 30 points three other times.

Bernard rushed for over 2,300 yards and found the endzone 25 times last season for a team that finished with over 2,800 yards on the ground and 30 touchdowns. Senior Evan Smith, junior Cochese Bradshaw and sophomore Andrew Simpson will join Bernard in the backfield. Marshall says the team will be more of a bubble and I-power team with Bernard in the backfield and will have to pass more than they did the past few seasons. He doesn't plan on running Bernard as much as last season, thus making it imperative for other players to step up if teams are going to key in on Bernard. Of the team's 371 carries in 2017, Bernard had 240 of them.

"He's picked it up; it's a new a system for him," Marshall said of Bernard. "We had to put a new system in because we don't have the line. We can't run what we ran last year, so, we have to install another offense."

The Gladiators will have a new signal caller as senior Jordan Simpson gets the job with senior Nathan Rhodes as the backup. Last season, Rhodes was three of right for 14 yards and an interception. The top wide receivers will be junior Aaron Okoro along with Brad-



shaw and Andrew Simpson.

Going from left to right on the line will be junior tackle Devan Coleman, senior guard Nathan Grande, junior center David Versteeg, senior guards Jason Blom or Danny Chinchilla and senior tackle Esteban Perez. Sophomore Anakin Larrabee could also play either right tackle or right guard. Marshall added that the offense will be more balanced passing to running.

"Pass protection is easy; it's the easiest thing you can do. If we can throw it, then we can teach our guys to protect against bigger guy," Marshall said.

DEFENSE

Last season, Gahr had three straight games in which it allowed no more than eight points. But, the defense tailed off towards the end of the campaign, allowing at least 28 points in the final five contests. Marshall, who is also the defensive coordinator, describes this season's defensive unit much like the one in a few seasons ago when Gahr won three games and had some players transfer out. There will be a lot of two-way players, so, with that said, the same offensive lineman will be the same on the defensive line with Grande playing nose and Coleman or Perez at one of the ends. The secondary will feature only one returning player from 2017-senior Kyle Veazie, who had 21 tackles. The cornerbacks will be junior Joaquin Camouche and one of the Nixon bothers, either Chandler or Chase, both sophomores, with the other one at safety. Junior Shane White and sophomore Kyle Nwosu will be outside linebackers while Smith is situated in the inside along with senior Justin Holland-Phillips.

SCHEDULE

Could this be the end of an era as it relates to the ABC Unified School District? Gone from Gahr's schedule are the yearly rivalry games with Artesia High and Cerritos High. The Gladiators had gone a combined 27-12 against those two since 1998, including the last 13 in a row against Cerritos.

"I don't like it," Marshall said. "I don't think it's good for the community, I don't think it's good for football, I don't think it's good for either of the programs. I don't see what the benefit of that is at all. But, that wasn't my choice; no one talked to me about it.

"I will never question someone trying to do something better for their program," he continued. "But I just don't see how not playing Gahr is bettering their programs. I don't get it. It makes for interesting football. What games do we have where people will come out just for the heck to go watch Gahr or Artesia or Cerritos? What games are there?

Those are the games. No one cares if we play Downey. No one cares if we play Paramount. The stands are empty; their people don't even come [to Gahr]. There's no connection, even though we've been in the league forever."

Marshall said this will be the toughest schedule he has ever faced, and that Millikan High will be like a San Gabriel Valley League game while the game against North Torrance High can go either way. He added that he thinks his team can compete with St. Anthony High. Either way, Gahr plays seven teams that advanced to the CIF-Southern Section playoffs last season. In addition, Gahr's two road league games are in the city of Downey, which has not been to hospitable for the Gladiators. Since 1998, Gahr is a combined 2-14 against Downey High and Warren High on the road.

"The league situation is just what it is," Marshall said. "You can come into the [league] season 4-1 or 5-0 and for Gahr High School to go into the San Gabriel Valley League and think you're going to win four or five more games is...I just don't think it's going to happen."

HOMECOMING

Gahr survived a 46-42 homecoming affair against Warren last season and is 5-9 in such games against San Gabriel Valley League foes since 1998. At time of press, Marshall wasn't sure if Gahr plays Dominguez High or Lynwood High for its homecoming game. Since at least 1998, Gahr has never played Dominguez for its homecoming game, but is 2-0 against Lynwood in such games and 11-5 against the Knights since 1998.

DIVISION

The Gladiators make a huge jump from Division 10 to Division 6 and go from 29 schools this season in Division 10 fighting it out for the 16 playoff spots to 22 schools in Division 6. Even with a young and inexperienced team, Marshall still likes his chances of making it to the playoffs. In fact, the Gladiators are barely out of Division 5, which also has 22 schools. Mayfair is the only opponent from the same division and the Gladiators are 1-5 against the Monsoons since 2000.

"That's a good thing, that it's only 22 teams in the bracket," Marshall said. "Because last year, with 37 [teams], even though we were third, a lot of third place teams didn't get in because there were so many first and second [place teams]. But we had a higher ranking."

The good news for the 2018 Cerritos High football team in its season opener against Western High is that they didn't get embarrassed like they did in last season's opener when the Pioneers routed the Dons 51-2. The bad news is Cerritos still lost badly in its opener last Friday night to the same Western team, this time by a 69-33 count at Dr. Hanford Rants Stadium.

Despite the blowout loss, Cerritos head coach Barry Thomas found more good things to take from the game than last year's meeting. For starters, senior running back Tve Anderson and senior

quarterback Stacy King combined to gain 172 yards on 28 touches and score the five touchdowns the Dons would have. Also, dating back to last season, Cerritos has combined to score 91 in its past three games.

"It's a character thing; it's nothing I taught or coached," Thomas said. "That's them deciding that they're not going to stop fighting. That's a tribute to them as a group."

The Dons were down 28-0 nearly 10 minutes into the game and had gained nine yards without getting a first down. At the same time, the Pioneers scored their second and third touchdowns on consecutive plays. But with 44 seconds left in the opening stanza, King scored on a three-yard run. Western, which scored on its first seven drives and had 468 yards total offense in the first half, scored four more times in the second quarter, twice by the air and twice by the ground.

Meanwhile, Anderson scored on a 45-yard run with 8:39 left in the second quarter and an 88-yard kickoff return with 1:09 remaining before halftime. And despite Western converting on all four if its fourth down plays in the half (six for the game), Thomas said his team did the fundamental things last Friday night as opposed to last season.

"Overall, I felt like we played pretty well against the run," Thomas said. "Again, numbers won't reflect that. But we played as far as doing what we're coached to do."

Anderson capped off the scoring for Cerritos late in the third quarter with a 17-yard run. But one of the game's headlines was King, who made his first varsity start. After going one of 14 for nine yards in the first half, he finished the game with eight completions and 75 yards. He also picked up 71 yards on the ground.

"That's just Stacy being Stacy," Thomas said. "He never got rattled, even when he wasn't connecting or if there was a drop. And I think that's because he played as a sophomore. Even though he played wide receiver, he got a little bit of time at quarterback. He played as a sophomore and that's huge. The stage wasn't too big as far as him getting rattled. So, that was a positive."

Sophomore cornerback Quibrantar led the Dons with 16 tackles. Also having big games, according to Thomas, were senior defensive linemen Daniel Gomez and Jacob Guzman (six tackles) and sophomore defensive linemen Jace Ramirez (11 tackles, one sack) and Will Reed on defense stood out



STAFF REPORT

As summer vacation comes to an end and children get ready to head back to school, the Downey Police Department is joining the California Office of Traffic Safety [OTS] and local school districts to remind parents and caretakers to exercise caution around schools.

It is a busy time for many families who are handling back-to-school preparations, but that should not surpass the importance of ensuring the upcoming school year is safe for everyone.

August is Back to School Safety month and the Downey Police Department urges parents, caretakers and the community to remember these important safety tips to kick off the new school year:

Plan your route ahead of time. If your child is biking or walking to school map out the safest route with safety spots to ask for help, best places to cross, and most direct path where the child won't get lost. Teach them about traffic signals and signs, urge them to not wear earbuds and to stop and look both ways before using crosswalks.

Always keep an eye out for children,

especially during pick-up and drop-off times. Avoid distractions such as texting, talking on the phone, grooming or eating while behind the wheel.

If your child takes the bus, remind them to line up five steps away from the curb and to always look out for cars before getting on or off the bus. Always buckle up. Practicing proper seat belt safety instills good habits that protect yourself and those you love. Look for school buses and know what to do when around them. Overhead flashing yellow lights means you should prepare to stop, overhead lights flashing yellow means drive with caution and overhead lights flashing red means stop.

Always use the crosswalk at an intersection with a stop light or sign and don't text while walking. Be sure to Stop, Look, Listen, and then cross. Obey all traffic laws, including following the posted speed limit, which is usually 25 MPH in school zones but may be as low as 15 MPG.

No matter how children go to school, it is important that everyone pays attention, looks out for one another and takes these necessary safety precautions.




