Armed with pro-Trump banners, rioters moved on the U.S. Capitol outnumbering and overwhelming the U.S. Capitol Police, charging up the Capitol steps, smashing windows, breaking into the Senate chamber and breaking into offices, including the one belonging to House Speaker

And the Senate minority leader Chuck Schumer said he will fire the Senate Sergeant-at-Arms, Mike Stenger when he becomes the Senate majority leader.

Pelosi Will Impeach

House Speaker Nancy Pelosi announced yesterday that Congress will impeach Trump if 25th Amendment not invoked.

Pelosi first called on the Cabinet to immediately remove President Donald Trump from office in the wake of the deadly violent protests at the U.S.

Capitol on Wednesday.

"I join the Senate Democratic leader in calling on the vice president to remove this president by immediately invoking the 25th Amendment. If the vice president and Cabinet do not act the Congress may be prepared to move forward with impeachment," Pelosi said

Why the police were not prepared and why it took them hours to drive them out will take a 9/11 commissions to find out.

The toll was substantial Four people died, including one woman shot in the chest by Capitol Police, blood still on the steps.

She was from San Diego identified by her husband who spoke to KTLA's sister station KSWB in San Diego.

She was 35-year-old Ashli Babbitt, with her husband saying, "She loved her country, and she was doing what she thought was right to support her country in joining up with like-minded people that also love their president and their country, she was voicing her opinion, and she got killed for it."

The other three died on the Capitol grounds from

Norwalk Mourns Passing of Former Mayor Luigi Vernola

Norwalk, CA—It is with great sadness that we announce the passing of former Norwalk Mayor, City Councilman, Planning Commissioner, businessman, philanthropist, family man, friend and neighbor, Luigi Vernola. Luigi passed away on New Year’s Day at the age of 76. He left behind his beloved wife of 56 years Joan, his son Thomas J. Vernola, and his daughters Lisa M. Vernola-Salas and Kristina A. Vernola-Freesmeier, in addition to, 11 grandchildren and three great-grandchildren.

Luigi’s parents, Tomas and Marta Vernola immigrated to the United States from Italy, and eventually settled in Norwalk. Raising three sons and a daughter in Norwalk, they instilled values that Luigi always based his life on; education, hard work, be a provider for your family, and always give back to your community and church. He received his education in the Norwalk School District, graduating from Norwalk High School in 1964. While a student at Norwalk High, Luigi met his future wife, Joan Yacobowich. They married in 1965 and remained residents in Norwalk, where they raised their children. At the age of 20, Luigi purchased his first service station, the first of many, including garages and a towing service.

Luigi started his public service in the 1980’s when he was appointed to the Norwalk Planning Commission, a job he genuinely enjoyed, as it was instrumental in the growth and beautification of Norwalk. In 1987, during a special election, Councilman Cecil Green was elected to the California State Senate, leaving his council seat vacant. Luigi was appointed by the remaining members of the council to fill the vacant seat until a

new member could be elected. He was proud to fill the temporary seat and eventually ran for, and won, the seat in the general election. Luigi chose to run for City Council because he, like other Norwalk residents, believed Norwalk’s best days were ahead. He faithfully served the City from 1987-1994. As a local businessman, he knew firsthand the responsibilities of running a successful company and city. He made fiscal accountability his top priority. As a Councilman, he was always committed to public safety and community engagement as crucial components to

the health and success of Norwalk. Luigi would later serve again on the Norwalk City Council from 2011-2020.

Time and again, Luigi demonstrated his dedication to the city he loved. He founded and co-founded several nonprofits to promote worthy causes, both in the city and around Los Angeles County. One such nonprofit was the Santa Sleigh Foundation, which was exceedingly special to Luigi. As part of this program, Luigi would host a breakfast event wherein children could eat breakfast and visit with Santa Claus, while also receiving a gift. During the

Thanksgiving and Christmas holidays, Luigi would give out over 600 turkeys and other food to senior citizens and families throughout the community. He also initiated The Friends of the Norwalk Sheriff’s Station, an organization that helped the families of our law enforcement community, who had loved ones injured or killed in the line of duty. Shortly after 9/11, Luigi had a monument erected and dedicated to the first responders of our area. He placed life-size statues of a firefighter, deputy sheriff, California Highway Patrol officer and one of Norwalk’s own public safety officers. He also placed a tableau that is located on the north/east corner of the City Hall lawn, with a bench facing the statue so that people can sit and show gratitude to our hometown heroes. He also helped establish the Hometown Heroes Banners that line our streets to honor our local servicemen and women. Over the years, Luigi strived to make Norwalk’s motto a reality and help make it “A Connected Community.” Luigi Vernola was truly a man who loved his family, city, and country. He will be greatly missed.

Norwalk, California, incorporated in 1957, ranks as Los Angeles County’s 14th largest city with 106,000 residents and 3,000 businesses. Located between downtown Los Angeles and Orange County, Norwalk is home to the County Superior Court, Registrar’s Office, Regional Library, Sheriff’s Station, Transportation Center and Cerritos College. Cerritos Company Blatantly Violating COVID Orders

A website that shows citations given out by the Los Angeles County Department of Health for COVID violations indicate that five companies in Cerritos have been cited for health violations. Citations issued to companies due to lack of compliance with Health Officer Order include Club Pilates on South St on October 9, 2020; It's a Grind on South Street on December 18, 2020, Sisters Korean Kitchen on Bloomfield on October 16, 2020 and UPS on Moore

St in September 2020. All were cited just once. But one company's blatant violations could catch the attention of Cerritos officials, Crunch Fitness on Del Amo. The gym apparently does not care about customers or those who could be infected by their customers getting cited in 2020 on August 29; September 5, 17, 19; October 10, 21; November 2, 17, 23 and 12/13; 10 times in four months. Also obvious is that the LADPH does not have a maximum amount of citations before mandating closure.

Asm. Garcia's Annual 'There Ought to be a Law'

With a goal to educate and engage constituents, Assemblymember Cristina Garcia has held a contest, ‘There Ought To Be A Law’ every year. Any resident within the 58th District can submit an idea that they believe should become law in California and Garcia, her team and the chosen winner will travel to Sacramento to participate in the law making process throughout the legislative session.

Entries can touch on a wide range

of issues that can be addressed by legislation to improve the quality of life for our district and throughout California. Applications must be submitted online by Friday, January 15, 2021 at 5 pm.

In 2016, and proposed by fifth grade class at Bell Gardens Elementary School, Assembly Bill 146 encourages that the "Mexican Repatriation," the unconstitutional deportation in the 1930's of over 1 million U.S. citizens and lawful residents of Mexican descent in California, was included in student history textbooks and studies. The year prior a submission by Sally and Ron Hoyt, from Bell Gardens, was introduced as Assembly Bill 1596, requiring all completed vote-by-mail applications be mailed directly to the county registrar's office and not to middlemen or political campaign organizations.

“The contest is open to residents of the 58th Assembly District, and I encourage people of all ages to enter, including school aged students,” remarked Garcia, “We will select at least one proposal to introduce this year. In previous year our contest winners have had their bill introduced and signed into law.” Previous winners have had the opportunity to travel to Sacramento to testify at committee hearings in support of the legislation. “Although this year may require us to continue working remotely, we are still excited to hear from you and introduce a new idea authored by one of our residents.”

Garcia has a team of representatives that can lend a helping hand. They can help navigate and connect residents to meal services, unemployment insurance, remote learning and various other services.

Meals on Wheels Holding Steady During Pandemic

In a time of greater food insecurity, Meals on Wheels of Orange County serves as a lifeline for seniors and their families now impacted by COVID-19.

“The need among our most isolated and vulnerable elderly neighbors has skyrocketed since the Stay-at-Home Order issued in March,” said President & CEO Holly Hagler, who has worked at Meals on Wheels O.C. since 2010.

“Demand continues – we haven’t seen a decline in the number of meals or people served,” she added. “There will be no return to ‘pre-pandemic’ numbers. We’re now producing about 9,000 meals a day – nearly triple our rates from before the outbreak.”

The demand is so great that Meals on Wheels O.C. has had to rent additional freezer containers to store meals before distribution throughout the community.

“Prior to the pandemic, we served nearly a million meals a year to more than 10,000 at-risk seniors,” said Hagler. “Because of the pandemic, we’re serving

as many as 20,000 older adults and have provided more than 2 million meals since March 2020. That is about 45,000 meals each week that continues to be needed by our older adult neighbors.”

“To meet the exploding demand which began in March 2020, we increased the number of homebound older adults receiving three meals a day, 5 days a week through our traditional home-delivered Meals on Wheels,” she said.

In just a matter of days when the pandemic began, Meals on Wheels O.C. completely retooled their Lunch Cafés, which normally provide hot nutritious meals and socialization at 23 community centers in 20 partnering cities. They went on to provide a weeks’ worth of frozen “Grab & Go Meals” for curbside pickup at local community centers, according to Hagler.

“Thousands of older adults in our community live with food insecurity, not knowing where their next meal will come from,” she explained. “They didn’t know about Meals on Wheels Orange County until COVID-19 hit and they will continue

needing nourishing meals and services beyond the pandemic.”

This is true for people like Wahida and her husband, who recently shared with Hagler, “No one was prepared for this to happen, but Meals on Wheels O.C. has been a blessing. They are delivering food to both of us and it is good! Without them, we just don’t know how we’d survive.”

The mission of Meals on Wheels O.C. is to nourish the wellness, purpose and dignity of older adults and their families in their community. They do this by delivering meals and supportive services through their Meals on Wheels, Lunch Cafes, Adult Day Services, and other programs.

“I love being part of our great mission at Meals on Wheels OC to nourish older adults in our community,” said Hagler, whose parents worked in the nonprofit sector and always stressed the importance of purpose and helping others. Although she worked in for-profit business for much of her career, while earning her MBA at night, she wanted to make a greater impact like what her parents valued.

“I made the move to the nonprofit sector more than 15 years ago and haven’t looked back,” she said.

“Here at Meals on Wheels O.C., we will continue to find innovative ways to serve meals, kindness, love and hope to those who spent their lives doing the same for our community,” Hagler said. “All of this has been possible through the generosity of our community – who continue to volunteer and make financial contributions.”

Hagler added that the nonprofit has an incredibly passionate team and Board of Directors who are dedicated to their purpose. She added, “It is wonderful to work alongside them to be of service in such a meaningful way.”

Meals on Wheels O.C. primarily serves adults age 60+ in the 20 cities of central and north Orange County, including Cypress, Buena Park, and La Palma. They distribute meals through partnering with community centers and through their volunteers, who deliver meals—and the warmth and connection of a friendly visit—to those who are homebound. Their

nutritional balanced meals are developed by a registered dietician and are prepared in their 22,000 square foot community kitchen in Anaheim, according to Hagler.

In recognition of Orange County’s ongoing response to serving their most vulnerable elderly citizens during the pandemic, Meals on Wheels O.C filmed a short documentary, Step Up to the Plate: Our Community in Action, which can be viewed by visiting their website at www.mealsonwheelsoc.org. More information about their various programs, locations they serve plus information on how to donate or volunteer can also be found online as well.

“As a nonprofit, we are dependent on the generosity of folks right here in Orange County, as well as support from our county and city partners,” she added. “We really cannot overstate the importance of our community in continuing this critical work, especially as food insecurity grows due to the financial strains of the pandemic.”

house to house singing, seeking shelter for the night, answered by those indoors in song. At the third home the peregrines or pilgrims are welcomed inside to pray, eat and celebrate. Traditionally in Mexico, pilgrims would eat the regional style of tamales with champurrado.

Norwalk invites you to join their virtual Posadas from the comfort and safety of your own home, school, parish or workplace. Virtual Posadas will honor the traditional celebration, and invite viewers into an experience of music, art, prayer, reflection and action as you virtually journey with the pilgrims in search of shelter and protection.

unspecified "medical emergencies."

More than 50 people were arrested, at least a dozen police were injured, and officers confiscated guns, pipe bombs and Molotov cocktails.

It all started with Trump who spoke at the Ellipse, a park between the Mall and the White House inciting the crowd, including members of far-right groups, with unsubstantiated claims of a stolen election.

Trump then encouraged them to march to the Capitol, where Congress is sitting, to protest.

Trump says he will "walk with them to the Capitol," but as the protestors leave, he returns to the White House to watch events unfold on television and tweet.

The mob tears down barricades , pushes past Capitol police, climbs a wall and charges the Capitol itself.

Pushing through the remaining police officers, they break into the building through the front door.

The rioters are now inside the Capitol building. To the left is the Senate chamber, to the right is the House of Representatives, with the Rotunda in the middle.

As they run through the Capitol, parts of the building are locked down.

Police lock the doors of the House chamber, barricading entrances and issuing protective "escape hoods".

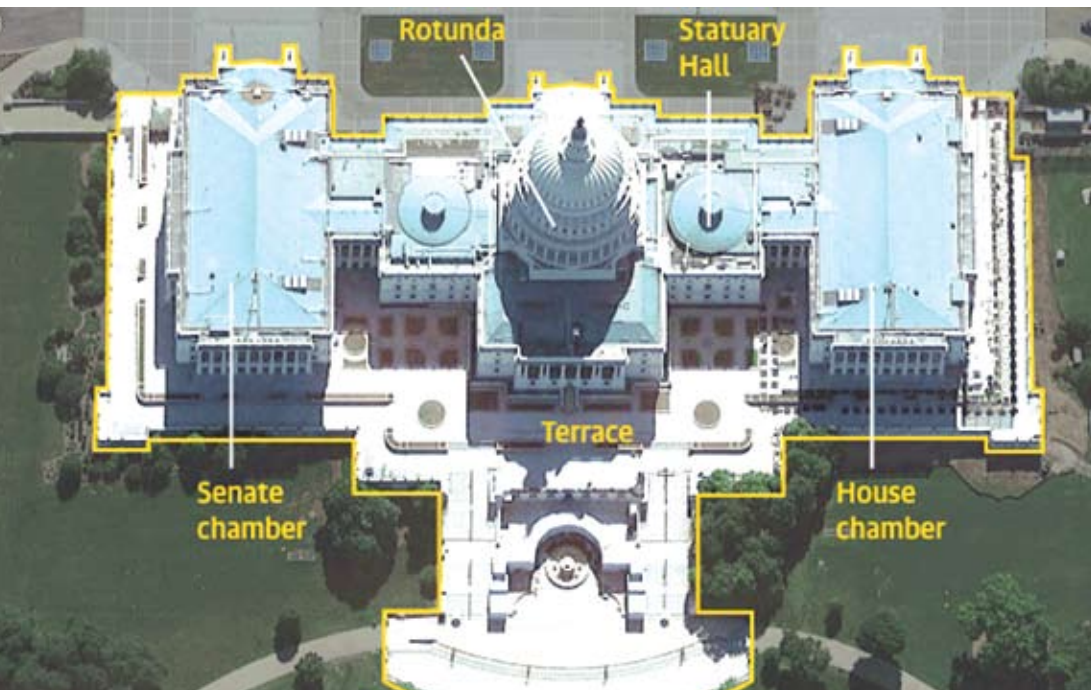

on the chamber's door.

Fearing for the safety of lawmakers, police move into evacuation mode while others hide in their offices.

Reports emerge that shots have been fired inside the Capitol, later reported the death of Babbitt.

Later pictures posted on social media show the domestic terrorists on the floor of the Senate chamber with one sitting at the dais.

Some who will likely be arrested by the FBI are seen in lawmakers' offices, including the House speaker Nancy Pelosi's office.

Finally around 3 p.m., armed police begin to gain control of the complex using pepper spray, flash-bangs and making arrests.

It's nearly 6 p.m. when officials declare the Capitol complex "secure" the occupation is finally brought to an end by heavily armed officers. Lawmakers applaud.

Condemnation of Trump's role in inciting the riot comes quickly. Social media companies, concerned about the prospect of more violence encouraged by Trump, freeze his social media accounts.

At 8 p.m. Congress gathers to resume counting the electoral college votes. Multiple Republican senators who supported objection suddenly reverse course saying they will not object to the certification of Biden's election victory.

Fall Sports Season Remains in Limbo for Area Public Schools

As the area public high schools resumed online learning earlier this past week, the waiting game for fall season athletics continues as it has not yet commenced. Per the 2020-2021 fall season calendar that the CIF-Southern Section released on July 20, boys volleyball was to have begun on Dec. 12, but on Dec. 18, the CIF-SS moved the sport to the spring season.

Girls volleyball was to have started on Dec. 19 with boys and girls water polo beginning their seasons on Dec. 21 and Dec. 28 respectively and boys and girls cross country on Dec. 26.

Conditioning for the fall sports began on Nov. 2 but was shut down last month as the number of COVID-19 positive cases continues to spike at a high rate. Most of the state remains in the purple tier as we head into the early part of January and many are wondering how much longer the fall season will be delayed or if it will completely be cancelled.

This past Monday, the California Department of Public Health was to have reassessed and evaluate its plan of having athletes return to competition on Jan. 25, which it has not done at time of press this past Wednesday. On Jan. 19, the CIF-SS will have an update on plans for its fall sports championships, which are scheduled anywhere from Mar. 6 for boys water polo to Apr. 9 for 11-man football.

“Based on what was taking place with the COVID numbers increasing, I think our district had to make the call,” said John Glenn High co-athletic direc-

tor Linda Parra on suspending the conditioning activities.

She said that the cheer, cross country, football and volleyball teams had been conditioning two to four times a week at Glenn, but at different times during the day, and with each sport entering and exiting at different gates. Each sport had pods of no more than 10 athletes. Cross country and volleyball would be conditioning first, followed by cheer and football in the evening. Glenn began its conditioning the second week of November and Parra said initially, the numbers were in the 20s for girls volleyball, which is low because usually they are around 45. However, that number had dipped to between 10-15 because the lower level volleyball athletes were not showing up.

Parra cites factors at home for the low numbers and added that even though the school was following every protocol and doing everything the right way, some parents didn’t want their daughter coming back for conditioning because they didn’t feel comfortable.

“We haven’t seen our kids since March, and so factors of laziness set in,” she said.

On July 21, the athletic directors of the 605 League, which has Artesia High, Cerritos High, Glenn, Oxford Academy, Pioneer High and Whitney High as its members, approved its league schedules for each sport. However, with boys volleyball now moved to the spring, and the uncertainty that the first girls volleyball league match, which was will be held today (Whitney at Oxford) or Tuesday for everyone else was going to go on as planned, the prospects of having a full league season are slim to none.



Parra said that there have been multiple conversations as athletic directors along with the principals regarding wanting to have the athletes prepared. They talked about missing a few league matches just to give the players an opportunity, if they were cleared to do so, to have a real practice before jumping into the matches.

“Our hope has always been that we could get at least the second round of league in play,” Parra said. “That’s something that we have discussed.”

The league schedule for volleyball is set up so that everyone plays two matches a week. The idea of possibly adding another league match a week to make up for lost matches not played from Jan. 12 to Jan. 26 was never mentioned. Instead, Parra said that that the concern from the athletic directors has been about the athletes not being able to be inside the gymnasium to practice at this point.

She added that if there was a chance

the athletes could get back in the gymnasium in the next few weeks, the 605 League would use the first round matches as non-league events instead of having to reschedule non-league opponents that had been on the original schools’ schedules.

As far as the other three fall sports that have league events, the first league cross country meet isn’t until Jan. 27, the first league boys water polo event (for Artesia, Cerritos, Pioneer and Whitney only), isn’t until Feb. 2 and the first league football game isn’t until Feb. 25-27.

The league did make one change involving its two cross country cluster meets (Jan. 27 and Feb. 15) and the league finals (Mar. 3). All three will now be held at Cerritos High as the league couldn’t get Cerritos Regional Park or La Mirada Regional Park to sign any permits to have the events there.

The waiting game has been difficult for everyone involved because what may look optimistic today or tomorrow could quickly turn dire later in a week or the following week. Trying to schedule and reschedule events and plan accordingly has been taxing for the athletic directors, coaches, principals and student-athletes.

“If you talk to any athletic director or coach, that’s been the biggest obstacle because we’re planners and we like to know...we plan a whole year ahead,” Parra said. “That’s just the nature of how we think. Now, we don’t even know what tomorrow is going to bring because there hasn’t been much discussion yet. That’s where it’s like, okay, just remember to stay patient and not get too much anxiety of what’s going to happen because really, there hasn’t been any conversation.”

As far as football goes, Parra believes the best case scenario to begin playing won’t be until February. Since four of the six league schools field football programs, that would mean there would be three league contests for that sport and Parra said the league could potentially get those games in if ‘miracles happen and the numbers go down quickly’.

Then there is the thought in the back of everyone’s head that the entire fall season would be wiped out. She commended her coaches for remaining realistic and taking everything in stride and added that there hasn’t been any grief when the school had to shut down conditioning.

“We’re hopeful for a season, but at the same time, we’re expecting that we might not have a season,” Parra said.

Parra said that the league athletic directors meet the first Thursday of every month and the second Thursday of every month is typically when the athletic directors and principals meet. She is also quick to say that even though the CIF-SS

may give the green light to play games at any given date, that doesn’t mean that the Norwalk-La Mirada Unified School District will grant the same for Glenn, La Mirada High or Norwalk High.

“I think the Norwalk-La Mirada School District is very cautious,” Parra said. “It’s not just CIF, it’s CIF plus what our school district is going to say, which is governed by the [Los Angeles Unified School District] and the state.

“Our district won’t move forward until they get the green light from L.A. County,” she later added. “And they do take into factors what CIF is saying. So, they’re following very closely what CIF is saying; they know what the updates are for high school sports. But again, it’s really hard to say, ‘you know what, we’re going to play games, but we don’t have kids in the classroom’.”

In closing, Parra would like to let her student-athletes know that as athletic directors, coaches or anyone else who works at Glenn, they are trying to provide hope to the kids that things will get better. They just don’t know when it will get better. She continued by saying that it will be interesting to see when the NL-MUSD is going to meet with the administrators to tell them what they will be allowed to do, either this month or next month.

It’s a different story for Valley Christian High, which is not bound by any school district. Athletic director Dan Leffler said that its fall season athletes have been conditioning since the summer while following strict protocols and the first girls volleyball match is slated to take place tonight when the Lady Defenders host Central Valley Christian High. Once again, just like at any other school, public or private, it’s all volun-

tary as far as athletes returning to conditioning.

“We actually see some kids on campus in pods, Monday through Thursday, in small groups,” Leffler said. “So, that’s kind of where we’re at. From an academic learning standpoint, it’s all voluntary. Obviously, we’re doing this all with proper protocol; six feet in classrooms. We have a bunch of new equipment inside there for us to be able to do Zoom and do all those things for kids who are not on campus. That’s a piece of the puzzle we added recently. We were pretty much remote up until right around Thanksgiving time, and then we went to this pseudo-hybrid with small groups in pods.”

Leffler couldn’t pinpoint an exact percentage, but he did say that a high percentage of students at V.C. are doing their classwork remotely and they do have the option of doing it remotely or coming to school. According to the practice schedule for the fall season sports at V.C. that was posted on its athletic website in the summer, girls volleyball was able to begin its practice on Aug. 10 with cheer, cross country and football beginning on Sept. 9. In addition, boys and girls basketball, which is in the spring season, began practicing on Aug. 12 and 24 respectively. Boys volleyball also started its practices on Aug. 18.

“We feel like we have a pretty good

protocol,” Leffler said. “We monitor everybody closely. So, we’re preparing like we’re going to play a game eventually someday when that information breaks and they tell us when the season actually is going to start. We feel like there’s a tremendous amount of mental stability in that for our student-athletes. So, we get them out here and do some speed and agility and try to stay in shape.”

There are four touchpoints at the high school where the athletes enter and the coaches do all the monitoring with temperature checks, according to Leffler. There’s an extensive spreadsheet for tracking purposes in the event they need to go back and trace for close contact. V.C. also does not allow anyone on campus who is not a student-athlete or credentialed to work at the school.

As it relates to the Olympic League master schedule for V.C., Heritage Christian High, Maranatha High, Village Christian High and Whittier Christian High, Leffler said there have not been any alterations for the fall sports since league events don’t begin until February. The only worries V.C. had, according to Leffler, was for its non-league events. He added that “all systems are go” for the Defenders to play in February assuming that the schools in the Olympic League are entertaining playing regardless of what the situation looks like.

Leffler said that the league athletic directors have Zoom meetings every week, a main reason why he feels they

are moving in the right direction. One of the negatives that the league has is that V.C.’s football stadium is the only one that has lights. The other four league schools rents from other facilities at public schools. Because of that, that puts a burden on Leffler to decide if V.C. is going to host all four Olympic League game or not.

“Up to this point, we’re all committed to doing that; to seeing our Olympic League schedule through,” Leffler said. “Right before [winter] break, we had our last Zoom meeting and we’re going to meet [Jan. 5]. There are a couple of schools who are on the fence, to be honest, to say, ‘hey, I’m not sure that administratively they’re going to let us pull this off’. I’ve got the full support of our head of school Superintendent to try to do this in a safe way and play games.”

The league has proposed the idea of moving the football games to Saturday afternoons as well as other options. The main thing is that the league is going to do everything it can to try to play its league schedule.

As of press time this past Wednesday, the girls volleyball team was on track to play Maranatha on Jan. 14 in the league opener. Originally, it’s scheduled as a road match, but the Lady Defenders would be ready to host the Pasadena-based school if it is unable to have sporting events on its campus.

Regarding spectators at the sporting events, Leffler said that it’s going to

be more of a universal decision from a league standpoint so that everyone is on the same page. With that said, two parents per players would be allowed in the gymnasium for volleyball. The league, which operates three levels of volleyball, would clear the gym following each level before letting parents enter for the next level’s match. Even for non-league matches, that would be the format that V.C. would use. Once the gym is cleared after a match, the bleachers would be wiped down before the beginning of the next match.

In terms of the numbers for the fall sports, V.C. has not seen a decrease and in fact, Leffler said this has been one of the stronger years for student-athletes coming out for football, whether it’s been for junior varsity or varsity. He said when everyone is at practices and the program is running about 48-56 players, which is a little bit higher than what the school is used to. Originally, the program had 61 players, but some decided not to play for non-COVID reasons. For the girls volleyball program, the numbers remain as strong as it always has been with 36 in the program for all three levels. Leffler said that 56 players tried out for volleyball during the summer. For boys and girls cross country, there are 25 in the program, which is lower than in the past.

The only fall sport that V.C. will not have for the 2020-2021 season is gym-

domestic terrorists has angered US politicians and former law enforcement officials wondering how police allowed the invasion to occur.

As members of Congress and Mike Pence were certifying the votes of the presidential election inside, a large group of pro-Trump domestic terrorists , encouraged by the president, marched on the Capitol.

Many scaled flimsy fences, made it past police and into the Capitol as everyone fled to secure rooms.

The domestic terrorists ransacked offices and posed for pictures on the Senate dais.

The incredible breach has drawn sharp criticism of the US Capitol police, and deservedly so.

Videos and pictures showed officers standing by as the domestic terrorists rushed past them, with one officer even posing for pictures with the invaders inside the building. The mob was later allowed to leave the Capitol largely unhindered, with one elderly Trump supporter helped down the steps by a police officer.

The pictures and videos were in stark contrast with anti-racism protests across the US last summer, where largely peaceful protesters were subjected to teargas, rubber bullets, beatings with batons and mass arrests.

Mondaire Jones, a newly elected congressman, called for a full investigation of the security breach on Wednesday and said that if the rioters “had been Black, they would have been gunned down before they got inside the Capitol”.

The Capitol police were apparently not prepared for the attack, with the force outnumbered and not wearing any sort of riot gear.

This left police unable to protect the approach to the Capitol and the many doors and windows of a building originally completed in 1800.

The police did not do their duty, despite weeks-long planning of the invasion by rightwing extremists seen on social media platforms such as Parler.

Heads need to roll starting with Chief Sund.

Pelosi said he could do further harm to the country.

“Any day can be a horror show for America,” she added.

Democrats and some Republicans want Trump removed before his term ends on Jan. 20 with Democrat Joe Biden’s inauguration.

The 25th Amendment allows for the vice president and a majority of the Cabinet to declare the president unfit for office.

Cabinet member must be confirmed and cannot be "acting" which narrows the number of votes needed to send to Congress for a two-thirds vote.

The vice president then becomes acting president.

nastic because of several reasons. V.C. competes in the Moore League for gymnastics and the other schools are also not going to do gymnastics, meaning the Lady Defenders wouldn’t have anyone to compete against. Also, there wouldn’t be any facilities open for V.C. to practice.

In closing, Leffler wanted to let everyone realize that the school takes this entire situation very seriously and has the upmost respect for the protocol and things that need to happen when bringing student-athletes on campus.

“Obviously, we’re in a very fortunate spot being here at Valley Christian, and it’s not tied to a specific school system or district,” Leffler said. “That gives the flexibility for our Board of Directors as well as our head of school as well as our community to make those decisions. We don’t do this going in blind.

“We do extensive surveys with our families; our community to make sure that everybody is on the same page,” he continued. “I think that needs to be noted, that we go ahead and try to get our community actively involved to say, ‘hey, is this something you would like entertained and do you want to do this and if you don’t, it’s optional’. There’s no penalty here. We’re just creating opportunities for our kids to do something else outside of sitting in front of a screen.”

The top 10 counties on the FEMA index include three in Southern California.

(AP) The Federal Emergency Management Agency has calculated the risk for every county in America for 18 types of natural disasters, including earthquakes, hurricanes, tornadoes, floods, volcanoes and even tsunamis. And of the nation’s more than 3,000 counties, Los Angeles County earned the highest ranking in the National Risk Index.

Having lived her life in Los Angeles, Morgan Andersen knows natural disasters all too well. In college, an earthquake shook her home hard. Her grandfather was affected by recent wildfires in neighboring Orange County.

“It’s just that constant reminder, ‘Oh yeah, we live somewhere where there’s natural disasters, and they can strike at any time,’” said the 29-year-old marketing executive.

FEMA’s top 10 riskiest places, in addition to Los Angeles, are three counties in the New York City area — the Bronx, New York County (Manhattan) and Kings County (Brooklyn) — along with Miami, Philadelphia, Dallas, St. Louis and Southern California’s Riverside and San Bernardino counties.

The way FEMA calculates the index spotlights places long known as danger spots, such as Los Angeles. But there are also plenty of surprises.

For instance, East Coast cities such as New York and Philadelphia rank far higher in terms of the risk for tornadoes than Tornado Alley stalwarts Oklahoma and Kansas.

And the county with the biggest coastal flood risk is one in Washington state that’s not on the ocean, although its river is tidal.

Those seeming oddities occur because

FEMA Ranks Los Angeles County Riskiest in the Nation



THE FEDERAL EMERGENCY MANAGEMENT AGENCY has calculated the risk for every county in America for 18 types of natural disasters, including earthquakes, hurricanes, tornadoes, floods, volcanoes and even tsunamis.

FEMA’s index goes beyond how often disasters strike. It also considers how many people and how much property are in harm’s way, how vulnerable the population is socially and how well the area is able to bounce back — in other words, how bad the toll would be.

That results in a high-risk assessment for big cities with lots of poor people and expensive property that are ill-prepared to be hit by once-in-a-generation disasters.

Take tornadoes. FEMA’s top five riskiest counties for twisters are two boroughs in New York City, Philadelphia, St. Louis and New Jersey’s Hudson County. The county that includes Oklahoma City — which has experienced more than 120 tornadoes since 1950, including one that killed 36 people in 1999 — ranks 120th.

In New York, people are far less aware of the risk and less prepared — and that’s

a problem, said Mike Grimm, a FEMA official who has specialized in risk management. The day before he said that, New York had a tornado watch. Days later, the National Weather Service tweeted that in 2020, several cities, mostly along the East Coast, had more tornadoes than Wichita, Kan.

In general, Oklahoma is twice as likely to get tornadoes as New York City, but the damage potential is much higher in New York because there are 20 times the people and nearly 20 times the property value at risk, FEMA officials said.

“It’s that risk perception that it won’t happen to me,” Grimm said. “Just because I haven’t seen it in my lifetime doesn’t mean it won’t happen.”

That sort of denial is especially true with frequent and costly flooding, he said. It’s also why only 4% of the population has

federal flood insurance when about one-third may need it.

Disaster experts say people have to think about the big disaster that happens only a few times a lifetime at most but is devastating when it hits — Hurricane Katrina, Superstorm Sandy, the 2011 super outbreak of tornadoes, the 1906 San Francisco earthquake or a pandemic.

“We’re bad at taking seriously risks that happen only infrequently,” said David Ropeik, a retired Harvard risk communications lecturer and author of “How Risky Is It, Really?” “We simply don’t fear them as much as we fear things that are more present in our consciousness, more common. That’s ... disastrous with natural disasters.”

Something like FEMA’s new index “opens our eyes to the gaps between what we feel and what is,” Ropeik said.

By the same measurement, Loudoun County, a Washington, D.C., outer suburb, has the lowest risk of any county, according to FEMA. Three other Washington suburban counties rank among the lowest risks for larger counties, along with suburban Boston, New York’s Long Island, suburban Detroit and Pittsburgh.

Some of FEMA’s risk rankings by disaster type seem obvious. Miami has the highest risk for hurricanes and Riverside County for wildfires.

Himanshu Grover, a risk expert at the University of Washington, called FEMA’s effort “a good tool, a good start.” But he also said it had flaws, such as final scores that seem to downplay disaster frequency.

This new tool, based on calculations by 80 experts over six years, is about “educating homeowners and renters and communities to be more resilient,” Grimm said, adding that people shouldn’t move into or out of a county because of the risk rating.
