



EXCLUSIVE: Civilian Grand Jury Investigating Metro Execs and Board of Directors' Actions

Metro CEO, L.A. County and City Elected Officials and Supervisors are implicated in the complaint.

Hews Media Group-Cerritos News has received a redacted complaint dated June 26, 2020 by a whistleblower accusing Los Angeles County elected officials, L.A. City elected officials, LA Metro Board Members and Executive Leadership of fraud, waste, abuse, and corruption.

The person or persons who filled out the complaint form received a letter two months later in August from a representative of Los Angeles County's Civil Grand Jury acknowledging

the receipt of the complaint and stating a grand jury will investigate the claims.

In February of this year HMG-CN first reported that the L.A. D.A.'s Office of Integrity was investigating Metro CEO Phil Washington and search warrants were served on the Los Angeles offices of Metro and Peace Over Violence.

The wide-ranging investigation also included a who's who of high profile government officials in Los Angeles.

Both the D.A.'s office and Metro's Communication Department did not deny the existence of an August email from Alan Yochelson, head of the D.A.'s Office of Public Integrity.

The next day, HMG-CN

Filipino Attacked at Knabe Community Regional Park

During the pandemic, the Hawaiian Gardens Food Bank, sponsored by The Irving I. Moskowitz Foundation, owners of the Bingo Club in Hawaiian Gardens, stepped up its usual operation providing free food and fresh produce, and any other donations available, to low income families, unemployed, disabled, and the homeless in Hawaiian Gardens and surrounding communities.

Food Bank Manager Leticia Macias and Purchasing Agent Melisa Halloran became increasingly busy as the pandemic spread, serving nearly 2,000 families with food every month.

Families receive a bag of USDA goods such as rice, beans, pasta, canned vegetables, canned fruit, and other items and are limited to two visits per month, or every other week. The distribution is held outside the food bank with distributors practicing proper hygiene and social distancing.

But there is many other services the Food Bank provides to area residents and companies that many do not know about.

Not only do they provide necessary items to families, registered residents can also obtain a voucher for bread, milk or eggs, canned goods, and a large bag of fresh produce to use at a local grocery store.

"I don't know what I would do if the food bank was not there," said one resident who

did not want to be identified, "it really helps me and my family, giving out food and other items every month to people like us."

The Food Bank also provides healthy snacks and fresh fruit to several after school programs such as the Migrant Program and the Red Cross Club, while also holding a "Toys and Turkey's" event for the holidays.

Knowing that low income families need other items, the Food Bank partners with Macy's and other stores to obtain clothing and essential items to distribute.

"To not have to spend money on clothing every month is a real help," said the resident, "I can use the money elsewhere, like for my rent."

In addition, the Food Bank, in collaboration with the with ABC School District, holds citizenship classes for community members who are seeking U.S. Citizenship.

The program was first proposed by current ABCUSD Trustee Chris Apodaca, who represents Hawaiian Gardens, with the classes conducted at the ABC Adult School in Cerritos.

Management even partnered with the American Red Cross to distribute smoke alarms to the community.

Running the Food Bank is Manager Leticia Macias and Purchasing Agent Melisa Halloran, they are the face of the Food Bank and provide crucial experience in operating the organization.

Macias told HMG, "Funding for the Hawaiian Gardens Food

Supreme Court Upholds Obamacare for 3rd Time, Preserving Coverage for Millions

Alito and Trump appointee Gorsuch dissent, while Kavanaugh and Barret join the majority.

For the third time, SCOTUS has dismissed a challenge to the Obama era health care law, preserving insurance coverage for millions of Americans.

The justices, by a 7-2 vote, left the entire law intact yesterday.

They rightly ruled that Texas and other Republican-led states had no right to bring their lawsuit in federal court.

The law's major provisions include protections for people with pre-existing health conditions, a range of no-cost preventive services and the expansion of the Medicaid program that insures lower-income people, including those who work in jobs that don't pay much or provide health insurance.

Also left in place is the law's requirement that people have health insurance or pay a penalty.

Congress rendered that provision irrelevant in 2017 when it reduced the penalty to zero.

The elimination of the penalty had become the hook that Texas and other Republican-led states, as well as the Trump administration, used to attack the entire law. They argued that without the mandate, the rest of the law

70-year-old retired Filipino health worker and Cerritos resident Cesar Echano and his wife were about to enjoy their weekly Saturday morning walk in Don Knabe Community Regional Park, when something all too familiar occurred.

As they emerged from their car, the two were verbally-assaulted by a man in his 20s who yelled at them to "go back to their country."

"I don't know why but he confronted us," Echano said. "He was laughing and asking me what he was looking at. I kept my head down and walked away. Then he started yelling a lot of profanity."

Fearing that he may be armed, the couple returned back to their car while the abuser continued with his profanity. As he got into his car, the assailant yanked open the door where Echano was sitting and began beating him.

"I just saw fists," he said. "It happened so quickly. I tried reaching for my phone to take a picture of him, but I couldn't get to it."

The suspect fled, and the wife drove off.

A few blocks away, the couple called the Sheriff's department

should fall, too.

And with Trump's crony SCOTUS majority, opponents of Obamacare hoped they would finally kill off the law.

But the third time was not the charm, with a majority of the court rebuffing the effort.

Trump's three illegitimate appointees to the Supreme Court - Justices Amy Coney Barrett, Neil Gorsuch and Brett Kavanaugh - split their votes... and Moscow Mitch was angry.

Beer-boy Kavanaugh and Stepford Wife Amy Barrett joined the majority. Gorsuch was in dissent, signing on to an opinion from Justice Samuel Alito.

Justice Stephen Breyer wrote for the court that the states and people who filed a federal lawsuit "have failed to show that they have standing to attack as unconstitutional the Act's minimum essential coverage provision."

In dissent, Alito wrote, "Today's decision is the third installment in our epic Affordable Care Act trilogy, and it follows the same pattern as installments one and two. In all three episodes, with the Affordable Care Act facing a serious threat, the Court has pulled off an improbable rescue." Alito was a dissenter in the two earlier cases, as well.

Somewhere deceased former Arizona Sen. John McCain is smiling.

The court's decision preserves benefits that became part of the fabric of the nation's health care system even as Republicans repeatedly tried to rip out Obamacare - in McConnell's words - "root and branch."

The health law is now undergoing an expansion under President Joe Biden, who sees it as the foundation for moving the

U.S. to coverage for all. His giant COVID-19 relief bill significantly increased subsidies for private health plans offered through the ACA's insurance markets, while also dangling higher federal payments before the dozen states that have declined the law's Medicaid expansion. About 1 million people have signed up with HealthCare.gov since Biden reopened enrollment amid high levels of COVID cases earlier this year.

The administration says an estimated 31 million people are covered because of the law, most through its combination of Medicaid expansion and marketplace plans. But its most popular benefit is protection for people with pre-existing medical conditions. They cannot be turned down for coverage on account of health problems, or charged a higher premium. While those covered under employer plans already had such protections, "Obamacare" guaranteed them for people buying individual policies.

Another hugely popular benefit allowed young adults to remain on their parents' insurance until they turn 26.

For Medicare recipients, "Obamacare" also improved preventive care, and more importantly, closed a prescription drug coverage gap of several thousand dollars that was known as the "doughnut hole."

received an email related to the search warrants.

According to sources close to the investigation, there are several other high-profile officials under scrutiny including L. A. County Supervisors

Sheila Kuehl, Hilda Solis, Kathryn Barger, former Supervisor Mark Ridley Thomas, L.A. Mayor Eric Garcetti, L.A. City Councilman Gil Cedillo, Inglewood Mayor James Butts, and former DA Jackie Lacey.

Those at Metro include other high ranking officials that reported to Washington.

The explosive allegations include bribery, conspiracy, pay to play, fraud, and waste on the part of LA Metro CEO Philip Washington, Metro Board, LA County Council Mary Wickham and the district attorney Jackie Lacey.


The letter from the grand jury representative stated, "Your letter to the Los Angeles County Civil Grand Jury has been received. The grand jury's review of the issues raised in your letter may or may not result in an investigation."

The whistleblower alleges that they complained to former L.A. District Attorney Jackie Lacey who ignored the complaint and the whistleblower's "21,000 pages of evidence."

The Civil Grand Jury consists of 23 members and a designated number of alternates. Each July these citizens are sworn in as grand jurors for a 12-month period ending June of the following year.

The responsibilities of the Civil Grand Jury include the examination of all aspects of county government, all municipalities, and special districts, to ensure that the County is being governed honestly and efficiently and that county monies are being handled appropriately. The Civil Grand Jury is further charged with investigating individual complaints from citizens.

The jury's findings could be coming soon, "No later than the end of its term (July 2021) the Grand Jury is required by law to submit a final report of its findings and recommendation to the Presiding Judge of the Superior Court."

Unusual things kept occurring around him. He has seen a saucer and flying objects shaped like beans, so he snapped a picture. For over ten years, Bingham kept his sightings to himself. and reported the incident.

The Sheriff and paramedics came, Echano said. The EMT treated him at the scene. Along with the Sheriff's deputy, they went back to the park to identify and apprehend the suspect.

Echano was admitted to the hospital for a day and is now recovering from his injuries from the attack.

A few days after the attack, throbbing pain still lingers, and he's afraid to go outside.

Cerritos Wastes Numerous Opportunities to Keep Season Going, Falls Late to Sultana

The prospects of the Cerritos High softball team playing in the program's fifth CIF-Southern Section divisional championship game was looking better and better throughout last Thursday's semifinal contest against Sultana High, The Lady Dons, ranked eighth in Division 3, had runners on base in every inning and had the winning run on base in the bottom of the seventh inning.

But when Cerritos needed to get that timely hit, it never came and the 605 League champions who had entered the game on a 19-game winning streak, fell to the unranked Sultans 4-3. Cerritos lost for just the second time in 24 games this season and the first time since a 7-6 setback to St. Joseph High on Apr. 13. Cerritos stranded 11 runners on base and had a runner on third base in the bottom of the second and fifth innings, the latter with less than two outs.

"The other day [against Whittier Christian High], we didn't leave anybody on base," said Cerritos first-year head coach Todd Denhart. "We got the hit when we needed it. Today, they made a couple more plays than we did, and in the semifinals of the playoffs, that's the way it goes."

The Lady Dons, who had not been to the semifinals since 2000, but had gone to the quarterfinals in 2004, 2015 and 2017, won Division II titles in 1999 and 2000. Cerritos had also lost the 1996 Division IV championship game to Centennial High of Corona and the 1998 Division II championship game to Quartz Hill High. And, since 2009, Cerritos had been bounced out in the first round seven times. In contrast, this will be the first time in school history that a Sultana softball team will be playing for a divisional championship.

Through the first three innings, it was a battle between junior pitcher Erin Gibbs, who had faced one above the minimum without allowing a hit and her counterpart, Zada Day-Adams, who got out of three consecutive sticky situations as the Lady Dons stranded a pair of runners in each of those frames.

"I didn't know anything about them, but [Gibbs] is a great pitcher", said Sultana head coach Obie Galindo. "I give her all the props. Actually, this was the first left-hander we've seen all year. She's got something there. Good luck to her

wherever she goes.

"My pitcher has been pitching light's out this year," he continued. "She's had one bad game, but it wasn't even [her fault]. We made a couple of errors and didn't back her up and we ended up losing that game."

But the Sultans got to Gibbs in the top of the fourth inning, loading the bases with one out before a single from Madelyn Torrenueva plated Hailey Elgan. Following a strikeout of Kamille Badibanga, a two-run single to left center from Kaiden Kerns made it 3-0.

Cerritos would respond in its half of the inning when senior designated player Leiloni Pina doubled to the right field gap, advanced on a wild pitch and came home on a one-out single from senior left fielder Azalea Herrera.

"The kid is a professional hitter; she hits and that's why she's in the lineup," Denhart said of Pina. "She goes in there with the right attitude, she's got the right mindset and nine times out of 10, you're going to get a good at-bat."

In the next inning, sophomore right fielder Camille Lara, junior second baseman Katelyn Caneda, senior first baseman Samiya Jones and Gibbs all had singles on a combined seven pitches thrown by Day-Adams. A sacrifice from senior center fielder Lauren Lejano advanced freshmen courtesy runners Natalie Gardea and Presley Hendrix. But a pop-up and a fly-out ended further damage.

Sultana, which entered the game on an eight-game winning streak and had two losses all season, both coming to Oak Hills High in Mojave River League games, scored the game-winner with two outs in the top of the seventh inning. Gibbs walked Ella Niles, who would steal second on the first pitch thrown to Kelsey Kerns. Two pitches later, Kerns hit a sharp single that deflected off Gibbs, allowing Niles to come home.

In the bottom of the seventh inning, with two outs, Day-Adams walked Lejano and Pina but got junior third baseman Makayla Sur to fly out to end the game. Caneda, Lara and Pina all had two hits as this was the second straight game Cerritos was held without a run through the first three innings. The only other time this season the Lady Dons failed to score within the first three innings came in a 1-0, walk-off win against Cajon High on Apr. 1.

You may contest the legality or validity of the matter by appearing and filing a written answer to the Complaint not later than July 19, 2021, which is 10 or more days after the anticipated completion of publication of this Summons. Unless you so respond, your default will be entered upon application by the Plaintiff, and the Plaintiff may apply to the court for the relief demanded in the Complaint. Persons who contest the legality or validity of the matter will not be subject to punitive action, such as wage garnishment or seizure of their real or personal property.

You may seek the advice of an attorney in any matter connected with the Complaint or this Summons. Such attorney should be consulted promptly so that your pleading may be filed or entered within the time required by this Summons.

DETAILED SUMMARY OF THE MATTER PLAINTIFF SEEKS TO VALIDATE:

The City of Hawaiian Gardens (“City”) provides its employees with a retirement plan under California Government Code Section 20000, et seq. (the “Retirement Law”). The Retirement Law obligates the City, among other things, to: make annual contributions to the California Public Employees Retirement System (the “System”) to fund employee pension benefits; amortize the unfunded liability with respect to such pension benefits for retired safety and miscellaneous employees (the “Pension Liability”); and appropriate funds to meet these obligations.

The City has entered into contracts with the System (collectively, the “CalPERS Contract”) that evidence the City’s obligations under the Retirement Law (the “Pension Obligation”). Pursuant to the Pension Obligation and the CalPERS Contract, the City currently must pay certain unfunded accrued actuarial liability of the City under the Retirement Law and CalPERS Contract, i.e., the liability that the Retirement System’s actuary has determined to have accrued under the Retirement Law but not paid through the City’s normal annual contribution.

To that end, on April 13, 2021, the City Council adopted Resolution No. 012-2021 (the “Resolution”), authorizing the issuance of the Pension Obligation Bonds; a trust agreement, to be entered into by the City and a financial institution, to carry out the bond issuance (the “Trust Agreement”); and this validation action. Accordingly, and pursuant to California Code of Civil Procedure Sections 860, et seq. and Government Code Sections 53511, et seq., the City now seeks to validate the Pension Obligation Bonds, the Trust Agreement, the Resolution, any other related contracts or agreements authorized or contemplated by the City to be entered into in connection with the issuance of the Bonds and all proceedings leading thereto.

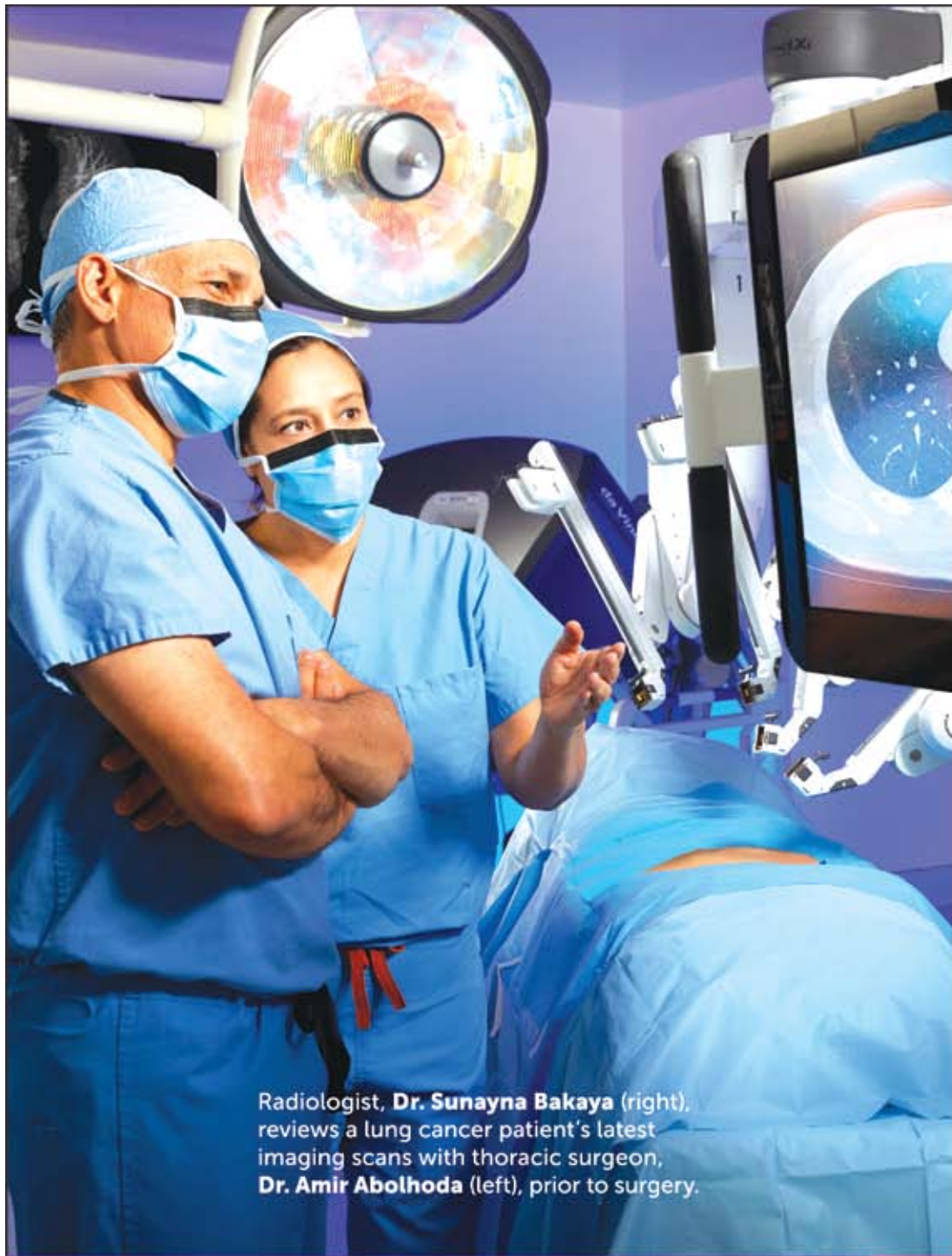
