



Cerritos Center for the Performing Arts Ticket Sales Hit Record Low After City Alters Marketing

Ticket sales plummeted at the Cerritos Center for the Performing Arts in 2022-2023 hitting a record low of \$3.4 million as Cerritos management altered its marketing plan, completely eliminating community newspapers and spending its entire print budget with the L.A. Times and the O.C. Register.

The overall sales were obtained via a public records request.

The expense budget was

pegged at \$7.9 million, meaning the CCPA lost an eye-popping \$4.5 million, a fact the Republican-controlled City Council knew when they proposed to raise '23-'24 CCPA expenses by 21%, or over \$1.6 million, for a total expense budget of \$10.5 million.

Commenting to Los Cerritos Community News, Cerritos City Manager Art Gallucci wrote, "The selection of the Los Angeles Times and Orange County Register is based

Councilmember Endorsed by the Cerritos Republican Club Wants to Ban Books

Gracey Van Der Mark, an extremely controversial Huntington Beach Councilmember who has been accused of being affiliated with white supremacists while at the same time being accused of racist social media

by Chamber Executive Director Noel Jaimes and Tammye McDuff, which outraged many at the meeting.

More than a hundred people signed up to speak, and more than 600 residents emailed comments to the city council.

The controversial proposal puts HB in the spotlight with other cities and school districts attempting book bans nationwide. Many residents said they are concerned that Van Der Mark's proposal could lead to book bans, but Van Der Mark has maintained that "isn't her intention."

Van Der Mark is asking the City Council to have the city manager and city attorney draft a new law to keep the materials from being made available to children. She also asked for a process to screen new books.

The proposal passed in a 4-3 vote shortly after 1 a.m. Wednesday, June 21, with the council's conservative majority echoing Van Der Mark's request to the city manager and attorney.

Book Bans Coming to Cerritos?

The Cerritos Republican Club has long supported Van Der Mark, with the Republican majority of Bruce Barrows, Chuong Vo, and Naresh Solanki approving Van Der Mark speaking at the Cerritos Library in September 2022.

A flyer was also circulated on social media under the Cerritos Republican Club logo, who sponsored the event.

The flyer was also seen on the right-wing Republican-leaning Facebook page Cerritos Press One, which has blocked LCCN from joining.

The flyer promoting Van Der Mark's appearance at the library was entitled What are your kids

Artesia Moves Closer to Permitting Commercial Cannabis in City

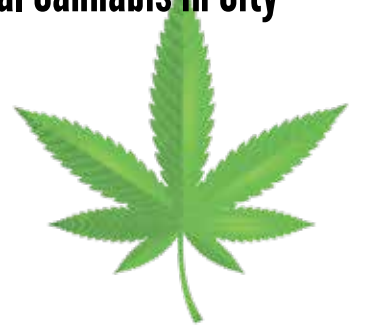

On October 10, 2022, the Artesia City Council adopted an ordinance that amended the city's code to provide for zones where commercial cannabis businesses could open a business.

The ordinance, which some businesses north of the freeway

complained about, mandated that the commercial cannabis facilities could only be located south of the 91-Artesia Freeway.

After adopting the cannabis ordinance, the city council approved two additional ordinances to create a framework for application submittals, reviewing and scoring applica-



tions, and awarding cannabis permits. The city mandated

Cerritos Resident Max Park Breaks Rubik Cube World Record

Cerritos is home to a world record Rubik's Cube Champion and his name is Max Park.

Max Park pulled off the feat in just 3.134 seconds.

Park is a 21 year-old boy with Autism who, in 2016, placed third in the World Cube Association of Rubik's Cube champions and was ranked number one in California, United States and North America. Max participated in twenty competitions in 2016 and earned first place in seventeen of those competitions.

As part of his therapy, doctors recommended Max play with a Rubik's cube.

Schwan Park, Max's Father told LCCN, "Initially working with the Rubik's cube was aimed at working on his fine motor skills." But it became much bigger than that.

At the age of ten, the Parks took Max to his first competi-

tion to help with his social skills. Max made it to competition floor, solving the 6x6 Rubik's cube in just 2 minutes and 57.66 seconds.

"He was beating out other competitor's by a full minute, and these were college age kids," recalls Schwan. The win gave Max his first division title, placing him in the top 100 players in the world. Further, it was the 89th fastest time ever recorded.

A Rubik's Cube is a three-dimensional flexible puzzle with six sides containing colored squares. The goal is to

spin the sides so each ends up with the same color. A standard cube has three rows of each color, but the puzzle comes in various sizes and Max can solve the puzzle faster than most people on the planet.

In the beginning, Max tinkered with the cube, but really became enthralled while watching YouTube videos of people solving the puzzle. He then challenged himself to match their speed. As Max watched the other competitors, he memorized their moves.

Children and their families will have the opportunity to explore their creativity in the form of Apple Store Camps, this year, the free sessions, titled "Design Your Dream Invention on iPad," will be held from June 10 to Aug. 5. According to Apple, the sessions are geared towards children between the ages of 8 and 12, as well as their parents or

During the 60-minute sessions, which are led by an Apple Creative, participants will be using Apple Pencil, Keynote and Freeform. 2nd Women's Equality Day Youth Speech and Art Contests

The second annual Women's Equality Day Youth Speech and Art Contests will take place on Sunday, August 27 from 1:00 to 3:00 p.m. at the Community Clubhouse of Shadow Park, 12721 Alconbury St. Cerritos, 90703, a gated community.

This event is co-sponsored by the non-profit Arias Art Foundation and the Hubert H. Humphrey Democratic Club. \$1,000 in cash prizes will be awarded to K-12 winners of the speech and art contests, made possible by the generosity of Juan Garza, former Bellflower Mayor and his wife Mayra Garza, 2023 BUSD Board President.

Other sponsors include Al Barlevy, Diana Needham, Ret. Judge Lee Tipton and Mary Ann Tipton, Norma Williamson, event founder and program chair and Arias Art Foundation Director Leo Perez.

The annual commemoration of Women's Equality Day marks the 103rd anniversary of the passage of the 19th amendment that granted American women the right to vote on August 26, 1920, culminating in 72 years of political activism by the "suffragists" the women who tirelessly advocated for the franchise. This event is largely organized by retired and current public school teachers (Pam Crawley, Emily Chen Darnell, Catherine Pascual, Mary Ann Tipton and Norma Williamson) who wish to instill in youth a sense of pride and knowledge of women's history. Keynote speaker is Asm. Sharon Quirk Silva D-67 who also is a former K-12 public school teacher.

Youth participants will create art and deliver speeches on famous historical women leaders and activists in politics. Area high school student finalists will be delivering a 3-minute speech on one famous female political/human rights leader like Mary McLeod Bethune, Malala Yousafzai,

Greta Thunberg &/or historical American suffragist like Alice Paul, Carrie Chapman Catt and more. First place winner will be awarded a \$300 check, 2nd place a \$200 check and third place a \$100 check.

Middle school students will compete for the best interpretive visual, two dimensional, 8 1/2 " x 11" multimedia art piece showcasing important female leaders like Susan B. Anthony, Sojourner Truth, Ida B. Wells, Eleanor Roosevelt and others. Prize money levels for winning are \$100, \$75 and \$50.

Elementary school boys and girls will participate in a coloring page contest (watercolors, colored pencils, crayons, markers, charcoal allowed) of either Ruth Bader Ginsburg, Sonia Sotomayor, Susan B. Anthony, Shirley Chisholm, Kamala Harris and/or Sandra Day O'Connor. Winning award levels are \$75, \$50 and \$25. ALL finalists in attendance, will receive a small participation gift bag.

One distinctive feature of our scoring system is based on the popular American Idol television show where the audience votes. The COVID-19 pandemic has hit another category of jobs: county lifeguards.

Normally operating six days a week in the summer, Los Angeles County's 25 swimming pools have cut their operating hours in half due to shortages of lifeguards, the county reported.

Half of the pools will be open Mondays, Wednesdays and Fridays, and the other half will be open Tuesdays, Thursdays and Saturdays.

The summer schedule begins this week.

The new Whittier Regional Aquatic Center and the San Fernando Regional Pool are year-round pools and will remain operational six days a week.

The county has tried to stagger the pools so if one is closed, another "close by" will be open.

Splash pads also are not affected and are located in City Terrace Park, Atlantic Ave. Park, Alondra Park Splash Pad, Los

Robles Park, and Cerritos Park Splash Pad.

One of the big reasons for the shortage is that the pandemic forced the closure of many pools that were an excellent recruitment source for lifeguards.

To counter, the county launched its Lifeguard Ready Training program that trains young people by matching them with an instructor. The instructor ascertains if the young person is a good swimmer, and then they can apply for a lifeguard position.

"Being a pool lifeguard is a great summer job, especially for a young person, and we need to make sure the salaries we offer are competitive," said Fourth District Supervisor and Board Chair Janice Hahn in a prepared statement. "It's also an important job, but hiring shouldn't take months."

LAB GROWN CHICKEN MEAT APPROVED BY USDA

For the first time, U.S. regulators on Wednesday approved the sale of chicken made from animal cells, allowing two California companies to offer "lab-grown" meat to the nation's restaurant tables and eventually, supermarket shelves.

The USDA gave the green light to Upside Foods and Good Meat, firms that sell meat that doesn't come from slaughtered animals — what's now being referred to as "cell-cultivated" meat.

The move launches a new era of meat production aimed at eliminating harm to animals and drastically reducing the environmental impacts of grazing, growing feed for animals and animal waste.

Cultivated meat is grown in steel tanks, using cells that come from a living animal, a fertilized egg or a bank of stored cells.

But don't look for this novel meat in U.S. grocery stores anytime soon.

The companies plan to serve the new food first in exclusive restaurants: Upside has partnered with a San Francisco restaurant called Bar Crenn, while Good Meat dishes will be served at a Washington, D.C., restaurant run by chef and owner Jose Andrés.

Company officials are quick to note the products are meat, not substitutes from plant proteins and other ingredients.

The finished chicken breast product was slightly paler than the grocery store

version. Otherwise it looked, cooked, smelled and tasted like pan-fried poultry.

Companies acknowledged that many consumers are skeptical, even squeamish, about the thought of eating chicken grown from cells.

The sentiment was echoed in a recent poll which half of U.S. adults said that they are unlikely to try meat grown using cells from animals. When asked to choose from a list of reasons for their reluctance, most who said they'd be unlikely to try it said "it just sounds weird." About half said they don't think it would be safe.

Cultivated meat begins with cells. Once the cell lines are selected, they're combined with a broth-like mixture that includes the amino acids, fatty acids, sugars, salts, vitamins and other elements cells need to grow. Inside the tanks, called cultivators, the cells grow, proliferating quickly.

Both firms emphasized that initial production will be limited. Upside says they can produce up to 50,000 pounds; Good Meat officials wouldn't estimate a production goal.

It could take a few years before consumers see the products in more restaurants and seven to 10 years before they hit the wider market.

Cost will be another sticking point. Eventually, the price is expected to mirror high-end organic chicken, which sells for up to \$20 per pound.

LOSS OF LOCAL JOURNALISM HAS CREATED SPACE FOR ABUSE AND CORRUPTION

“All politics is local,” is an old American saying. That might partly explain why democratic politics is going so badly — especially, but not only, in the United States. For local government to work properly, there must be local journalism to hold politicians and policymakers to account. But local journalism has been collapsing in many parts of the world.

This makes it more difficult for citizens to connect to civic life; local problems that could have wider significance go unreported.

But though there is no single “fix” for the decline of local journalism, we are not helpless. Experiments in different countries suggest ways to revitalize local reporting. All make the production of public interest news, by whatever economic means available.

For most of the 20th century, the news business relied on advertising revenue, but the internet put a huge dent in that. Local journalism was hit especially hard, not only because ads migrated to free online classified boards like Craigslist, killing the backbone of newspapers, the Classifieds

By some estimates, one-third of the newspapers that existed in the U.S. in 2005 will be gone by 2025. In the United Kingdom, 320 local newspapers closed between 2009 and 2019. The private equity firms like the one that owns Whittier and Long Beach papers, tend to make things worse. Rather than investing in

journalism, they downsize newsrooms and sell off newspaper buildings.

The implications for democracy are beyond debate. Social scientists who study the issue have demonstrated clearly that less local journalism results in higher levels of corruption, undermines political competition and reduces citizen engagement.

And even if there is good local reporting, it too often remains local. George Santos’ serial lying was covered by a local newspaper, but it did not become a national news story until weeks after he was elected to Congress.

Although no single business model has emerged as a reliable replacement for advertising revenue, alternatives to the tyranny of the market exist. Consider philanthropy. While there is an obvious danger of creating dependencies or conflicts of interest, a mixture of philanthropic funding and volunteering can give rise to inspiring initiatives like Report for America, which places people in local newsrooms to cover underreported issues.

Editors note: Here in California, the state spends hundreds of millions on advertising, and very little in print newspapers.

Countries could make it easier for journalism to qualify as a charitable activity, and governments everywhere can provide grants.

The peril of creating dependencies or conflicts of interest is avoidable if there are enough layers between the state and recipients of taxpayer money.

Contrary to what Elon Musk wants people to think when he calls NPR “state-affiliated media,” mechanisms for insulating journalists from political pressures have long been available in public service broadcasting.

There is no reason why they can’t be extended to local journalism as well.

Democracy depends on communication. But effective communication, in turn, depends on understanding which democratic decisions really matter. To that end, the nonprofit States Newsroom focuses squarely on state-level policies that affect citizens in ways that are not

obvious even to the relatively well-informed.

The Documenters Network trains and pays people to report on local government meetings that otherwise would go unobserved. The BBC, for instance, has partnered with local newspapers to increase the quantity of local reporting, sending a clear signal that decisions on the ground matter.

Some approaches will function better than others, depending on the locale.

But as a general matter, it is crucial to avoid strategies that primarily benefit larger regional or even national newspaper companies, rather than local institutions.

Innovative plans to let newspapers negotiate for content fees from big platforms like Google have worked for media companies in Australia, and they may yet work in the U.S. if new legislation such as the Journalism Competition and Preservation Act is approved by Congress. But money must go to the grassroots too.

The goal, after all, is to produce genuine news of public interest about and from places otherwise forgotten or ignored.

Metro Allows Pay-As-You-Go on I-10 and I-110 Freeways



FOR YEARS drivers were not allowed in the Metro Express Lanes on the I-10 and I-110 freeways without a transponder in their vehicle, that will now change.

Staff Report

Yesterday, L.A. County Supervisor Janice Hahn applauded a vote by the Metro Board to permanently "decriminalize" the Express Lanes on the 10 and 110 freeways. Hahn, who serves on the Metro Board, was the author of the original proposal to decriminalize, and replace it with a "pay-as-you-go" model in 2018.

For years, drivers were not allowed in the Metro Express Lanes on the I-10 and I-110 freeways without having an official transponder in their vehicle. If caught by the CHP in the Express Lane without a transponder, a driver would receive a \$250 citation. A camera would also capture the license plates of any vehicles without transponders and send the drivers a fine in the mail.

In 2018, Supervisor Hahn proposed a

plan to decriminalize the Express Lanes and allow drivers without a transponder to use the lanes and simply pay the congestion toll and a small processing fee which are sent in the mail. Metro implemented Hahn's plan as a pilot program starting in 2019.

"I proposed this plan back in 2018 because I know how intimidating the Express Lanes can be for drivers and that plenty of people haven't gone through the trouble of getting a transponder," said Hahn. "It is gratifying to know that the pay-as-you-go model has been working and that we can make this a permanent option for drivers and make our freeways a little more friendly."

Data compiled by Metro showed 900,000 more people using the express lanes without transponders during the pilot program.

La Mirada to Strictly Enforce Fireworks Regulations

La Mirada wants to remind the community that the La Mirada Public Safety Team will take a "zero-tolerance" approach to enforcing fireworks and party regulations.

The Public Safety Team will strictly enforce this policy, and will issue a \$1,000 fine to individuals caught discharging or in possession of illegal fireworks.

The discharging of fireworks on city-owned property, including parks, streets and sidewalks, is strictly prohibited.

The use of "safe and sane fireworks" is permitted and only allowed on Tuesday, July 4 from 3 to 10 p.m.

Trespassing laws will be enforced and individuals who discharge fireworks or conduct celebrations on private property without the owner's permission will be cited.

The city also reminds residents of La Mirada that streets may not be blocked to accommodate parties or large gatherings. Those hosting large parties that disturb the peace may be cited for the costs of dispersing the party. Public drinking of alcoholic beverages and public intoxication are also prohibited. All laws will be proactively enforced.

Residents are highly encouraged to take an active part in reporting criminal activity.

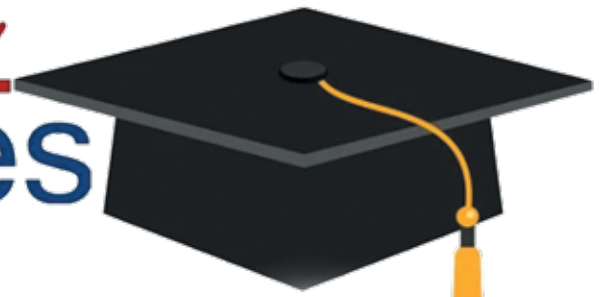

FIVE YEARS OF 605 LEAGUE

CERRITOS HIGH AND OTHERS FINDING COMPETITIVE COMFORT IN 605 LEAGUE

Artesia High, Cerritos High and John Glenn High, once longtime members of the defunct Suburban League, were hoping for a better chance to be competitive in the 605 League when it was introduced to the CIF-Southern Section to kick off the 2018-2019 school year. The former Suburban League had been primarily dominated by La Mirada High and Mayfair High, though the three schools that broke ties with the Suburban League had spurts of success.

Five years into the existence of the 605 League and it's been a win-win for the six-member 605 League as every school has tasted life as a league champion, has gone deep in the playoffs and has even called themselves a CIF champion.

One of the main reasons for the formation of the 605 League, which also includes former Del Rio League member Pioneer High and ex-Academy League rivals Oxford Academy and Whitney High, was football driven. From 1998-2017, La Mirada and Mayfair combined to win all but one football league crown, though Cerritos was a tri-champion in 2001.

In the five years of the 605 League, Cerritos has two league titles in football and Artesia and Glenn have one each. There was no official league season in the fall of 2020 as the pandemic shifted the season to the spring of 2021 with no more



than six games played, and Pioneer went to the playoffs last season.

"I think Covid had kind of an effect on us, especially on the smaller schools," said Cerritos co-athletic director Robert Adams. "I think for some of the schools, the 605 League has done really well. For Cerritos, I think it's a mixed bag. Not all sports have benefitted at Cerritos because some of the other schools have not been able to field all the sports they committed to and/or all the levels they committed to in those sports."

Adams continued to say that he is hopeful that the schools which don't have all levels in certain sports will correct itself. But for now, the six institutions have to figure out ways to schedule competitive non-league games for their lower level teams

during league action if there aren't enough league teams to field a balanced schedule.

"The 605 League's first five years have been a success," said Glenn athletic director Linda Parra. "We have had the opportunity to create competitive equity in every sport. Teams who have not had much success in league play in the past, have been able to compete and qualify for the CIF playoffs. Many of our league teams have had success within the CIF playoffs as well."

Although Glenn's football team won the league in 2019, it has tried to stay within striking range of an automatic playoff berth in some of the other sports. Last season's girls volleyball team finished in third place, the 2021-2022 boys basketball team finished in third place and advanced

to the quarterfinals in the playoffs, the 2019-2020 boys soccer team was a second place finisher, the 2019 baseball team got third place and the last three Eagle softball teams have combined to go 18-12 in league action with a pair of playoff trips.

"Yes, while there are some athletic teams at John Glenn that might struggle a bit in the league, due to participation and lack of experience, I do believe the 605 League is beneficial for JGHS Athletics," said Parra.

While Glenn has struggled, Cerritos has thrived more than the other five schools. Of the four major sports in each of the three seasons, the Dons have claimed 33 league titles. That doesn't include the dominance in such sports like boys and girls cross country, boys and girls golf, boys and girls track and field and boys and girls wrestling. It's statistics like that that shows why the 605 League is a good landing spot for Cerritos.

"Right now, it certainly is," said Adams. "I think it's easier for us at Cerritos than it was for La Mirada. I don't think the situation is apples to apples in as much as when the Suburban League was attacked six years ago, or seven years ago, all the schools had similar population. For La Mirada to excel in as many sports as they did was very impressive. It's a less impressive feat for a 2,100 student school to dominate or to have success over a bunch of 1,000 or lower population schools. We're twice the size of most of the schools in the 605 League."

But with the good, comes the bad. Whitney was hit probably the hardest in a pair of sports when Covid shut everything down in the early spring of 2020. The baseball team was on the verge of a possible playoff berth in 2020 despite finishing in fifth place in 2019 and had a strong senior class returning. But low numbers wiped out the return of a team in 2021 and the Wildcats haven't fielded a team since then. The same happened with its girls soccer team, which went to the playoffs weeks before Covid hit. Some of the girls played for the 2020-2021 boys team which advanced to the Division 7 championship game. But even then, Whitney boys soccer has gone winless in league action the past two seasons while there has not been a girls soccer program.

In girls soccer, Cerritos has gone 40-0-0 in league action and went to the Division 4 semifinals this past February. But Artesia, Oxford Academy, Pioneer and Whitney have either been eliminated in the wild card or first round nine times and only Oxford has advanced to the second round once. On top of that, Glenn has yet to win a league game.

"Again, I think you can make an argument that Covid may have played a little part of it, but the 605 League has not shown as much competitiveness as we have hoped," said Adams. "And, we have dropped levels. Girls soccer, using them as example and I'm the coach of that, obviously, we don't participate in a six-team league. We participate in a five-team league [and] not only do we participate in a five-team league, but we participate in a five-team league with no junior varsity teams. So, that presents a huge difficulty on our side."

Adams said he and Cerritos would be open to entertaining expansion of the league as needed in order to preserve the competitiveness and the validity of the different sports in multiple levels.

Not winning a 605 League title doesn't mean you can't have success in the playoffs, especially with the CIF-SS having changed its divisional format over the years. Artesia's 2019 league title in foot-

AREA ATHLETES, COACHES VIE FOR A BERTH IN END OF SUMMER'S TOP TOURNAMENT

IRVINE-Many of the area's high school softball players' travel teams have already clinched a spot in the Premier Girls Fastpitch National Championship, but they wanted more. Others were looking to stamp their name to the lengthy list of teams that will flock to several Orange County facilities at the end of July and early August in what will either be their last softball games before college, or a little bit of momentum for the 2024 high school season.

Those area athletes and a couple of coaches took part in the PGF Southern California Qualifier, and one team in particular came up short in playing for either an automatic spot in the Premier Division or Platinum Division of the National Championships. In the 18-Under age division, the Southern California Athletics-Rivera/Blanck had the bases loaded with two outs in the bottom of the seventh inning, trailing the [Moorpark] Southern Cali-

fornia Choppers-Ashley by a run. But a base-running mistake ended the game and the Athletics fell 3-2. The Athletics, coached by Tim Rivera and current Artesia High head coach Ed Blanck, both of whom were once coaches in the Artesia Punishers organization, won three straight games before falling to the [San Marcos] Southern California Breakers-Beddo/Wright 5-1 this past Sunday morning followed by the setback to the Choppers.

"It was unfortunate we had to get to [that situation]," said Rivera. "We shouldn't have been there; all their runs were unearned. Otherwise, we would have won 2-0 and been still playing."

"I think as we go on, you're facing better pitching," he later added. "In the first game today, we didn't do too well. We should have won that game. This team right here, it was a very good team we lost to. We play them all the time and we battle with them. I don't feel as bad losing to them as I do losing that first game."

The Athletics took a 1-0 lead in the bottom of the second when Maya Torres (Artesia High) singled with two outs and scored from second when catcher Viki

Barron (Manhattanville College) reached on an error. The score remained that way until the top of the fifth when the Choppers scored twice.

The eventual game-winner was scored one inning later before the Athletics began to make things interesting. On the first pitch of the bottom of the sixth, center fielder Olivia Madkins (Columbia University) homered over the left field fence.

In the final inning with one out, Barron was walked on four pitches and went to second on a single from left fielder Jenessa Hernandez (Wilcox High). Then with two outs and after fouling off three straight pitches, Madkins singled to load



the bases. However, a blunder on the base paths ended the game.

Had the Athletics pulled out the victory, they would have faced the [Foothill Ranch] Southern California Athletics-Dave Lastrapes with the winner of that game earning a spot in the Premier Division and loser getting a berth in the Platinum Division of the National Championships. Heading into the qualifier, the Athletics were pretty much locked in the National Championships.

"We would have much rather earned it," said Rivera. "I think we earned it anyway, but to do it on the field and come out with a plaque would have been nice for the girls and their hard work."

Last Friday, the Athletics doubled up the [Corona] E1 Prospects-Marez 6-3 as a four-run bottom of the first inning proved to be the difference. Center fielder Alea Medina (Artesia High) went three for three and scored three times while shortstop Vanessa Soto (Artesia High) also went three for three, drove in a pair of runs and scored once. Designated player Alexis Rosales (Pioneer High) went two

for three and had an RBI.

Last Saturday morning, the Athletics got past the [La Mirada] Explosion-Sanchez, coached by Gahr High head coach Rey Sanchez. The Athletics scored a pair of runs in the top of the third to take a one-run lead before the Explosion tied the game in the fourth. With one out in the top of the seventh and second baseman Analeigh Herrera (Warren High) at third, Medina singled to center to make it 3-2 and that was followed by a base hit from Soto on a full count, accounting for the final tally of the game.

Later in the day, the Athletics had no problems with the [Downey] Ohana Ti-

gers-Colenzo in a 10-2 conquest. Already leading 1-0, the Athletics added four runs in the top of the second as Madkins tripled in a pair of runs with one out and Lianna Lara (Sierra Canyon High) hit a two-run home run to left field with two outs. She would finish the game going three for three and drove in four runs. After the Tigers scored in the third and fourth innings, the Athletics put the game away with a five-spot in the sixth. Medina went three for four and scored twice while Torres worked the first four innings, scattering three hits and striking out two.

"Alea is a stud," said Rivera. "We moved her to leadoff now and she's been amazing. Maya did a great job pitching yesterday. She's versatile; can play short, third and pitcher, and she's been hitting the ball very well. The same for Vanessa, our number four hitter. She catches for us, plays shortstop for us, plays third base for us. All three of them are amazing ball players."

This is the first year Blanck and Rivera have been coaching together for the So Cal Athletics. Blanck, the 2023 HMG-

Community News Coach of the Year, had been with the Punishers for roughly two decades before moving to the Athletics, where he has been for five years. Rivera, in his seventh year with the Athletics, spent 10 years with the Punishers.

"It was time for a change," said Rivera. "I left first, then he retired from over there and I brought him over here with us. We do so well together."

The Athletics will next be in action at the SurfCity Tourneys Summer Showcase, to be held July 7-9. In other action featuring some of the area softball players, Gahr graduates Sophia Magcale (University of Redlands), Hailey Sanchez (California State University, Northridge) and La Mirada High's Amber Valdez were on the Explosion, which went two and out. After the loss to the Athletics, the Explosion fell to the [Tracy] All American Sports Academy-Clark 7-4 later in the day. Hailey Sanchez went a combined three for seven with two runs scored and a RBI, while Magcale had a pair of hits in four at-bats.

Cerritos graduate Catherine Quibrantar, who went a combined two for eight with a run and a RBI, and John Glenn High's Sienna Contreras, who went hitless in her lone at-bat in the last game, are on the Tigers, which won their first two games before losing the next two.

In the 16-Under division, Norwalk High's Kendall Nakano, the 2023 HMG-Community News Player of the Year, calls the [Norco] Wildcats-Laufou/Hunter her travel team, which went 3-2 last weekend. Nakano went a combined five for 14 with a double, drove in three runs and scored three times. Since the beginning of the summer travel season, Nakano is batting .490. Also on the team is Kylie Manibusan of Cerritos, who did not record a hit in 15 at-bats, but scored once and was walked once.

ball got the Pioneers to the Division 12 championship game. No other league team has gotten out of the first round. Whitney girls tennis, which was 2019 co-champs with Cerritos and lost in the Division 4 semifinals, moved up a division for the 2021 season, won league and went to the semifinals again while Cerritos advanced to the quarterfinals.

The winter sports have been the most competitive with the farthest advancement in the postseason. In boys basketball, after seeing Cerritos open the league with three straight league titles, Artesia has won the last two and played in the Division 4AA semifinals two seasons ago. Last season, Whitney finished in third place, lost in the Division 5AA semifinals and played in the state tournament.

In girls basketball, which has seen four of the six schools have a share of a league title, Oxford Academy went to the Division 2A championship game in 2019 as did Cerritos in 2022 in Division 3AA. In 2020, Artesia finished in fourth place but won the Division 5AA crown while three schools have combined for four quarterfinals appearances. And in boys soccer, Artesia won the Division 5 championship two

seasons ago and Oxford Academy played for the Division 7 crown last season.

In the spring sports, Whitney's 2019 third place softball team lost in the quarterfinals and two seasons later, Cerritos fell in the semifinals in the same sport. Just a month ago, Artesia's third place softball team lost in the seventh inning in the Division 6 semifinals while in boys volleyball, third place Oxford Academy went to the 2019 Division 6 semifinals.

Finally, in boys tennis, 2022 was good for league champion Oxford Academy (quarterfinals), second place Cerritos (Division 4 champions) and third place Whitney (Division 3 finalists). This past spring, league champion Whitney and second place Cerritos both lost in the quarterfinals.

"From a community standpoint, the varsity sports obviously take the spotlight, and they should," said Adams. "That will always be the case. But, without a strong lower division, whether it's a two-level sport or a three-level sport, you're going to lose participation. I've always been of the opinion that the 605 is a lower competitive league, overall, taken in total from the Suburban League before the Suburban League split."

The original plans for the 605 League was to have a similar model that the Sub-

urban Valley Conference is using. That conference merged the Suburban League, which had five members once the 605 League was formed, and the San Gabriel Valley League, which had six members.

"That was always the target when the 605 League was developed," said Adams. "Now, keep in mind, the Suburban League has now merged in a model with the San Gabriel Valley League in a way that Cerritos and Artesia and [Glenn] tried to do for multiple years, and the Suburban League blocked it. That's when we were forced to leave."

"All three of us tried vigorously to try to bring in some other schools in order to form a conference," he continued. "The Suburban League six years ago was a seven-team league, and that presents some difficulties as well. Just by bringing in three additional teams, whatever those would have been, and going to a conference model would have changed the competitive nature."

While the SVC is trying to get a 12th school to make things equal between the Gateway League and Mid-Cities League, the 605 League is trying to do the same, especially for football since Oxford Academy and Whitney do not house football programs.

Some of the changes in the near future will take place in golf and water polo where the league will be entertaining guest schools coming into the league. Adams said that swimming and water polo are always in a difficult situation because of facilities. He would love to see badminton come into the 605 League, but it takes three or four teams to make that happen.

For the 2023-2024 school year, Valley Christian High will join the 605 League in boys and girls golf while Calvary Chapel Downey High come in for wrestling purposes. And, pending administration approval, Milken Community will enter the league for boys water polo.

"Overall, I'm very pleased with where the 605 League is," said Adams. "It's easy to take a microscope out and focus on individual sports and every individual sports can say 'yes, we would be better over here or we would be better with somebody else coming in with us'. In general, it has worked out really, really well."

"I would like to see our [league] participation numbers in certain sports improve so that we can all have healthy junior varsity and varsity teams," said Parra.

Notice is hereby given that on June 13, 2023, the City Council of the City of Hawaiian Gardens introduced for first reading, Ordinance No. 2023-611, which proposes to impose regulations on sidewalk vending in compliance with SB 946 and SB 972.

SB 946, went into effect on January 1, 2019, and established statewide governance of vending in the public right-of-way and parks. Local jurisdictions that wish to regulate sidewalk vending are required to first adopt an ordinance establishing rules and regulations consistent with SB 946. SB 972 took effect on January 1, 2023, and decriminalized sidewalk food vending under the California Retail Food Code.

The City currently regulates solicitors, peddlers, and vendors through Chapter 5.30 of the Hawaiian Garden's Municipal Code. With the State's adoption of SB 946, Chapter 5.30 is outdated and inconsistent with the new state laws. Therefore, Ordinance 2023-611 will repeal Chapter 5.30 and replace it with a new sidewalk vending regulation that are consistent with SB 946 and SB 972. In addition, the ordinance sets operational restrictions that are objective in consideration of the protection of public health, safety and welfare.

MANDATORY PRE-BID MEETING AND SITE VISIT. A mandatory pre-Bid meeting will be held on July 12th, 2023 at 10:00 a.m. at 18750 Clarkdale Avenue Artesia, CA, 90701 followed by a mandatory site visit. Every Bidder is required to attend the pre-Bid meeting and the Project site visit. Failure of a Bidder to attend will render that Bidder’s Bid non-responsive. No allowances for cost adjustments will be made if a Bidder fails to adequately examine the Project site before submitting a Bid.

REGISTRATION WITH THE DEPARTMENT OF INDUSTRIAL RELATIONS. In accordance with Labor Code Sections 1725.5 and 1771.1, no contractor or subcontractor shall be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, unless currently registered and qualified to perform public work pursuant to Section 1725.5 [with limited exceptions for bid purposes only under Labor Code Section 1771.1(a)].

PREVAILING WAGES. In accordance with Labor Code Section 1770 et seq., the Project is a “public work.” The successful Bidder (“Contractor”) and any Subcontractors shall pay wages in accordance with the determination of the Director of the Department of Industrial Relations (“DIR”) regarding the prevailing rate of per diem wages. Copies of those rates are on file with the Director of Public Works, and are available to any interested party upon request. The Contractor shall post a copy of the DIR’s determination of the prevailing rate of per diem wages at each job site. This Project is subject to compliance monitoring and enforcement by the DIR.

BONDS. Each Bid must be accompanied by a cash deposit, cashier’s check, certified check or Bidder’s Bond issued by a Surety insurer, made payable to the City and in an amount not less than ten percent (10%) of the total Bid submitted. Personal or company checks are not acceptable. Upon Contract award, the Contractor shall provide faithful performance and payment Bonds, each in a sum equal to the Contract Price. All Bonds must be issued by a California admitted Surety insurer using the forms set forth in the Contract Documents, or in any other form approved by the City Attorney. Failure to enter into the Contract with the City, including the submission of all required Bonds and insurance coverages, within fifteen (15) Days after the date of the mailing of written notice of contract award to the Bidder, shall subject the Bid security to forfeiture to the extent provided by law.

LICENSES. Each Bidder shall possess a valid Class B Contractor’s license issued by the California State Contractors License Board at the time of the Bid submission, unless this Project has any federal funding, in which case the Contractor must possess such a license at the time of the Contract award. The successful Contractor must also possess a current City business license.

RETENTION SUBSTITUTION. Five percent (5%) of any progress payment will be withheld as retention. In accordance with Public Contract Code Section 22300, and at the request and expense of the Contractor, securities equivalent to the amount withheld may be deposited with the City or with a State or federally chartered bank as escrow agent, which shall then pay such moneys to the Contractor. Upon satisfactory completion of the Project, the securities shall be returned to the Contractor. Alternatively, the Contractor may request that the City make payments of earned retentions directly to an escrow agent at the Contractor’s expense. No such substitutions shall be accepted until all related documents are approved by the City Attorney.

BIDDING PROCESS. The City reserves the right to reject any Bid or all Bids, and to waive any irregularities or informalities in any Bid or in the bidding, as deemed to be in its best interest.

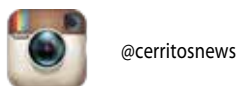

on the number of subscribers reached, geographic scope of the newspapers and the demographics of the covered areas.”

Only 13% of people in households in LCCN’s delivery area subscribe to the Los Angeles Times and Orange County Register, which was pre-pandemic, while LCCN is delivered to 98% of the homes in the same area. The numbers are similar in Downey, which also has a community newspaper that was excluded from the CCPA marketing plan.

Cerritos’ management chose to not reveal what LCCN asked for - the per show tickets sold and corresponding revenue. The sales document sent by the city clerk only revealed total revenue per show; per show tickets sold and revenue were redacted.

The city clerk cited California Government Code Section 6254.15 as the reason for non-disclosure, “Nothing in this chapter shall be construed to require the disclosure of records that are any of the following: corporate financial records, corporate proprietary information including trade secrets, and information relating to siting within the state furnished to a government agency by a private company for the purpose of permitting the agency to work with the company in retaining, locating, or expanding a facility within California. The requested information may be released to you upon the City’s receipt from you, the consent of individual artists, of release of this specific information.”

When LCCN asked the city of La Mirada for its sales at the La Mirada

Theater for the Performing Arts, which had a record 2022-23 year, the city did not redact any information concerning ticket sales and revenue.

There are no plans to change the sales and operations of the CCPA for the 23-24 season; consequently, the city is looking at another multi-million dollar loss.

Emails into Cerritos management, Mayor Bruce Barrows and Mayor pro tem Naresh Solanki for comment went unanswered.

learning? "Join the non-partisan, no-cost, educational conversation on our children's education. Critical Race Theory is being taught to our students without our consent, and we must engage together for the future of our kids."

Critical Race Theory is only taught in college graduate courses and not K-12; it is an alt-right talking point used to drive another wedge between American citizens.

The Cerritos City Council held a special meeting two days before Van Der Mark spoke on September 13, addressing the invitation by the Republican Club.

Similar to Huntington Beach, the fireworks started at public comment with speaker after speaker taking the dais and slamming the Cerritos Republican Club - and the Councilmembers who promote the club - for inviting Van Der Mark to speak.

"This is perpetuating hate in the City, and it is unacceptable."

"The Republican party in Cerritos is lost."

"I have a problem with leadership here."

Chris Foster angrily criticized the in-

invitation of Van der Mark by the Cerritos Republican Club.

Foster pointed out the relationships that she has with certain infamous alt-right members.

He cited many names who were filmed at several highly controversial events, including Charlottesville and neo-nazi book burning that Van Der Mark praises.

"Its time for members of the Republican Club, whom Barrows, Vo, and Solanki are members, to speak out against this."

Anantha Ramachadran pointed out that the council is dominated by members of the Cerritos Republican Club, endorsed by them for many years. "You need to speak out on this," he said.

Norma Williamson expressed her concern about Van Der Mark, "her only political experience is a stint as a finance commissioner and the fact that she ran and lost for Huntington Beach City Council endorsed by Tito Ortiz, another infamous right-wing hack."

Seth Grossman, son of Marty and Gail Grossman, said, "the Republican Club has

chosen to disgrace our city."

He pointed out that Van de Mark and two other men invaded a meeting at the Simon Wiesenthal Center. "They then showed up at Charlottesville chanting 'Jews will not replace us,'" he said.

"This is perpetuating hate in the City and it is unacceptable."

LCCN asked for comment from the City Council, only Councilman Frank Yokoyama has responded.

Yokoyama told LCCN, "I am outraged and deeply saddened whenever racism and racists are discovered or revealed in our City of Cerritos. The prevalence and tolerance of hateful and racist people threaten safety in Cerritos. I denounce these hateful and racist people and their hateful racist acts and speech that strike fear into the hearts of our diverse communities, and I urge my fellow leaders likewise to make such denouncements. I strongly urge the Los Angeles County Sheriff's Department to keep Cerritos safe from racist attacks and hate crimes."

that a maximum of three retail commercial cannabis permits could operate within city borders at any time.

Soon after the adoption, the city council designated a time frame to accept applications for cannabis permits, running from February 6, 2023 through March 8, 2023.

But before closing, an applicant north of the 91 freeway filed a lawsuit against the city alleging that the ordinance's language "was not clear and that it allows commercial cannabis businesses to locate north of the 91 freeway."

The city was forced to postpone the permit program on March 16 to evaluate the pending legal action. It came up with revisions to the code that reaffirmed that cannabis businesses may only be located south of the 91 freeway.

In essence, the city was doing that already when it denied any permits north of the 91 freeway.

In addition, Artesia also streamlined the process after permit approval related to modifications of the existing design or exterior of the building.

Usually, that kind of change go through a Planning Commission review, but under the proposed revisions, if an approved cannabis business seeks "minor modifications" to an existing structure, then it would be reviewed by the Community Development Director.

Minor modification means that less than sixty percent of the building facade is being modified; any changes over 60% or any appeal of an administrative design review would still go to the Planning Commission.

Finally, the city "strengthened the

City's oversight of permitted businesses," including providing the city manager more flexibility to create the process for how an application is scored. The changes will not change the scoring criteria set by the city council.

Revising the requirement that permittees must provide the city with signed leases. Instead, permittees would have to give the city a notarized and recorded memorandum of lease.

Scrutinizing whether applicants or renewal businesses have failed to collect, report, or remit cannabis-related taxes to the State or other local jurisdictions and providing the process by which a permit may be suspended or revoked.

Once fully operational, the businesses are expected to generate between \$600,000 and \$800,000 for city coffers.

When Max isn't doing his homework, he spends time searching for better moves, "He does it all the time, like kids playing video games," Schwan said. "He'll just do it, practicing in bits and pieces, 10 minutes at a time, 15 minutes at a time."

Solving the puzzle involves mathematics and memorization, Schwan said, both of which Max has seemed to have mastered. Max also excels on the piano having perfect pitch, "Piano is similar to the cube in the mechanics of it," Schwan said. "Music is finite. If there's a finite knowledge base, that's what he likes."
